**A BILL FOR AN ACT**

101     **CONCERNING EXTENDING THE EARLY CHILDHOOD AND SCHOOL**  
102     **READINESS LEGISLATIVE COMMISSION.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under existing law, the early childhood and school readiness legislative commission (commission) will repeal July 1, 2012. The bill extends the repeal date to July 1, 2017, authorizes reimbursement for the members of the commission, and authorizes the legislative staff to work with the commission. The commission will meet at least 4 times per year.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **add** 26-6.5-201.5 as  
3 follows:

4           **26-6.5-201.5. Legislative declaration.** (1) THE GENERAL  
5 ASSEMBLY FINDS THAT:

6           (a) THE MOST ECONOMICALLY EFFICIENT TIME TO DEVELOP  
7 CHILDREN'S SKILLS AND SOCIAL ABILITIES IS IN THE VERY EARLY YEARS  
8 WHEN DEVELOPMENTAL EDUCATION ACROSS ALL OF THE FOUR DOMAINS  
9 OF EARLY LEARNING, FAMILY SUPPORT AND EDUCATION, HEALTH CARE,  
10 SOCIAL-EMOTIONAL HEALTH, AND MENTAL HEALTH CAN HAVE THE MOST  
11 EFFECT;

12           (b) CHILDREN, FAMILIES, AND SOCIETY BENEFIT FROM QUALITY  
13 INVESTMENTS IN EARLY CHILDHOOD DEVELOPMENT AND LEARNING.  
14 COMPREHENSIVE EARLY CHILDHOOD DEVELOPMENT PROVIDES CHILDREN  
15 AND THEIR FAMILIES WITH THE RESOURCES THEY NEED FOR EARLY  
16 NURTURING AND FOR EARLY LANGUAGE DEVELOPMENT AND LEARNING  
17 EXPERIENCES AND THE PHYSICAL HEALTH SUPPORTS THEY NEED TO HELP  
18 THEM ARRIVE AT SCHOOL THRIVING AND READY TO LEARN.

19           (c) HIGH-QUALITY EARLY CHILDHOOD CARE AND EDUCATION  
20 DURING THE CRUCIAL GROWTH YEARS FROM BIRTH TO FIVE YEARS OF AGE  
21 IS NECESSARY TO ENABLE CHILDREN TO SUCCEED WHEN THEY START  
22 KINDERGARTEN AND AS THEY CONTINUE THEIR EDUCATION;

23           (d) RESEARCH DEMONSTRATES THAT PARENTAL SUPPORT AND  
24 INVOLVEMENT, COMBINED WITH A HIGH-QUALITY PRESCHOOL EDUCATION  
25 PROGRAM, INCREASES STUDENTS' SCHOOL READINESS AND ACHIEVEMENT  
26 IN KINDERGARTEN AND SIGNIFICANTLY CONTRIBUTES TO OVERCOMING THE

1 EFFECTS OF STUDENTS' VARYING SOCIO-ECONOMIC CIRCUMSTANCES; AND

2 (e) RESEARCH FURTHER SHOWS THAT IMPROVING EDUCATIONAL  
3 PERFORMANCE THROUGH IMPROVED SCHOOL READINESS COSTS MUCH LESS  
4 THAN SPECIAL EDUCATION, REMEDIATION, AND GRADE RETENTION.

5 (2) THE GENERAL ASSEMBLY CONCLUDES THEREFORE THAT IT IS  
6 IN THE BEST INTERESTS OF THE STATE TO CREATE A LEGISLATIVE  
7 COMMISSION TO MEET ON A REGULAR BASIS TO STUDY ISSUES AND  
8 RECOMMEND LEGISLATION CONCERNING EARLY CHILDHOOD AND SCHOOL  
9 READINESS, INCLUDING HEALTH CARE, MENTAL HEALTH, PARENTAL  
10 INVOLVEMENT, FAMILY SUPPORT, AND EARLY LEARNING.

11 **SECTION 2.** In Colorado Revised Statutes, 26-6.5-203, **amend**  
12 (2) (a) and (2) (b); **repeal and reenact, with amendments,** (1) (d), (2)  
13 (d), and (3); and **add** (2) (e) as follows:

14 **26-6.5-203. Early childhood and school readiness legislative**  
15 **commission - creation - membership - duties.** (1) (d) THE MEMBERS OF  
16 THE COMMISSION SHALL BE COMPENSATED FOR ATTENDANCE AT MEETINGS  
17 OF THE COMMITTEE AS PROVIDED IN SECTION 2-2-307, C.R.S.

18 (2) (a) ~~Beginning on or before August 1, 2009,~~ The commission  
19 shall meet at least ~~six~~ FOUR times annually. ~~and as needed thereafter;~~  
20 ~~except that the commission shall not meet during the 2010 interim.~~

21 (b) The commission shall study issues concerning early childhood  
22 and school readiness, including but not limited to health care, mental  
23 health, parental involvement, family support, and early learning. ~~The~~  
24 ~~commission may recommend legislative changes which shall be treated~~  
25 ~~as bills recommended by an interim legislative committee for purposes of~~  
26 ~~any introduction deadlines or bill limitations imposed by the joint rules~~  
27 ~~of the general assembly.~~

1 (d) THE LEGISLATIVE COUNCIL STAFF AND THE OFFICE OF  
2 LEGISLATIVE LEGAL SERVICES SHALL ASSIST THE COMMISSION IN  
3 CARRYING OUT ITS DUTIES.

4 (e) THE COMMISSION SHALL REPORT TO THE LEGISLATIVE COUNCIL  
5 BY THE DATE SPECIFIED IN JOINT RULE 24 (b)(1)(D). THE REPORT MAY  
6 INCLUDE RECOMMENDATIONS FOR LEGISLATION, INCLUDING BUT NOT  
7 LIMITED TO LEGISLATION CONTINUING THE COMMISSION AND AN  
8 EXPLANATION OF THE ADDITIONAL TIME AND PROCEDURES THAT THE  
9 COMMISSION MAY IMPLEMENT TO ACHIEVE THE COMMITTEE'S STUDY  
10 GOALS. LEGISLATION RECOMMENDED BY THE COMMISSION SHALL BE  
11 TREATED AS LEGISLATION RECOMMENDED BY ANY OTHER INTERIM  
12 COMMITTEE FOR THE PURPOSES OF ANY INTRODUCTION DEADLINES OR BILL  
13 LIMITATIONS IMPOSED BY THE JOINT RULES OF THE SENATE AND HOUSE OF  
14 REPRESENTATIVES.

15 (3) THE CHAIR OF THE LEGISLATIVE COUNCIL SHALL APPROVE ALL  
16 REASONABLE AND NECESSARY EXPENSES INCURRED BY THE COMMISSION.  
17 THE APPROVED EXPENSES SHALL BE PAID BY VOUCHERS AND WARRANTS  
18 DRAWN AS PROVIDED BY LAW FROM MONEYS ALLOCATED TO THE  
19 LEGISLATIVE COUNCIL FOR LEGISLATIVE STUDIES FROM APPROPRIATIONS  
20 MADE BY THE GENERAL ASSEMBLY.

21 **SECTION 3.** In Colorado Revised Statutes, **amend** 26-6.5-204  
22 as follows:

23 **26-6.5-204. Repeal of part.** This part 2 is repealed, effective July  
24 1, ~~2012~~ 2015.

25 **SECTION 4. Safety clause.** The general assembly hereby finds,  
26 determines, and declares that this act is necessary for the immediate  
27 preservation of the public peace, health, and safety.
