A BILL FOR AN ACT

101 **CONCERNING THE REPEAL OF THE REQUIREMENT FOR A HOTEL AND**
102 **RESTAURANT ALCOHOL LICENSE THAT TWENTY-FIVE PERCENT**
103 **OF SALES MUST BE FROM MEALS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill repeals the requirement that an establishment with a hotel and restaurant alcohol license must make at least 25% of its gross income from the sale of meals.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-47-411, **amend**

3 (1) (a) and (1) (b) as follows:

4 **12-47-411. Hotel and restaurant license - definition - rules.**

5 (1) Except as otherwise provided in subsection (2) of this section, a hotel
6 and restaurant license shall be issued to persons selling alcohol beverages
7 in the place where the alcohol beverages are to be consumed, subject to
8 the following restrictions:

9 (a) Restaurants shall sell alcohol beverages as provided in this
10 section only to customers of the restaurant and only if meals are actually
11 and regularly served and provide not less than twenty-five percent of the
12 gross income from sales of food and drink of the business of the license
13 premises OVER ANY PERIOD OF TIME OF AT LEAST ONE YEAR.

14 (b) Hotels shall sell alcohol beverages as provided in this section
15 only to customers of the hotel and, except in hotel rooms, only on the
16 licensed premises where meals are actually and regularly served and
17 provide not less than twenty-five percent of the gross income from sales
18 of food and drink of the business of the licensed premises OVER ANY
19 PERIOD OF TIME OF AT LEAST ONE YEAR.

20 **SECTION 2. Act subject to petition - effective date.** This act
21 takes effect at 12:01 a.m. on the day following the expiration of the
22 ninety-day period after final adjournment of the general assembly (August
23 8, 2012, if adjournment sine die is on May 9, 2012); except that, if a
24 referendum petition is filed pursuant to section 1 (3) of article V of the
25 state constitution against this act or an item, section, or part of this act
26 within such period, then the act, item, section, or part will not take effect

1 unless approved by the people at the general election to be held in
2 November 2012 and, in such case, will take effect on the date of the
3 official declaration of the vote thereon by the governor.
