A BILL FOR AN ACT

101 CONCERNING A PROHIBITION ON THE USE OF PUBLIC LAND FOR RETAIL

102 SALES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill prohibits a public entity from operating, or contracting with a private entity to operate, for public use any truck stop, fueling station, or convenience store on or near public land, state highways, toll roads, or any other similar infrastructure supported by any state revenues. The bill does not prohibit a public entity from maintaining existing interstate public rest areas or constructing new interstate public rest areas as allowed by law. The bill also specifies that the prohibition is not retroactive and does not apply to restaurants or service centers related to a golf course or any souvenir shops that are on or near such public land, state highways, toll roads, or such similar infrastructure.

2	SECTION 1. In Colorado Revised Statutes, add article 65.2 to

ARTICLE 20.1

Prohibit Use of Public Land for Retail Sales

29-20.1-101. Definitions. As used in this article, unless the
 CONTEXT OTHERWISE REQUIRES:

(1) "POLITICAL SUBDIVISION" MEANS A GOVERNING SUBDIVISION
OF THE STATE, INCLUDING COUNTIES, MUNICIPALITIES, AND SPECIAL
DISTRICTS.

(2) "PRIVATE ENTITY" MEANS ANY INDIVIDUAL, CORPORATION,
BUSINESS TRUST, ESTATE, TRUST, LIMITED LIABILITY COMPANY,
PARTNERSHIP, ASSOCIATION, OR OTHER LEGAL ENTITY.

27 (3) "PUBLIC LAND" MEANS LAND OWNED BY A POLITICAL

14 (2) THE PROHIBITION SET FORTH IN THIS ARTICLE DOES NOT APPLY
15 TO ANY TRUCK STOP, FUELING STATION, OR CONVENIENCE STORE IN
16 OPERATION ON OR NEAR PUBLIC LAND, STATE HIGHWAYS, TOLL ROADS, OR
17 ANY OTHER SIMILAR INFRASTRUCTURE SUPPORTED BY ANY STATE
18 REVENUES PRIOR TO THE EFFECTIVE DATE OF THIS SECTION.

SECTION 3. Safety clause. The general assembly hereby finds,
determines, and declares that this act is necessary for the immediate
preservation of the public peace, health, and safety.
