101 **CONCERNING THE CREATION OF THE PARKS AND WILDLIFE**
102 **COMMISSION TO REPLACE THE PARKS AND WILDLIFE BOARD IN**
103 **THE DEPARTMENT OF NATURAL RESOURCES, AND, IN**
104 **CONNECTION THEREWITH, DESCRIBING THE COMPOSITION AND**

outdoor recreation entities and functions under the department of natural resources. In so doing, the existing wildlife commission was merged with the existing board of parks and outdoor recreation to form the 16-member parks and wildlife board (board).

Effective July 1, 2012, the bill replaces the board with the new parks and wildlife commission (commission). The commission is comprised of 11 voting members and 2 nonvoting ex officio members (the executive director of the department and the commissioner of the department of agriculture). The voting members are appointed by the governor with the consent of the senate and must represent various geographical regions in the state and certain areas of interest or knowledge. Initial term lengths are staggered to reduce the impact to the board that results from member turnover.

The commission is required to submit a 5-year strategic plan to specified committees of reference. Components of the plan are specified.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **repeal and reenact,**
3 **with amendments,** 33-9-101 as follows:

4 **33-9-101. Commission - creation - composition - terms -**
5 **vacancies - removal - meetings - strategic plan - legislative**
6 **declaration - repeal.** (1) (a) EFFECTIVE JULY 1, 2012, THERE IS HEREBY
7 CREATED THE PARKS AND WILDLIFE COMMISSION, ALSO REFERRED TO IN
8 THIS ARTICLE AS THE "COMMISSION".

9 (b) (I) EFFECTIVE JULY 1, 2012, THE PARKS AND WILDLIFE BOARD
10 IS ABOLISHED AND THE TERMS OF MEMBERS OF THAT BOARD SERVING AS
11 OF THAT DATE ARE TERMINATED.

12 (II) THIS PARAGRAPH (b) IS REPEALED, EFFECTIVE JANUARY 1,
13 2013.

14 (2) THE COMMISSION CONSISTS OF THIRTEEN MEMBERS, AS
15 FOLLOWS:

16 (a) TWO MEMBERS WHO ARE EX OFFICIO NONVOTING MEMBERS, AS
17 FOLLOWS:

1 (I) THE EXECUTIVE DIRECTOR; AND
2 (II) THE COMMISSIONER OF THE DEPARTMENT OF AGRICULTURE;
3 (b) ELEVEN VOTING MEMBERS WHO ARE APPOINTED, IN
4 ACCORDANCE WITH SUBSECTION (3) OF THIS SECTION, BY THE GOVERNOR
5 WITH THE CONSENT OF THE SENATE.

6 (3) (a) THE ELEVEN VOTING MEMBERS OF THE COMMISSION ARE AS
7 FOLLOWS:

8 (I) THREE MEMBERS WHO ARE SPORTS PERSONS WHO CAN
9 DEMONSTRATE A REASONABLE KNOWLEDGE OF WILDLIFE ISSUES AND WHO
10 HAVE OBTAINED A HUNTING OR FISHING LICENSE ISSUED UNDER THIS TITLE
11 FOR AT LEAST EACH OF THE THREE YEARS PRIOR TO THEIR APPOINTMENTS.
12 ONE OF THE MEMBERS APPOINTED PURSUANT TO THIS SUBPARAGRAPH (I)
13 MUST BE AN OUTFITTER REGISTERED PURSUANT TO ARTICLE 55.5 OF TITLE
14 12, C.R.S.

15 (II) THREE MEMBERS WHO ARE ACTIVELY INVOLVED IN
16 PRODUCTION AGRICULTURE AS OWNERS OR LESSEES OF THE
17 AGRICULTURAL PROPERTY AND OWNERS OR PARTIAL OWNERS OF THE
18 COMMODITIES PRODUCED ON THE LAND AND WHO CAN DEMONSTRATE A
19 REASONABLE KNOWLEDGE OF WILDLIFE ISSUES;

20 (III) THREE MEMBERS WHO CAN DEMONSTRATE THAT THEY
21 REGULARLY ENGAGE IN OUTDOOR RECREATION AND UTILIZE PARKS
22 RESOURCES. ONE MEMBER APPOINTED UNDER THIS SUBPARAGRAPH (III)
23 SHALL REPRESENT A NONPROFIT ORGANIZATION THAT SUPPORTS AND
24 PROMOTES THE CONSERVATION AND ENHANCEMENT OF COLORADO'S
25 WILDLIFE AND HABITAT; RECOGNIZES AND PROMOTES PRIMARILY
26 NONCONSUMPTIVE WILDLIFE USE; AND HAS EXPERTISE IN WILDLIFE ISSUES,
27 WILDLIFE HABITAT, OR WILDLIFE MANAGEMENT; AND

1 (IV) TWO MEMBERS APPOINTED FROM THE PUBLIC AT-LARGE.

2 (b) (I) IN APPOINTING MEMBERS TO THE COMMISSION UNDER
3 PARAGRAPH (a) OF THIS SUBSECTION (3), THE GOVERNOR SHALL MAKE
4 APPOINTMENTS THAT ENSURE THAT A REASONABLE BALANCE OF THE
5 FOLLOWING AREAS OF KNOWLEDGE AND EXPERIENCE, AS THEY RELATE TO
6 PARKS AND WILDLIFE, ARE REPRESENTED: OUTDOOR BUSINESS, SERVICE
7 AS A CURRENT OR FORMER LOCAL ELECTED OFFICIAL, YOUTH OUTDOOR
8 EDUCATION, WILDLIFE BIOLOGY OR SCIENCE, ENERGY, CONSERVATION,
9 BENEFICIAL USES OF WATER, LAND CONSERVATION AND CONSERVATION
10 EASEMENTS, AND DIVERSIFIED TRAILS INTERESTS AND ACTIVITIES. IN
11 ORDER TO SATISFY THE REQUIREMENTS OF THIS PARAGRAPH (b), THE
12 GOVERNOR SHALL GIVE PREFERENCE TO PERSONS WITH EXPERIENCE OR
13 EXPERTISE IN MULTIPLE AREAS OF KNOWLEDGE.

14 (II) REGARDLESS OF THE PARTICULAR INTERESTS OR
15 QUALIFICATIONS POSSESSED BY EACH MEMBER APPOINTED TO THE
16 COMMISSION PURSUANT TO PARAGRAPH (a) OF THIS SUBSECTION (3), EACH
17 COMMISSIONER REPRESENTS DIVERSE PARKS, WILDLIFE, AND OUTDOOR
18 RECREATION THROUGHOUT COLORADO AND IS COMMITTED TO THE
19 LONG-TERM FINANCIAL STABILITY AND SUSTAINABILITY OF THE
20 DEPARTMENT.

21 (c) OF THE VOTING MEMBERS APPOINTED TO THE COMMISSION,
22 THERE SHALL NOT BE A DIFFERENCE OF MORE THAN ONE PERSON BETWEEN
23 THOSE MEMBERS AFFILIATED WITH ANY MAJOR POLITICAL PARTY.

24 (d) TO THE EXTENT POSSIBLE, VOTING MEMBERS SHALL BE
25 APPOINTED TO THE COMMISSION IN A MANNER THAT ENSURES BALANCED
26 GEOGRAPHICAL REPRESENTATION OF DIVERSE AREAS OF THE STATE. AT
27 LEAST FOUR VOTING MEMBERS SHALL BE APPOINTED FROM WEST OF THE

1 CONTINENTAL DIVIDE.

2 (e) (I) EXCEPT AS PROVIDED IN PARAGRAPH (f) OF THIS
3 SUBSECTION (3), TERMS OF MEMBERS SERVING PURSUANT TO PARAGRAPH
4 (b) OF SUBSECTION (2) OF THIS SECTION ARE FOR FOUR YEARS.

5 (II) NO MEMBER SERVING PURSUANT TO PARAGRAPH (b) OF
6 SUBSECTION (2) OF THIS SECTION IS PERMITTED TO SERVE MORE THAN TWO
7 CONSECUTIVE TERMS.

8 (f) (I) INITIAL APPOINTMENTS OF VOTING MEMBERS OF THE
9 COMMISSION ARE AS FOLLOWS: TWO MEMBERS TO SERVE UNTIL JULY 1,
10 2013; THREE MEMBERS TO SERVE UNTIL JULY 18, 2014; THREE MEMBERS
11 TO SERVE UNTIL JULY 18, 2015; AND THREE MEMBERS TO SERVE UNTIL
12 JULY 18, 2016. ALL SUBSEQUENT APPOINTMENTS ARE FOR TERMS OF FOUR
13 YEARS.

14 (II) IN MAKING INITIAL APPOINTMENTS TO THE COMMISSION UNDER
15 SUBPARAGRAPH (I) OF THIS PARAGRAPH (f), THE GOVERNOR MAY SELECT
16 PERSONS SERVING ON THE FORMER PARKS AND WILDLIFE BOARD, AS THAT
17 BOARD EXISTED ON JUNE 30, 2012. HOWEVER, A PERSON SO APPOINTED IS
18 INELIGIBLE TO SERVE ANY OF THE INITIAL APPOINTMENTS THAT WOULD
19 RESULT IN EXTENDING FOR MORE THAN TWO YEARS THE DATE ON WHICH
20 THE PERSON'S PARKS AND WILDLIFE BOARD TERM WOULD HAVE EXPIRED.

21 (4) THE GOVERNOR SHALL FILL VACANCIES ON THE COMMISSION
22 FOR ANY UNEXPIRED TERM, WITH THE CONSENT OF THE SENATE. THE
23 MEMBER APPOINTED TO FILL A VACANCY SHALL BE FROM THE SAME
24 CATEGORY DESCRIBED IN PARAGRAPH (a) OF SUBSECTION (3) OF THIS
25 SECTION AS THE MEMBER VACATING THE POSITION.

26 (5) THE GOVERNOR IS PERMITTED TO REMOVE MEMBERS OF THE
27 COMMISSION ONLY FOR CAUSE.

1 (6) SIX VOTING COMMISSIONERS CONSTITUTE A QUORUM FOR
2 PURPOSES OF CONDUCTING THE BUSINESS OF THE COMMISSION.

3 (7) FOR PURPOSES OF MAILING AND SERVICE, THE COMMISSION'S
4 PRINCIPAL OFFICE IS IN THE OFFICE OF THE EXECUTIVE DIRECTOR.

5 (8) FOR EACH DAY ACTUALLY ENGAGED IN THE DUTIES OF THE
6 COMMISSION, THE COMMISSION MEMBERS ARE ENTITLED TO RECEIVE A PER
7 DIEM AMOUNT OF FIFTY DOLLARS, TOGETHER WITH ALL ACTUAL AND
8 NECESSARY TRAVEL EXPENSES TO BE PAID AFTER THE EXPENSES ARE
9 INCURRED. MILEAGE RATES ARE AS PROVIDED IN SECTION 24-9-104,
10 C.R.S.

11 (9) THE COMMISSION SHALL EXERCISE ITS POWERS AND PERFORM
12 ITS DUTIES AND FUNCTIONS UNDER THE DEPARTMENT AND THE EXECUTIVE
13 DIRECTOR OF THE DEPARTMENT AS IF THE SAME WERE TRANSFERRED TO
14 THE DEPARTMENT BY A **TYPE 1** TRANSFER, AS DEFINED IN THE
15 "ADMINISTRATIVE ORGANIZATION ACT OF 1968", ARTICLE 1 OF TITLE 24,
16 C.R.S.

17 (10) (a) (I) THE INITIAL MEETING OF THE COMMISSION SHALL BE
18 CONVENED BY THE EXECUTIVE DIRECTOR.

19 (II) AT THE FIRST MEETING, THE COMMISSION SHALL:

20 (A) ELECT A CHAIR AND VICE-CHAIR FROM THE MEMBERS SERVING
21 PURSUANT TO PARAGRAPH (b) OF SUBSECTION (2) OF THIS SECTION, WHO
22 SHALL SERVE IN THAT CAPACITY FOR A TERM OF ONE YEAR BUT WHO MAY
23 BE REELECTED FOR ADDITIONAL TERMS; AND

24 (B) DESIGNATE TWO MEMBERS TO SERVE AS REPRESENTATIVES TO
25 THE STATE BOARD OF THE GREAT OUTDOORS COLORADO TRUST FUND
26 ESTABLISHED UNDER ARTICLE XXVII OF THE STATE CONSTITUTION. ONE
27 REPRESENTATIVE MUST BE A COMMISSIONER WITH WILDLIFE KNOWLEDGE

1 APPOINTED PURSUANT TO SUBPARAGRAPH (I) OF PARAGRAPH (a) OF
2 SUBSECTION (3) OF THIS SECTION, AND THE OTHER REPRESENTATIVE MUST
3 BE A COMMISSIONER WITH EXPERIENCE IN OUTDOOR RECREATION
4 APPOINTED PURSUANT TO SUBPARAGRAPH (III) OF PARAGRAPH (a) OF
5 SUBSECTION (3) OF THIS SECTION.

6 (b) THE COMMISSION SHALL MEET AS OFTEN AS NECESSARY AND
7 MAY ADOPT POLICIES AND PROCEDURES NECESSARY TO CARRY OUT ITS
8 DUTIES. THE COMMISSION SHALL CONDUCT AT LEAST TWO MEETINGS PER
9 CALENDAR YEAR AT LOCATIONS WEST OF THE CONTINENTAL DIVIDE.

10 (11) (a) IN ADDITION TO DISCHARGING ITS REGULAR DUTIES AND
11 FUNCTIONS, THE COMMISSION SHALL SPECIFICALLY DISCUSS AND
12 FORMULATE A FIVE-YEAR STRATEGIC PLAN TO ADDRESS ONGOING OR NEW
13 ISSUES RESULTING AFTER, AND IDENTIFY INCREASED EFFICIENCIES AND
14 COST SAVINGS THAT MAY BE REALIZED FROM, THE 2011 MERGER OF THE
15 FORMER DIVISION OF WILDLIFE AND THE FORMER DIVISION OF PARKS AND
16 OUTDOOR RECREATION INTO THE DIVISION OF PARKS AND WILDLIFE. THE
17 STRATEGIC PLAN MUST ADDRESS HOW THE MERGER HAS AFFECTED
18 POLICIES, OBJECTIVES, STRATEGIES, AND ESTIMATED ANNUAL FISCAL
19 COSTS AND SAVINGS ASSOCIATED WITH THE DUTIES AND PROGRAMS OF
20 THE DIVISION.

21 (b) THE COMMISSION SHALL FINALIZE THE STRATEGIC PLAN
22 REQUIRED BY THIS SUBSECTION (11) BY DECEMBER 31, 2013. IN
23 DEVELOPING THE STRATEGIC PLAN, THE COMMISSION SHALL PLACE
24 SPECIAL EMPHASIS ON OBTAINING MEANINGFUL STATEWIDE INPUT.

25 (c) NOTWITHSTANDING SECTION 24-1-136 (11), C.R.S., FOR EVERY
26 YEAR INCLUDED IN THE STRATEGIC PLAN, THE COMMISSION SHALL SUBMIT
27 A REPORT ANNUALLY TO THE HOUSE COMMITTEE ON AGRICULTURE,

1 LIVESTOCK, AND NATURAL RESOURCES AND THE SENATE COMMITTEE ON
2 AGRICULTURE, NATURAL RESOURCES, AND ENERGY, OR ANY SUCCESSOR
3 COMMITTEES, REGARDING THE PROGRESS AND STATUS OF THE STRATEGIC
4 PLAN. IN ORDER TO REDUCE COSTS ASSOCIATED WITH PREPARING AND
5 TRANSMITTING SUCH REPORTS, THE COMMISSION IS AUTHORIZED TO SEND
6 THE REPORTS IN AN ELECTRONIC FORMAT.

7 (12) (a) THE GENERAL ASSEMBLY HEREBY FINDS, DETERMINES,
8 AND DECLARES THAT IT IS THE POLICY OF THE STATE THAT:

9 (I) COLORADO'S WILDLIFE, NATURAL, SCENIC, AND SCIENTIFIC
10 RESOURCES MUST BE PROTECTED, PRESERVED, ENHANCED, AND MANAGED
11 FOR THE USE, BENEFIT, AND ENJOYMENT OF THE PEOPLE OF THE STATE AND
12 ITS VISITORS;

13 (II) COLORADO'S AGRICULTURE PLAYS A VITAL ROLE IN PROVIDING
14 THE STATE'S WILDLIFE, NATURAL, SCENIC, AND SCIENTIFIC RESOURCES THE
15 HABITAT AND CONDITIONS THAT ALLOW THESE RESOURCES TO THRIVE;

16 (III) A COMPREHENSIVE PROGRAM DESIGNED TO OFFER THE
17 GREATEST POSSIBLE VARIETY OF RECREATIONAL OPPORTUNITY TO THE
18 PEOPLE OF THE STATE AND ITS VISITORS IS PROVIDED;

19 (IV) THERE MUST BE A CONTINUOUS OPERATION OF PLANNING,
20 ACQUISITION, DEVELOPMENT, AND MANAGEMENT OF WILDLIFE HABITATS,
21 STATE PARKS, OUTDOOR RECREATION LANDS, TRAILS, WATERS, AND
22 FACILITIES IN A MANNER THAT RECOGNIZES THE PRIVATE PROPERTY
23 RIGHTS OF INDIVIDUAL PROPERTY OWNERS; AND

24 (V) BOTH EDUCATION AND OUTREACH ACTIVITIES MUST BE USED
25 TO PROMOTE NATURAL RESOURCES STEWARDSHIP.

26 (b) THE GENERAL ASSEMBLY FURTHER FINDS AND DECLARES THAT
27 THE MISSION OF THE COMMISSION AND THE DIVISION IS TO PERPETUATE

1 THE WILDLIFE RESOURCES OF THE STATE, TO PROVIDE A QUALITY STATE
2 PARKS SYSTEM, AND TO PROVIDE ENJOYABLE AND SUSTAINABLE OUTDOOR
3 RECREATION OPPORTUNITIES THAT EDUCATE AND INSPIRE CURRENT AND
4 FUTURE GENERATIONS TO SERVE AS ACTIVE STEWARDS OF COLORADO'S
5 NATURAL RESOURCES.

18 development of uniform standards for trail construction ~~which~~ that may
19 be adopted by the ~~board~~ COMMISSION for statewide use and ~~which~~ THAT
20 shall be made available to participating local governments. The
21 committee shall offer plans and methods for funding a trails system
22 through user fees or other financing methods.

23 **SECTION 44.** In Colorado Revised Statutes, **amend** 33-11-107
24 as follows:

25 **33-11-107. Availability of funds.** The ~~board~~ COMMISSION is
26 authorized to make funds appropriated by the general assembly for the
27 purposes of this article available to local governments and nonprofit

20 local governmental agencies, the division may provide such uniform signs
21 and markers to such agencies in accordance with written agreements and
22 may require such agencies to erect and maintain them in accordance with

19 for relief from responsibility for passes and registrations or moneys that
20 have been lost, stolen, or destroyed and for which the employees are
21 unable to account in accordance with ~~the provisions of subsections (4) to~~

10 is subject to the provisions of this section and the commission agree upon
11 a mitigation plan for the facility, the commission shall forward such
12 agreement to the Colorado water conservation board, and the board shall
13 adopt such agreement at its next meeting as the official state position on
14 the mitigation actions required of the applicant. In all cases the
15 commission shall proceed expeditiously and, no later than sixty days from
16 the applicant's notice, unless extended in writing by the applicant, make
17 its evaluation regarding the probable impact of the proposed facility on
18 fish and wildlife resources and their habitat and to make its
19 recommendation regarding such reasonable mitigation actions as may be
20 needed.

21 **SECTION 104.** In Colorado Revised Statutes, 37-60-123.7,
22 **amend** (1.5) as follows:

23 **37-60-123.7. Acquisitions of water for instream flows.** (1.5) In
24 any year that the board expends all of the moneys available for the costs
25 of acquiring water, water rights, and interests in water for instream flow
26 use from the moneys that have been appropriated for the current fiscal
27 year from the Colorado water conservation board construction fund

1 pursuant to this section, the board shall apply to the PARKS AND wildlife
2 commission for all or any portion of the five hundred thousand dollars
3 from habitat stamp moneys made available pursuant to section 33-4-102.7
4 (4) (a) (II), C.R.S. Any habitat stamp moneys received shall be used to
5 acquire water, water rights, or interests in water pursuant to section
6 37-92-102 (3), subject to the limitations set forth in this section.

7 **SECTION 105.** In Colorado Revised Statutes, 43-1-106, **amend**
8 (8) (l) and (8) (m) as follows:

9 **43-1-106. Transportation commission - powers and duties.**

10 (8) In addition to all other powers and duties imposed upon it by law, the
11 commission has the following powers and duties:

12 (l) To do all things necessary and appropriate in the construction,
13 improvement, and maintenance of the public roads serving the state parks
14 and recreation areas and, to this end, to cooperate with the ~~board of parks~~
15 ~~and outdoor recreation~~ PARKS AND WILDLIFE COMMISSION and the director
16 of the division of parks and ~~outdoor recreation~~ WILDLIFE;

17 (m) To do all things necessary and appropriate in the construction,
18 maintenance, and improvement of recreational trails along and across new
19 or existing state or interstate highways and, to this end, to cooperate with
20 the ~~board of parks and outdoor recreation~~ PARKS AND WILDLIFE
21 COMMISSION and the director of the division of parks and ~~outdoor~~
22 ~~recreation~~ WILDLIFE;

23 **SECTION 106. Appropriation - adjustments in 2012 long bill.**

24 For the implementation of this act, the appropriation made in the annual
25 general appropriation act to the department of natural resources for the
26 fiscal year beginning July 1, 2012, is decreased by \$18,055 cash funds. Of
27 this amount, \$11,607 shall be from the wildlife cash fund pursuant to

1 section 33-1-112 (1) (a), Colorado Revised Statutes, and \$6,448 shall be
2 from the parks and outdoor recreation cash fund pursuant to section
3 33-10-111 (1), Colorado Revised Statutes.

4 **SECTION 107. Safety clause.** The general assembly hereby
5 finds, determines, and declares that this act is necessary for the immediate
6 preservation of the public peace, health, and safety.
