A BILL FOR AN ACT

101 CONCERNING COMMUNITY COLLEGE TWO-YEAR DEGREE PROGRAMS IN
102 CERTAIN HEALTH CARE FIELDS WITHOUT A STUDENT TRANSFER
103 AGREEMENT.

Bill Summary

The bill allows a Colorado community college to offer a two-year degree program with academic designation in nursing or dental hygiene without a valid student transfer agreement.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 23-60-211, **amend**
3 (1) as follows:

4 **23-60-211. Degrees.** (1) Before a community college offers a
5 two-year degree program with academic designation, as authorized by
6 section 23-60-201, the community college shall determine the program
7 designation for the degree. A two-year degree program with academic
8 designation shall only be for a degree program that has a valid student
9 transfer agreement pursuant to section 23-1-108 (7); EXCEPT THAT A
10 COMMUNITY COLLEGE MAY OFFER A TWO-YEAR DEGREE PROGRAM WITH
11 ACADEMIC DESIGNATION IN [REDACTED] DENTAL HYGIENE WITHOUT A VALID
12 STUDENT TRANSFER AGREEMENT. The community college shall then
13 submit the degree program designation to the board for its review and
14 approval. The community college may offer the degree program only after
15 it has been approved by the board and by the Colorado commission on
16 higher education. The community college shall exclusively use the degree
17 program designation name in official publications, course catalogs,
18 diplomas, and official transcripts.

19 **SECTION 2. Act subject to petition - effective date.** This act
20 takes effect at 12:01 a.m. on the day following the expiration of the
21 ninety-day period after final adjournment of the general assembly (August
22 8, 2012, if adjournment sine die is on May 9, 2012); except that, if a
23 referendum petition is filed pursuant to section 1 (3) of article V of the
24 state constitution against this act or an item, section, or part of this act
25 within such period, then the act, item, section, or part will not take effect
26 unless approved by the people at the general election to be held in

- 1 November 2012 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
