Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB13-1228 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, line 6, strike "**created.**" and substitute  
2 "**created - repeal.**".

3 Page 2, strike lines 18 through 20 and substitute:  
4 "(c) THE MONEYS IN THE FUND SHALL BE SUBJECT TO ANNUAL  
5 APPROPRIATION BY THE GENERAL ASSEMBLY FOR THE DIRECT AND  
6 INDIRECT COSTS ASSOCIATED WITH PERFORMING BACK GROUND CHECKS".

7 Page 3, after line 11, insert:  
8 "(f) (I) THE BUREAU IS AUTHORIZED TO CONTINUE USING GENERAL  
9 FUND MONEYS APPROPRIATED TO THE BUREAU FOR THE 2013-14 FISCAL  
10 YEAR FOR THE PURPOSE OF PERFORMING CRIMINAL BACKGROUND CHECKS  
11 PURSUANT TO THIS SECTION UNTIL THE SOONER OF:  
12 (A) A DATE SIX MONTHS AFTER THE EFFECTIVE DATE OF THIS  
13 PARAGRAPH (f); OR  
14 (B) A DATE UPON WHICH SUFFICIENT MONEYS EXIST WITHIN THE  
15 FUND TO PAY FOR THE PERFORMING OF CRIMINAL BACKGROUND CHECKS  
16 PURSUANT TO THIS SECTION.  
17 (II) THIS PARAGRAPH (f) IS REPEALED EFFECTIVE JULY 1, 2014.

18 **SECTION 2. Appropriation - adjustments to 2013 long bill.** (1)  
19 For the implementation of this act, appropriations made in the annual  
20 general appropriation act to the department of public safety for the fiscal  
21 year beginning July 1, 2013, are adjusted as follow:

1 (a) The general fund appropriation for the executive director's  
2 office is decreased by \$107,739.

3 (b) The general fund appropriation for the state point of contact-  
4 national instant criminal background check program is decreased by  
5 \$924,637 and 15.0 FTE.

6 (2) In addition to any other appropriation, there is hereby  
7 appropriated, out of any moneys in the instant criminal background check  
8 cash fund created in section 24-33.5-424 (3.5) (b), Colorado Revised  
9 Statutes, not otherwise appropriated, to the department of public safety,  
10 for the fiscal year beginning July 1, 2013, the sum of \$1,032,376 and 15.0  
11 FTE, or so much thereof as may be necessary, to be allocated for the  
12 implementation of this act as follows:

13 (a) \$107,739 for the executive director's office; and

14 (b) \$924,637 and 15.0 FTE for the state point of contact-national  
15 instant criminal background check program.".

16 Renumber succeeding section accordingly.

17 Page 1, line 103, strike "FIREARM." and substitute "FIREARM, AND, IN  
18 CONNECTION THEREWITH, MAKING AND REDUCING AN  
19 APPROPRIATION.".
