**A BILL FOR AN ACT**

101 **CONCERNING CHANGES TO CHILD SUPPORT PROVISIONS.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill makes several changes to the child support sections of the Uniform Dissolution of Marriage Act, including:

- ! Revises the schedule of basic child support obligations, including the application of a minimum order formula for income below \$1,100 per month rather than the existing level of \$850 per month;
- ! Revises the minimum child support amount in

circumstances in which the parents' combined monthly adjusted gross income is less than \$1,100 per month to \$50 per month for one child; \$70 per month for 2 children; \$90 per month for 3 children; \$110 per month for 4 children; \$130 per month for 5 children; and \$150 per month for 6 or more children;

- ! Revises the formula for calculating the low-income adjustment by removing the 40% multiplier factor;
- ! Makes amendments to the definition of "gross income", including clarification of when earnings or gains on retirement accounts may be included in gross income;
- ! Adds language concerning the handling and application of lump sum social security disability benefits or retirement benefits;
- ! Provides language concerning the retroactive establishment of child support in situations where there has been a post-order change of physical care agreed on by the parents; and
- ! Revises the duties, make-up, and terms of the child support commission.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 14-10-115, **amend**  
3 (5) (a) (I) (D), (5) (a) (I) (O), (5) (a) (I) (W), (6) (b) (I), (7) (a) (II) (B), (7)  
4 (a) (II) (C), (7) (a) (II) (D), and (16); and **add** (5) (a) (II) (E) and (11) (d)  
5 as follows:

6           **14-10-115. Child support guidelines - purpose - definitions -**  
7 **determination of income - schedule of basic child support obligations**  
8 **- adjustments to basic child support - additional guidelines - child**  
9 **support commission. (5) Determination of income. (a)** For the  
10 purposes of the child support guidelines and schedule of basic child  
11 support obligations specified in this section, the gross income of each  
12 parent shall be determined according to the following guidelines:

13           (I) "Gross income" includes income from any source, except as  
14 otherwise provided in subparagraph (II) of this paragraph (a), and

2 (D) Payments received as an independent contractor for labor or  
3 services, WHICH PAYMENTS MUST BE CONSIDERED INCOME FROM  
4 SELF-EMPLOYMENT;

5 (O) Any moneys drawn by a self-employed individual for personal  
6 use THAT ARE DEDUCTED AS A BUSINESS EXPENSE, WHICH MONEYS MUST  
7 BE CONSIDERED INCOME FROM SELF-EMPLOYMENT;

8 (W) ~~Taxable distributions from general partnerships, limited~~  
9 ~~partnerships, closely held corporations, or limited liability companies~~  
10 INCOME FROM GENERAL PARTNERSHIPS, LIMITED PARTNERSHIPS, CLOSELY  
11 HELD CORPORATIONS, OR LIMITED LIABILITY COMPANIES. HOWEVER, IF A  
12 PARENT IS A PASSIVE INVESTOR, HAS A MINORITY INTEREST IN THE

14 THE INCOME TO BE RECOGNIZED MAY BE LIMITED TO ACTUAL CASH  
15 DISTRIBUTIONS RECEIVED.

16 (II) "Gross income" does not include:

17 (E) EARNINGS OR GAINS ON A RETIREMENT ACCOUNT, INCLUDING  
18 AN IRA, WHICH EARNINGS OR GAINS MUST NOT BE INCLUDED AS INCOME  
19 UNLESS OR UNTIL A PARENT TAKES A DISTRIBUTION FROM THE ACCOUNT.  
20 IF A DISTRIBUTION FROM A RETIREMENT ACCOUNT MAY BE TAKEN  
21 WITHOUT BEING SUBJECT TO AN IRS PENALTY FOR EARLY DISTRIBUTION  
22 AND THE PARENT DECIDES NOT TO TAKE THE DISTRIBUTION, THE COURT  
23 MAY CONSIDER THE DISTRIBUTION THAT COULD HAVE BEEN TAKEN IN  
24 DETERMINING THE PARENT'S GROSS INCOME.

25 (6) **Adjustments to gross income.** (b) (I) At the time of the  
26 initial establishment of a child support order, or in any proceeding to  
27 modify a support order, if a parent is also legally responsible for the

1 support of other children for whom the parents do not share joint legal  
2 responsibility, an adjustment shall be made revising the parent's income  
3 prior to calculating the basic child support obligation for the children who  
4 are the subject of the support order if the children are living in the home  
5 of the parent seeking the adjustment or if the children are living out of the  
6 home, and the parent seeking the adjustment provides documented proof  
7 of money payments of support of those children. The amount shall not  
8 exceed the schedule of basic support obligations listed in this section. For  
9 a parent with a gross income of one thousand ~~eight~~ NINE hundred fifty  
10 dollars or less per month, the adjustment shall be seventy-five percent of  
11 the amount calculated using the low-income adjustment described in  
12 sub-subparagraphs (B) and (C) of subparagraph (II) of paragraph (a) of  
13 subsection (7) of this section based only upon the responsible parent's  
14 income, without any other adjustments for the number of other children  
15 for whom the parent is responsible. For a parent with gross income of  
16 more than one thousand ~~eight~~ NINE hundred fifty dollars per month, the  
17 adjustment shall be seventy-five percent of the amount listed under the  
18 schedule of basic support obligations in paragraph (b) of subsection (7)  
19 of this section that would represent a support obligation based only upon  
20 the responsible parent's income, without any other adjustments for the  
21 number of other children for whom the parent is responsible. The amount  
22 calculated as set forth in this subparagraph (I) shall be subtracted from the  
23 amount of the parent's gross income prior to calculating the basic support  
24 obligation based upon both parents' gross income, as provided in  
25 subsection (7) of this section.

26 (7) **Schedule of basic child support obligations.**

27 (a) (II) (B) Except as otherwise provided in sub-subparagraph (D) of this

1 subparagraph (II), in circumstances in which the parents' combined  
2 monthly adjusted gross income is less than ~~eight hundred fifty~~ ONE  
3 THOUSAND ONE HUNDRED dollars, a child support payment of fifty dollars  
4 per month FOR ONE CHILD, SEVENTY DOLLARS PER MONTH FOR TWO  
5 CHILDREN, NINETY DOLLARS PER MONTH FOR THREE CHILDREN, ONE  
6 HUNDRED TEN DOLLARS PER MONTH FOR FOUR CHILDREN, ONE HUNDRED  
7 THIRTY DOLLARS PER MONTH FOR FIVE CHILDREN, AND ONE HUNDRED  
8 FIFTY DOLLARS PER MONTH FOR SIX OR MORE CHILDREN shall be required  
9 of the obligor. The minimum order of ~~fifty dollars~~ AMOUNT shall not  
10 apply when each parent keeps the children more than ninety-two  
11 overnights each year as defined in paragraph (h) of subsection (3) of this  
12 section. In no case, however, shall the amount of child support ordered to  
13 be paid exceed the amount of child support that would otherwise be  
14 ordered to be paid if the parents did not share physical custody.

15 (C) Except as otherwise provided in sub-subparagraph (D) of this  
16 subparagraph (II), in circumstances in which the parents' combined  
17 monthly adjusted gross income is ~~eight hundred fifty~~ ONE THOUSAND ONE  
18 HUNDRED dollars or more, but in which the parent with the least number  
19 of overnights per year with the child has a monthly adjusted gross income  
20 of less than one thousand ~~eight~~ NINE hundred ~~fifty~~ dollars, the court or  
21 delegate child support enforcement unit, pursuant to section 26-13.5-105  
22 (4), C.R.S., shall perform a low-income adjustment calculation of child  
23 support as follows: The court or delegate child support enforcement unit  
24 shall determine each parent's monthly adjusted gross income, as that term  
25 is defined in subsection (3) of this section. Based upon the parents'  
26 combined monthly adjusted gross incomes, the court or delegate child  
27 support enforcement unit shall determine the monthly basic child support

1 obligation, using the schedule of basic child support obligations set forth  
2 in paragraph (b) of this subsection (7) and shall determine each parent's  
3 presumptive proportionate share of said obligation. The court or delegate  
4 child support enforcement unit shall then adjust the income of the parent  
5 with the fewest number of overnights per year with the child by  
6 subtracting ~~nine~~ ONE THOUSAND ONE hundred dollars from that parent's  
7 monthly adjusted gross income. ~~The court shall multiply the resulting~~  
8 ~~amount by a factor of forty percent.~~ The ~~product~~ RESULT of the  
9 ~~multiplication~~ SUBTRACTION shall be added to the following basic  
10 minimum child support amount as additional minimum support, unless  
11 the ~~product of the multiplication~~ RESULT OF THE SUBTRACTION amount is  
12 zero or a negative figure, in which case the court shall add zero to the  
13 following basic minimum child support amount: ~~Seventy-five~~ FIFTY  
14 dollars for one child; ~~one hundred fifty~~ SEVENTY dollars for two children;  
15 ~~two hundred twenty-five~~ NINETY dollars for three children; ~~two hundred~~  
16 ~~seventy-five~~ ONE HUNDRED TEN dollars for four children; ~~three hundred~~  
17 ~~twenty-five~~ ONE HUNDRED THIRTY dollars for five children; and ~~three~~  
18 ~~hundred fifty~~ ONE HUNDRED FIFTY dollars for six or more children. The  
19 court or delegate child support enforcement unit shall compare the  
20 product of this addition to the parent's presumptive proportionate share  
21 of the monthly basic support obligation determined previously from the  
22 schedule of basic child support obligations. The lesser of the two amounts  
23 shall be the basic monthly support obligation to be paid by the  
24 low-income parent, as adjusted by the low-income parent's proportionate  
25 share of the work-related and education-related child care costs, health  
26 insurance, extraordinary medical expenses, and other extraordinary  
27 adjustments as described in subsections (9) to (11) of this section. The

1 low-income adjustment shall not apply when each parent keeps the  
2 children more than ninety-two overnights each year as defined in  
3 subsection (8) of this section. In no case, however, shall the amount of  
4 child support ordered to be paid exceed the amount of child support that  
5 would otherwise be ordered to be paid if the parents did not share  
6 physical custody.

7 (D) In any circumstance in which the obligor's monthly adjusted  
8 gross income is less than ~~eight hundred fifty~~ ONE THOUSAND ONE  
9 HUNDRED dollars, regardless of the monthly adjusted gross income of the  
10 obligee, the obligor shall be ordered to pay ~~fifty dollars per month~~ THE  
11 MINIMUM MONTHLY ORDER AMOUNT in child support BASED ON THE  
12 NUMBER OF CHILDREN DUE SUPPORT AND THIS SUBSECTION (7). THE  
13 MINIMUM ORDER AMOUNT SHALL BE FIFTY DOLLARS PER MONTH FOR ONE  
14 CHILD, SEVENTY DOLLARS PER MONTH FOR TWO CHILDREN, NINETY  
15 DOLLARS PER MONTH FOR THREE CHILDREN, ONE HUNDRED TEN DOLLARS

24 (11) **Extraordinary adjustments to the schedule of basic child**  
25 **support obligations - periodic disability benefits.** (d) IN CASES WHERE  
26 THE CUSTODIAL PARENT RECEIVES A LUMP SUM RETROACTIVE AWARD FOR  
27 BENEFITS GRANTED BY THE FEDERAL OLD-AGE, SURVIVORS, OR DISABILITY

1 INSURANCE BENEFITS PROGRAM, 42 U.S.C. 7, ON BEHALF OF A DEPENDENT  
2 CHILD DUE TO THE DISABILITY OF THE NONCUSTODIAL PARENT, OR  
3 RECEIVES A LUMP SUM RETROACTIVE AWARD FOR EMPLOYER-PAID  
4 RETIREMENT BENEFITS FROM THE FEDERAL GOVERNMENT ON BEHALF OF  
5 A DEPENDENT CHILD DUE TO THE RETIREMENT OF THE NONCUSTODIAL  
6 PARENT, THE LUMP SUM AWARD RECEIVED BY THE CUSTODIAL PARENT  
7 MUST BE CREDITED AGAINST ANY RETROACTIVE SUPPORT JUDGMENT OR  
8 ANY PAST-DUE CHILD SUPPORT OBLIGATION, REGARDLESS OF WHETHER  
9 THE PAST-DUE OBLIGATION HAS BEEN REDUCED TO JUDGMENT OWED BY  
10 THE NONCUSTODIAL PARENT. THIS CREDIT MUST NOT BE GIVEN AGAINST  
11 ANY AMOUNTS OWED BY THE NONCUSTODIAL PARENT FOR DEBT AS  
12 DEFINED IN SECTION 14-14-104 OR FOR ANY RETROACTIVE SUPPORT OR  
13 ANY ARREARAGE THAT ACCRUED PRIOR TO THE DATE OF ELIGIBILITY FOR  
14 DISABILITY OR RETIREMENT BENEFITS AS DETERMINED BY THE SOCIAL  
15 SECURITY ADMINISTRATION. ANY LUMP SUM RETIREMENT OR DISABILITY  
16 PAYMENTS DUE TO THE RETIREMENT OR DISABILITY OF THE  
17 NONCUSTODIAL PARENT, RECEIVED BY THE CUSTODIAL PARENT AS A  
18 RESULT OF THE RETIREMENT OR DISABILITY OF THE NONCUSTODIAL  
19 PARENT, PAID FOR A PERIOD OF TIME THAT PRECEDES THE DATE OF SUCH  
20 BENEFIT DATE ELIGIBILITY, OR ANY AMOUNT IN EXCESS OF THE

23 (16) **Child support commission.** (a) The child support  
24 guidelines, including the schedule of basic child support obligations, and  
25 general child support issues shall be reviewed and the results of ~~such~~ THE  
26 review and any recommended changes shall be reported to the governor  
27 and to the general assembly on or before December 1, 1991, and at least



1 every four years thereafter by a child support commission, which  
2 commission is hereby created.

3 (b) As part of its review, the commission must consider economic  
4 data on the cost of raising children and analyze case data on the  
5 application of, and deviations from, the guidelines and the schedule of  
6 basic child support obligations to be used in the commission's review to  
7 ensure that deviations from the guidelines and schedule of basic child  
8 support obligations are limited. ~~In addition, the commission shall review~~  
9 ~~issues identified in the federal "Personal Responsibility and Work~~  
10 ~~Opportunity Reconciliation Act of 1996", Public Law 104-193, including~~  
11 ~~out-of-wedlock births and the prevention of teen pregnancy.~~

12 (c) The child support commission shall consist of no more than  
13 twenty-one members. The governor shall appoint persons to the  
14 commission who are representatives of the judiciary and the Colorado bar  
15 association. Members of the commission appointed by the governor shall  
16 also include the director of the division in the state department of human  
17 services that is responsible for child support enforcement, or his or her  
18 designee, a director of a county department of social services, the child  
19 support liaison to the judicial department, interested parties, a certified  
20 public accountant, and parent representatives. In making his or her  
21 appointments to the commission, the governor ~~shall attempt to~~ MAY  
22 appoint persons as parent representatives. ~~or as other representatives on~~  
23 ~~the commission who include a male custodial parent, a female custodial~~  
24 ~~parent, a male noncustodial parent, a female noncustodial parent, a joint~~  
25 ~~custodial parent, and a parent in an intact family.~~ In making his or her  
26 appointments to the commission, the governor shall attempt to assure  
27 geographical diversity. ~~by appointing at least one member from each of~~

1 ~~the congressional districts in the state.~~ The remaining two members of the  
2 commission shall be a member of the house of representatives appointed  
3 by the speaker of the house of representatives and a member of the senate  
4 appointed by the president of the senate and shall not be members of the  
5 same political party.

6 (d) Members of the child support commission shall not be  
7 compensated for their services on the commission; except that members  
8 shall be reimbursed for actual and necessary expenses for travel and  
9 mileage incurred in connection with their duties. The child support  
10 commission is authorized, subject to appropriation, to incur expenses  
11 related to its work, including the costs associated with public hearings,  
12 printing, travel, and research.

13 ~~(d.5) The terms of the members appointed by the speaker of the~~  
14 ~~house of representatives and the president of the senate who are serving~~  
15 ~~on March 22, 2007, shall be extended to and expire on or shall terminate~~  
16 ~~on the convening date of the first regular session of the sixty-seventh~~  
17 ~~general assembly. As soon as practicable after such convening date, the~~  
18 ~~speaker and the president shall each appoint or reappoint one member in~~  
19 ~~the same manner as provided in paragraph (c) of this subsection (16).~~

1           **SECTION 3.** In Colorado Revised Statutes, 14-10-122, **amend**  
2 (1) (a) and (5) as follows:

3           **14-10-122. Modification and termination of provisions for**  
4 **maintenance, support, and property disposition - automatic lien.**

5 (1) (a) Except as otherwise provided in ~~section~~ SECTIONS 14-10-112 (6)  
6 AND 14-10-115 (11) (c), the provisions of any decree respecting  
7 maintenance may be modified only as to installments accruing subsequent  
8 to the motion for modification and only upon a showing of changed  
9 circumstances so substantial and continuing as to make the terms unfair,  
10 and, except as otherwise provided in subsection (5) of this section, the  
11 provisions of any decree respecting child support may be modified only  
12 as to installments accruing subsequent to the filing of the motion for  
13 modification and only upon a showing of changed circumstances that are  
14 substantial and continuing or on the ground that the order does not  
15 contain a provision regarding medical support, such as insurance  
16 coverage, payment for medical insurance deductibles and copayments, or  
17 unreimbursed medical expenses. The provisions as to property disposition  
18 may not be revoked or modified unless the court finds the existence of  
19 conditions that justify the reopening of a judgment.

25 THE PROVISIONS FOR THE ESTABLISHMENT OF A CHILD SUPPORT ORDER

10 (I) HAS NOT PREVIOUSLY BEEN EMPLOYED BY THE EMPLOYER; OR  
11 (II) WAS PREVIOUSLY EMPLOYED BY THE EMPLOYER BUT HAS BEEN  
12 SEPARATED FROM HIS OR HER PRIOR EMPLOYMENT FOR AT LEAST SIXTY  
13 CONSECUTIVE DAYS.

14 (2) The state department, or its agent, shall establish and maintain  
15 a state directory of new hires on and after October 1, 1997, for the  
16 purpose of locating newly hired ~~individuals~~ EMPLOYEES for the purposes  
17 of establishing, enforcing, or modifying child support obligations and for  
18 other purposes specified in paragraph (b) of subsection (8) of this section.

19 (3) Effective October 1, 1997, each employer shall submit to the  
20 state directory of new hires a copy of the W-4 form or, at the option of the  
21 employer, an equivalent form for each ~~new~~ NEWLY HIRED employee ~~hired~~  
22 ~~to work~~ in Colorado. ~~on or after said date.~~ The report may be transmitted  
23 to the state department by first class mail, magnetically, or electronically.  
24 The report ~~shall~~ MUST contain the NEWLY HIRED employee's name,  
25 address, ~~and~~ social security number, AND THE DATE SERVICES FOR  
26 REMUNERATION WERE FIRST PERFORMED BY THE NEWLY HIRED EMPLOYEE.  
27 The report ~~shall~~ MUST contain the name and address of the employer and

1 the identifying number assigned to the employer under section 6109 of  
2 the federal "Internal Revenue Code of 1986", as amended. No liability  
3 shall attach to any employer for furnishing information pursuant to this  
4 section. No employer shall be required to submit to the state directory of  
5 new hires a report concerning any employee hired for less than thirty  
6 days.

7 **SECTION 5. Effective date.** This act takes effect January 1,  
8 2014.

9 **SECTION 6. Act subject to petition - effective date.** This act  
10 takes effect at 12:01 a.m. on the day following the expiration of the  
11 ninety-day period after final adjournment of the general assembly (August  
12 7, 2013, if adjournment sine die is on May 8, 2013); except that, if a  
13 referendum petition is filed pursuant to section 1 (3) of article V of the  
14 state constitution against this act or an item, section, or part of this act  
15 within such period, then the act, item, section, or part will not take effect  
16 unless approved by the people at the general election to be held in  
17 November 2014 and, in such case, will take effect on the date of the  
18 official declaration of the vote thereon by the governor.
