**A BILL FOR AN ACT**

101 **CONCERNING THE WILDLAND FIRE COST RECOVERY FUND.**

---

**Bill Summary**

**Joint Budget Committee.** House Bill 12-1283 established the wildland fire cost recovery fund (fund), which is administered by the division of fire prevention and control in the department of public safety to finance personnel and operating expenses associated with wildland fire suppression activities. The bill:

- ! Makes the fund noninterest-bearing;
- ! Exempts wildland fire cost recovery activities for which the

fund is used from the \$12 million limit imposed on  
advances authorized by the controller; and  
! Corrects an incorrect statutory citation relating to the fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1220,  
3 **amend** (4) and (5) as follows:

4 **24-33.5-1220. Funds available - emergency fire fund - wildland**  
5 **fire equipment repair fund - wildland fire cost recovery fund -**  
6 **creation - gifts, grants, and donations authorized.** (4) (a) There is  
7 hereby created in the state treasury the wildland fire cost recovery fund,  
8 ~~which fund shall~~ TO be administered by the division for personnel and  
9 operating expenses associated with WILDLAND fire suppression activities.  
10 The division is authorized to seek and accept gifts, grants,  
11 reimbursements, or donations from private or public sources for the  
12 purposes of this ~~section~~ SUBSECTION (4). The fund consists of all moneys  
13 recovered for the division's expenditures for WILDLAND fire suppression  
14 moneys that may be appropriated thereto by the general assembly and all  
15 private and public funds, including from counties and the Denver water  
16 board, received through gifts, grants, reimbursements, or donations that  
17 are transmitted to the state treasurer and credited to the fund. ~~All interest~~  
18 ~~earned from the investment of moneys in the fund shall be credited to the~~  
19 ~~fund.~~ THE FUND IS NONINTEREST-BEARING. The moneys in the fund are  
20 hereby continuously appropriated for the purposes set forth in this ~~section~~  
21 SUBSECTION (4). Any moneys not expended at the end of the fiscal year  
22 shall remain in the fund and shall not be transferred to or revert to the  
23 general fund.

24 (b) NOTWITHSTANDING ANY LIMITATION ON THE AMOUNT OF

1       ADVANCES SET FORTH IN SECTION 24-75-203 (2), THE CONTROLLER MAY  
2       AUTHORIZE AN ADVANCE WITHOUT INTEREST IN ANY AMOUNT TO BE MADE  
3       TO THE DIVISION TO PROVIDE IT WITH WORKING CAPITAL FOR THE  
4       OPERATION OF WILDLAND FIRE SUPPRESSION ACTIVITIES TO WHICH  
5       WILDLAND FIRE COST RECOVERY FUND MONEYS ARE ALLOCATED  
6       PURSUANT TO THIS SUBSECTION (4).

7               (5) Notwithstanding any provision of law to the contrary, the  
8       funds established under subsections (2), (3), and (4) of this section are  
9       exempt from the limitations set forth in ~~section 24-72-402~~ SECTION  
10      24-75-402.

11              **SECTION 2. Safety clause.** The general assembly hereby finds,  
12      determines, and declares that this act is necessary for the immediate  
13      preservation of the public peace, health, and safety.
