Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB13-1114 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 20, after line 22 insert:

2 "SECTION 21. **Appropriation.** In addition to any other
3 appropriation, there is hereby appropriated, out of any moneys in the
4 general fund not otherwise appropriated, to the judicial department, for
5 the fiscal year beginning July 1, 2013, the sum of \$12,000, or so much
6 thereof as may be necessary, for allocation to the office of the state public
7 defender for mandated costs related to the implementation of this act.

8 SECTION 22. In Colorado Revised Statutes, **add** 17-18-108 as
9 follows:

10 **17-18-108. Appropriation to comply with section 2-2-703 - HB**
11 **13-1114 - repeal.** (1) PURSUANT TO SECTION 2-2-703, C.R.S., THE
12 FOLLOWING STATUTORY APPROPRIATIONS, OR SO MUCH THEREOF AS MAY
13 BE NECESSARY, ARE MADE IN ORDER TO IMPLEMENT HOUSE BILL 13-1114,
14 ENACTED IN 2013:

15 (a) FOR THE FISCAL YEAR BEGINNING JULY 1, 2014, IN ADDITION
16 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
17 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
18 OTHERWISE APPROPRIATED, THE SUM OF TWENTY THOUSAND EIGHT
19 HUNDRED SIXTEEN DOLLARS (\$20,816).

20 (b) FOR THE FISCAL YEAR BEGINNING JULY 1, 2015, IN ADDITION TO
21 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
22 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
23 OTHERWISE APPROPRIATED, THE SUM OF FIVE THOUSAND FIVE HUNDRED

- 1 FIFTY-ONE DOLLARS (\$5,551).
- 2 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2016."
- 3 Renumber succeeding section accordingly.
- 4 Page 1, line 102, strike "DRUGS." and substitute "DRUGS, AND, IN
- 5 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
