Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB13-1292 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 25, after line 18 insert:

2           **"SECTION 17. Appropriation.** (1) In addition to any other  
3 appropriation, there is hereby appropriated, out of any moneys in the  
4 general fund, not otherwise appropriated, to the department of labor and  
5 employment, for the fiscal year beginning July 1, 2013, the sum of  
6 \$98,519 and 1.0 FTE, or so much thereof as may be necessary, to be  
7 allocated for the implementation of this act as follows:

8           (a) \$63,757 and 1.0 FTE for personal services and operating  
9 expenses in the division of labor; and

10           (b) \$34,762 for the purchase of legal services.

11           (2) In addition to any other appropriation, there is hereby  
12 appropriated to the department of law, for the fiscal year beginning July  
13 1, 2013, the sum of \$34,762 and 0.3 FTE, or so much thereof as may be  
14 necessary, for the provision of legal services for the department of labor  
15 and employment related to the implementation of this act. Said sum is  
16 from reappropriated funds received from the department of labor and  
17 employment out of the appropriation made in paragraph (b) of subsection  
18 (1) of this section.

19           (3) In addition to any other appropriation, there is hereby  
20 appropriated, out of any moneys in the general fund, not otherwise  
21 appropriated, to the department of personnel, for the fiscal year beginning  
22 July 1, 2013, the sum of \$364,099 and 2.0 FTE, or so much thereof as  
23 may be necessary, to be allocated for the implementation of this act as

1 follows:

2 (a) \$127,511 and 2.0 FTE to be allocated to the office of the state  
3 architect for personal services and operating expenses;

4 (b) \$225,000 for computer programming costs; and

5 (c) \$11,588 for the purchase of legal services.

6 (4) In addition to any other appropriation, there is hereby  
7 appropriated to the department of law, for the fiscal year beginning July  
8 1, 2013, the sum of \$11,588, or so much thereof as may be necessary, for  
9 the provision of legal services for the department of personnel related to  
10 the implementation of this act. Said sum is from reappropriated funds  
11 received from the department of personnel out of the appropriation made  
12 in paragraph (c) of subsection (3) of this section."

13 Renumber succeeding sections accordingly.

14 Page 1, line 103, strike "**EMPLOYMENT.**" and substitute "**EMPLOYMENT,**  
15 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
