Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB13-1211 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Education Committee Report, dated March 27, 2013, page 9,
2 line 37, strike "**rules - repeal.**" and substitute "**rules.**".

3 Page 11, strike lines 3 and 4.

4 Page 11, before line 5 insert:

5 **"SECTION 2. Appropriation.** (1) In addition to any other
6 appropriation, there is hereby appropriated, out of any moneys in the state
7 education fund created in section 17 (4) (a) of article IX of the state
8 constitution, not otherwise appropriated, to the department of education,
9 for the fiscal year beginning July 1, 2013, the sum of \$3,090, or so much
10 thereof as may be necessary, for the purchase of legal services.

11 (2) In addition to any other appropriation, there is hereby
12 appropriated to the department of law, for the fiscal year beginning July
13 1, 2013, the sum of \$3,090, or so much thereof as may be necessary, for
14 the provision of legal services for the department of education related to
15 the implementation of this act. Said sum is from reappropriated funds
16 received from the department of education out of the appropriation made
17 in subsection (1) of this section.

18 (3) In addition to any other appropriation, there is hereby
19 appropriated, out of any moneys in the state education fund created in
20 section 17 (4) (a) of article IX of the state constitution, not otherwise
21 appropriated, to the department of education, for the fiscal year beginning
22 July 1, 2013, the sum of \$479,144 and 6.0 FTE, or so much thereof as
23 may be necessary, for the implementation of this act as follows:

- 1 (a) \$424,426 and 6.0 FTE for personal services; and
2 (b) \$54,718 for operating expenses and other expenses.
3 (4) In addition to any other appropriation, for the fiscal year
4 beginning July 1, 2013, there is hereby appropriated, out of any moneys
5 in the state education fund created in section 17 (4) (a) of article IX of the
6 state constitution, not otherwise appropriated, to the department of
7 education to be credited to the excellence awards fund created in section
8 22-24-107 (4) (a), Colorado Revised Statutes, the sum of \$250,000, to be
9 used for purposes consistent with the creation of the fund.
10 (5) In addition to any other appropriation, there is hereby
11 appropriated, out of the excellence awards fund, to the department of
12 education, for the fiscal year beginning July 1, 2013, the sum of
13 \$250,000, or so much thereof as may be necessary, for allocation to grant
14 programs, distributions, and other assistance for awards to local education
15 providers pursuant to section 22-24-107, Colorado Revised Statutes.
16 (6) In addition to any other appropriation, for the fiscal year
17 beginning July 1, 2013, there is hereby appropriated, out of any moneys
18 in the state education fund created in section 17 (4) (a) of article IX of the
19 state constitution, not otherwise appropriated, to the department of
20 education to be credited to the professional development and student
21 support fund created in section 22-24-108 (3) (a), Colorado Revised
22 Statutes, the sum of \$6,267,766, to be used for purposes consistent with
23 the creation of the fund.
24 (7) In addition to any other appropriation, there is hereby
25 appropriated, out of the professional development and student support
26 fund, to the department of education, for the fiscal year beginning July 1,
27 2013, the sum of \$6,267,766, or so much thereof as may be necessary, for
28 allocation to grant programs, distributions, and other assistance for
29 distribution to local education providers pursuant to section 22-24-108,
30 Colorado Revised Statutes."

31 Page 11 of the committee report, line 5, strike "**SECTION 2.**" and
32 substitute "**SECTION 3.**".

33 Page 11 of the committee report, after line 7 insert:

34 "Page 1 of the printed bill, line 102, strike "**SCHOOLS.**" and substitute
35 "**SCHOOLS, AND, IN CONNECTION THEREWITH, MAKING AN**
36 **APPROPRIATION.**".
