101      **CONCERNING APPROVAL OF THE PERFORMANCE CONTRACT BETWEEN**  
102                    **THE COLORADO SCHOOL OF MINES AND THE COLORADO**

1                    WHEREAS, The General Assembly has recognized Colorado  
2 School of Mines as an exemplary institution of higher education that has  
3 demonstrated a high degree of responsibility and capability with regard  
4 to its academic and administrative functions; and

5                    WHEREAS, The General Assembly authorized Colorado School  
6 of Mines to be the first Colorado institution of higher education to operate  
7 under a performance contract; and

8                    WHEREAS, Pursuant to sections 23-1-108 (1.5) (f) and

1 23-41-104.6, Colorado Revised Statutes, the Colorado Commission on  
2 Higher Education and Colorado School of Mines have negotiated a new  
3 performance contract; and

4 WHEREAS, Section 23-41-104.6 (4), Colorado Revised Statutes,  
5 provides that the performance contract shall not take effect until approved  
6 by a joint resolution adopted by the General Assembly; and

7 WHEREAS, Section 23-41-104.6 (4), Colorado Revised Statutes,  
8 also requires approval of the terms of the performance contract by a  
9 majority of the members of the education committees of the House of  
10 Representatives and the Senate and the members of the Joint Budget  
11 Committee of the General Assembly; and

12 WHEREAS, Said education committees and said Joint Budget  
13 Committee met in a joint session on January 30, 2013, to review the  
14 provisions of the contract, and a majority of the members of said  
15 committees approved the terms of the performance contract; and

16 WHEREAS, Section 23-41-104.6 (4), Colorado Revised Statutes,  
17 requires the chairpersons of the education committees of the House of  
18 Representatives and the Senate, in cooperation with the Joint Budget  
19 Committee, to sponsor a joint resolution to recognize and approve the  
20 performance contract, and the performance contract is deemed approved  
21 upon the final passage of said joint resolution; now, therefore,

22 *Be It Resolved by the House of Representatives of the Sixty-ninth*  
23 *General Assembly of the State of Colorado, the Senate concurring herein:*

24 That the new performance contract between the Colorado School  
25 of Mines and the Colorado Commission on Higher Education is hereby  
26 recognized and approved.

27 *Be It Further Resolved*, That copies of this Joint Resolution be sent  
28 to the board of trustees of the Colorado School of Mines and to the  
29 Colorado Commission on Higher Education.
