**A BILL FOR AN ACT**

101     **CONCERNING IMPROVING ACCESS TO CHILDHOOD IMMUNIZATIONS,**  
102     **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law prohibits the department of public health and environment (department) from establishing a universal purchasing system for procuring vaccines for insured individuals in the state.

**Section 2** of the bill removes the barrier to establishing a vaccine

purchasing system. **Section 4** authorizes the department, for purposes of increasing access to immunizations, to examine mechanisms for statewide purchase of vaccines, including childhood immunizations, and options for the state to more effectively purchase and distribute vaccines for insured individuals in the state. Additionally, the department is to explore authorizing the department of health care policy and financing to purchase vaccines recommended by the federal advisory committee on immunization practices (ACIP). Section 3 also:

- ! Requires the department to convene a stakeholder task force to make recommendations regarding the financing and delivery of childhood immunizations, including through a vaccine purchasing system; and
- ! Authorizes the state board of health to adopt rules to implement the task force's recommendations.

**Section 3** of the bill authorizes the department to expend moneys in the immunization fund to purchase vaccines through a vaccine purchasing system, if developed.

**Section 5** of the bill permits the department of health care policy and financing to purchase vaccines recommended by the ACIP through a vaccine purchasing system, if developed, for children enrolled in the children's basic health plan.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby finds that:

4 (a) Colorado's current system of financing and delivering  
5 childhood immunizations is complicated and presents barriers for  
6 providers, patients, and payers;

7 (b) The current fragmented system creates access issues because  
8 some small and rural providers are unable to afford to stock and deliver  
9 vaccine, thus forcing the patient to seek immunizations elsewhere and  
10 eroding the medical home;

11 (c) Many of Colorado's primary care providers report that, in a  
12 private office setting, the cost to purchase and deliver childhood  
13 immunizations is second only to the cost of personnel, resulting in many

1 providers being unable to offer immunizations;

2 (d) Colorado's primary care providers are required to keep  
3 different inventory and accounting systems for vaccine stock, based on  
4 the insurance status of patients, resulting in a "two drawer" system;

5 (e) Recent changes in federal law prohibit local public health  
6 agencies from providing federally funded immunizations to patients with  
7 private insurance, including situations in which a primary care provider  
8 is unable to offer immunizations and refers a patient to the local public  
9 health agency;

10 (f) In the future, local public health agencies will only be able to  
11 provide immunizations to insured children if the family is able to pay for  
12 the cost of the vaccine or the agency implements a sophisticated billing  
13 procedure with each private payer;

14 (g) Vaccines for children enrolled in the state's medicaid program  
15 are received from the vaccines for children program, taking advantages  
16 of economies of scale and bulk purchasing power;

17 (h) Vaccines for the children's basic health plan are purchased in  
18 the commercial market, creating a fragmented funding system for the  
19 state's public health programs;

20 (i) The current patchwork of conflicting vaccine financing and  
21 requirement system makes it difficult to respond to disease outbreaks with  
22 a statewide, systematic plan and response;

23 (j) In order to ease the administrative and financial burdens on the  
24 state's primary care providers and thus expand access to vaccines for  
25 Colorado children, the state needs to take a comprehensive look at the  
26 current system of vaccine financing and delivery; ==

27 (k) Allowing provider choice in any purchasing system aids in the

1 most effective and efficient management of a patient's care and supports  
2 stable vaccine supply for the community; and

3 (1) Colorado is in a unique position to examine existing models,  
4 as well as proposed models, for vaccine financing and delivery in order  
5 to create an efficient solution designed with cost savings and effective  
6 administration in mind.

7 **SECTION 2.** In Colorado Revised Statutes, 25-4-1705, **amend**  
8 (9) (b) as follows:

9 **25-4-1705. Department of public health and environment -**  
10 **powers and duties - rules.** (9) (b) The department or any person who  
11 contracts with the department pursuant to subsection (7) of this section  
12 ~~shall not~~ MAY establish a ~~universal~~ purchase system AS DESCRIBED IN  
13 SECTION 25-4-2403 for the procurement of vaccines for privately insured  
14 persons under federal government contracts.

15 **SECTION 3.** In Colorado Revised Statutes, 25-4-1708, **amend**  
16 (1) as follows:

17 **25-4-1708. Fund created.** (1) (a) There is hereby established in  
18 the state treasury a fund to be known as the immunization fund, which  
19 fund ~~shall be~~ IS subject to annual appropriation BY THE GENERAL  
20 ASSEMBLY to the department of public health and environment ~~by the~~  
21 ~~general assembly~~ for the purposes of:

22 (I) Purchasing vaccines, INCLUDING PURCHASING VACCINES  
23 THROUGH A VACCINE PURCHASING SYSTEM, IF SUCH A SYSTEM IS  
24 DEVELOPED PURSUANT TO SECTION 25-4-2403 (1) AND (1.3), WHICH  
25 SYSTEM MAY INCLUDE VACCINES FOR PRIVATELY INSURED INDIVIDUALS;

26 (II) Assisting users of the immunization tracking system  
27 established in section 25-4-2403 to connect to the system;

1 (III) Utilizing the reminder and recall process of the immunization  
2 tracking system; and

3 (IV) Implementing, developing, and operating immunization  
4 programs.

5 (b) The fund ~~shall be credited with such appropriations as~~  
6 CONSISTS OF:

7 (I) MONEYS APPROPRIATED BY the general assembly ~~may make~~  
8 from the general fund for immunization programs;

9 (II) Any gifts, grants, or awards received pursuant to sections  
10 25-4-1705 (6) and 25-4-2403 (9) (c) OR FOR PURPOSES OF EXPANDING  
11 ACCESS TO CHILDHOOD IMMUNIZATIONS; and

12 (III) Moneys received from the state department of health care  
13 policy and financing as reimbursement pursuant to section 25-4-1707.

14 (c) THE STATE TREASURER SHALL CREDIT TO THE FUND all income  
15 from the investment of moneys in the fund. ~~shall be credited to the fund.~~

16 (d) THE DEPARTMENT SHALL USE THE MONEYS IN THE  
17 IMMUNIZATION FUND TO PAY THE DEPARTMENT'S DIRECT AND INDIRECT  
18 COSTS OF ADMINISTERING THE PROGRAMS DESCRIBED IN PARAGRAPH (a)  
19 OF THIS SUBSECTION (1).

20 **SECTION 4.** In Colorado Revised Statutes, 25-4-2403, **amend**  
21 (1) introductory portion, (1) (a), (1) (c), and (1) (f); and **add** (1.3) and  
22 (13) as follows:

23 **25-4-2403. Department of public health and environment -**  
24 **powers and duties - immunization tracking system.** (1) In order to  
25 expand the immunization registry and increase access to immunizations,  
26 the department of ~~public health and environment~~ may address:

27 (a) Mechanisms for:

1 (I) Maximizing federal funds to purchase, distribute, and deliver  
2 vaccines for individuals in Colorado; ~~including, but not limited to,~~  
3 ~~participation in a state purchasing and distribution cooperative and the~~  
4 ~~mechanisms for~~

5 (II) Statewide purchase, distribution, and prioritization ~~to include,~~  
6 ~~but not be limited to~~ OF VACCINES, INCLUDING CHILDHOOD  
7 IMMUNIZATIONS AND the seasonal influenza vaccine;

8 (c) Options for Colorado to more effectively purchase, distribute,  
9 and deliver vaccines to INSURED, underinsured, and uninsured individuals;

10 (f) ~~Methods for implementing the findings addressed in~~  
11 ~~paragraphs (a) to (d) of~~ THE ABILITY OF THE DEPARTMENT OF HEALTH  
12 CARE POLICY AND FINANCING TO PURCHASE VACCINES RECOMMENDED BY  
13 ACIP THROUGH A PURCHASING SYSTEM, IF DEVELOPED PURSUANT TO this  
14 subsection (1) AND SUBSECTION (1.3) OF THIS SECTION, FOR CHILDREN  
15 WHO ARE ENROLLED IN THE CHILDREN'S BASIC HEALTH PLAN CREATED IN  
16 ARTICLE 8 OF TITLE 25.5, C.R.S.

17 (1.3) (a) THE DEPARTMENT SHALL CONVENE A TASK FORCE OF  
18 INTERESTED STAKEHOLDERS TO CONSIDER THE ISSUES IDENTIFIED IN  
19 SUBSECTION (1) OF THIS SECTION. THE TASK FORCE MUST CONSIST OF AT  
20 LEAST THE FOLLOWING PERSONS OR GROUPS:

21 (I) PRIMARY CARE PROVIDERS, INCLUDING ESSENTIAL COMMUNITY  
22 PROVIDERS, PEDIATRICIANS, FAMILY PHYSICIANS, MID-LEVEL PROVIDERS,  
23 AND PRACTICE MANAGERS;

24 (II) PHARMACISTS FROM BOTH INDEPENDENT AND CHAIN  
25 PHARMACIES;

26 (III) LOCAL PUBLIC HEALTH PROVIDERS;

27 (IV) CHILD HEALTH ADVOCATES;

1 (V) HEALTH INSURERS AND OTHER PERSONS WHO PAY FOR HEALTH  
2 CARE SERVICES;

3 (VI) A REPRESENTATIVE FROM A COLORADO-BASED INNOVATIVE  
4 VACCINE COMPANY;

5 (VII) PHARMACEUTICAL MANUFACTURERS; AND

6 (VIII) REPRESENTATIVES FROM THE DEPARTMENTS OF PUBLIC  
7 HEALTH AND ENVIRONMENT AND HEALTH CARE POLICY AND FINANCING.

8 (b) THE TASK FORCE SHALL MAKE RECOMMENDATIONS TO THE  
9 DEPARTMENT AND THE BOARD ON THE FINANCING, ORDERING, AND  
10 DELIVERY OF CHILDHOOD IMMUNIZATIONS, INCLUDING THROUGH ANY OF  
11 THE FOLLOWING METHODS:

12 (I) A PUBLIC-PRIVATE MODEL OF VACCINE PURCHASE AND  
13 DELIVERY;

14 (II) JUST-IN-TIME DELIVERY;

15 (III) INVENTORY MANAGEMENT, INCLUDING VACCINE CHOICES,  
16 COMBINATION VACCINES, AND EQUIVALENT VACCINES;

17 (IV) OUTBREAK RESPONSE;

18 (V) LINKAGE BETWEEN THE IMMUNIZATION TRACKING SYSTEM  
19 ESTABLISHED PURSUANT TO SUBSECTION (2) OF THIS SECTION AND  
20 VACCINE INVENTORY;

21 (VI) VACCINE SHORTAGE RESPONSE;

22 (VII) PRESERVATION OF VACCINE DELIVERY IN A MEDICAL HOME  
23 MODEL OF CARE;

24 (VIII) MECHANISMS FOR LOCAL PUBLIC HEALTH ENTITIES TO BILL  
25 HEALTH INSURANCE CARRIERS; AND

26 (IX) CONTINUATION AND PRESERVATION OF CURRENT MODELS OF  
27 VACCINE PURCHASE, FINANCING, AND DELIVERY AND THE ABILITY OF

1 HEALTH CARE PROVIDERS TO USE THOSE CURRENT MODELS OR ANY NEW  
2 MODELS THAT MAY BE DEVELOPED PURSUANT TO THIS SUBSECTION (1.3)  
3 AND SUBSECTION (1) OF THIS SECTION.

4 (c) THE BOARD MAY ADOPT RULES AS NECESSARY TO IMPLEMENT  
5 THE RECOMMENDATIONS OF THE TASK FORCE.

6 (d) NO HEALTH CARE PROVIDER IS COMPELLED TO PARTICIPATE IN  
7 A VACCINE PURCHASING SYSTEM, IF SUCH SYSTEM IS DEVELOPED  
8 PURSUANT TO THIS SECTION.

9 (13) AS USED IN THIS SECTION:

10 (a) "ACIP" MEANS THE ADVISORY COMMITTEE ON IMMUNIZATION  
11 PRACTICES TO THE CENTERS FOR DISEASE CONTROL AND PREVENTION IN  
12 THE FEDERAL DEPARTMENT OF HEALTH AND HUMAN SERVICES, OR ITS  
13 SUCCESSOR ENTITY.

14 (b) "BOARD" MEANS THE STATE BOARD OF HEALTH CREATED IN  
15 SECTION 25-1-103.

16 (c) "DEPARTMENT" MEANS THE DEPARTMENT OF PUBLIC HEALTH  
17 AND ENVIRONMENT CREATED IN SECTION 25-1-102.

18 (d) "EQUIVALENT VACCINES" MEANS TWO OR MORE VACCINES  
19 THAT:

20 (I) PROTECT A RECIPIENT OF THE VACCINE AGAINST THE SAME  
21 INFECTION;

22 (II) HAVE SIMILAR SAFETY AND EFFICACY PROFILES; AND

23 (III) ARE RECOMMENDED FOR COMPARABLE POPULATIONS BY THE  
24 FEDERAL CENTERS FOR DISEASE CONTROL AND PREVENTION.

25 **SECTION 5.** In Colorado Revised Statutes, 25.5-8-107, **add** (5)  
26 as follows:

27 **25.5-8-107. Duties of the department - schedule of services -**



1 **premiums - copayments - subsidies - purchase of childhood**  
2 **immunizations.** (5) THE DEPARTMENT MAY PURCHASE VACCINES  
3 RECOMMENDED BY THE ADVISORY COMMITTEE ON IMMUNIZATION  
4 PRACTICES TO THE CENTERS FOR DISEASE CONTROL AND PREVENTION IN  
5 THE FEDERAL DEPARTMENT OF HEALTH AND HUMAN SERVICES, OR ITS  
6 SUCCESSOR ENTITY, THROUGH A VACCINE PURCHASING SYSTEM, IF SUCH  
7 A SYSTEM IS DEVELOPED PURSUANT TO SECTION 25-4-2403 (1), C.R.S.,  
8 FOR CHILDREN ENROLLED IN THE CHILDREN'S BASIC HEALTH PLAN.

9 **SECTION 6. Appropriation.** In addition to any other  
10 appropriation, there is hereby appropriated, out of any moneys in the  
11 general fund, not otherwise appropriated, to the department of public  
12 health and environment, for the fiscal year beginning July 1, 2013, the  
13 sum of \$68,054 and 1.0 FTE, or so much thereof as may be necessary, to  
14 be allocated to the disease control and environmental epidemiology  
15 division for the implementation of this act as follows:

16 <u>Immunization Personal Services</u>	<u>\$62,401 and 1.0 FTE</u>
17 <u>Immunization Operating Expenses</u>	<u>\$5,653.</u>

18 **SECTION 7. Safety clause.** The general assembly hereby finds,  
19 determines, and declares that this act is necessary for the immediate  
20 preservation of the public peace, health, and safety.
