**A BILL FOR AN ACT**

101 **CONCERNING THE COLLECTION OF BUSINESS INFORMATION BY THE**  
102 **SECRETARY OF STATE, AND, IN CONNECTION THEREWITH,**  
103 **MAKING AN APPROPRIATION.**

The bill requires the secretary of state to request information from each business owner that files documents with the secretary of state regarding whether the business is owned by a woman, minority, veteran, or person with a disability and requires the secretary of state to make the

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 24-21-114 as  
3 follows:

4 **24-21-114. Secretary of state collection of business information.**

5 BEGINNING THIRTY DAYS AFTER THE EFFECTIVE OF THIS SECTION, THE  
6 SECRETARY OF STATE SHALL REQUEST THAT EACH INDIVIDUAL WHO FILES  
7 DOCUMENTS WITH THE SECRETARY OF STATE PURSUANT TO PART 3 OF  
8 ARTICLE 90 OF TITLE 7, C.R.S., SUBMIT INFORMATION TO THE SECRETARY  
9 OF STATE UPON INITIAL REGISTRATION OF A BUSINESS AND WHEN  
10 UPDATING A BUSINESS REGISTRATION. THE SECRETARY OF STATE SHALL  
11 REQUEST THAT EACH REPORTING ENTITY, AS THAT TERM IS DEFINED IN  
12 SECTION 7-90-102 (58), C.R.S., TO WHICH THE FILING RELATES, SUBMIT  
13 THE FOLLOWING INFORMATION ABOUT THE REPORTING ENTITY: GENDER;  
14 RACE, INCLUDING WHETHER THE PERSON IS LATINO, AFRICAN AMERICAN,  
15 ASIAN, ANGLO, NATIVE AMERICAN, OR OTHER; VETERAN STATUS;  
16 WHETHER THE REPORTING ENTITY IS A PERSON WITH A DISABILITY; AND  
17 THE NATIONAL AMERICAN INDUSTRY CLASSIFICATION SYSTEM CODE OR ITS  
18 SUCCESSOR CODE OF THE REPORTING ENTITY'S BUSINESS, IF APPLICABLE.

19 THE INDIVIDUAL IS NOT REQUIRED TO SUBMIT THE INFORMATION. THE  
20 SECRETARY OF STATE SHALL MAKE THE INFORMATION AVAILABLE TO THE  
21 PUBLIC ON THE SECRETARY OF STATE'S WEB SITE IN A SEARCHABLE  
22 MANNER BY THE INFORMATION SUBMITTED.

23 **SECTION 2. Appropriation.** In addition to any other  
24 appropriation, there is hereby appropriated, out of any moneys in the  
25 department of state cash fund created in section 24-21-104 (3) (b),

1 Colorado Revised Statutes, not otherwise appropriated, to the department  
2 of state, for the fiscal year beginning July 1, 2013, the sum of \$74,592, or  
3 so much thereof as may be necessary, for allocation to information  
4 technology services for contract programming services related to the  
5 implementation of this act.

6 **SECTION 3. Act subject to petition - effective date.** This act  
7 takes effect January 1, 2014, except that, if a referendum petition is filed  
8 pursuant to section 1 (3) of article V of the state constitution against this  
9 act or an item, section, or part of this act within the ninety-day period  
10 after final adjournment of the general assembly, then the act, item,  
11 section, or part will not take effect unless approved by the people at the  
12 general election to be held in November 2014 and, in such case, will take  
13 effect on the date of the official declaration of the vote thereon by the  
14 governor.
