SB13-226 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

- 1 Amend printed bill, page 3, strike lines 6 through 27.
- 2 Strike page 4.
- 3 Page 5, strike lines 1 through 22.
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 7, line 14, strike "a matter of" and substitute "necessary and  
6 appropriate".
- 7 Page 7, line 15, strike "statewide concern".
- 8 Page 8, line 11, strike "AND A".
- 9 Page 8, line 12, strike "MATTER OF STATEWIDE CONCERN".
- 10 Page 10, line 22, after "(II)" insert "(A)".
- 11 Page 11, after line 1 insert:  
12 "(B) NOTHING IN SUB-SUBPARAGRAPH (A) OF THIS SUBPARAGRAPH  
13 (II) REQUIRES LIVE, IN-PERSON TRAINING BE PROVIDED TO LOCAL LAW  
14 ENFORCEMENT AGENCIES BY QUALIFIED ANIMAL BEHAVIOR EXPERTS OR  
15 LICENSED VETERINARIANS."

- 1 Page 12, line 2, strike "TWENTY-THREE" and substitute "NINETEEN".
- 2 Page 12, line 8, strike "REPRESENTATIVE OF" and substitute "ANIMAL  
3 BEHAVIORIST OR ANIMAL BEHAVIOR EXPERT APPOINTED BY".
- 4 Page 12, strike lines 24 through 27.
- 5 Renumber succeeding subparagraphs accordingly.
- 6 Page 13, line 4, strike "PERSON" and substitute "PERSON, WHO NEED NOT  
7 BE AN ATTORNEY,".
- 8 Page 13, line 6, strike "THREEMEMBERS," and substitute "ONE MEMBER,".
- 9 Page 13, line 7, strike "CRIMINAL JUSTICE,".
- 10 Page 13, strike line 8 and substitute "BEHAVIOR OR OTHER ANIMAL  
11 BEHAVIOR. LICENSED VETERINARIANS AND ATTORNEYS ARE INELIGIBLE  
12 FOR APPOINTMENT UNDER THIS SUB-SUBPARAGRAPH (I).".
- 13 Page 14, line 24, strike "DEVELOP" and substitute "DEVELOP, USING  
14 VOLUNTEERED AND DONATED RESOURCES TO THE GREATEST EXTENT  
15 POSSIBLE,".
- 16 Page 14, after line 26 insert:  
17 "(e) THE TASK FORCE SHALL NOT RECOMMEND THAT THE TRAINING  
18 REQUIRED UNDER THIS SECTION BE CONDUCTED BY THE PEACE OFFICERS  
19 STANDARDS AND TRAINING BOARD CREATED IN PART 3 OF ARTICLE 31 OF  
20 TITLE 24, C.R.S.".
- 21 Reletter succeeding paragraphs accordingly.
- 22 Page 16, line 15, strike "(a)".
- 23 Page 16, strike lines 18 through 22.
- 24 Page 17, strike lines 10 through 22.
- 25 Renumber succeeding section accordingly.
