Human trafficking and slavery - directive to 5 Colorado commission on criminal and juvenile justice - repeal. 6 (1) THE COLORADO COMMISSION ON CRIMINAL AND JUVENILE JUSTICE 7 CREATED AND EXISTING PURSUANT TO SECTION 16-11.3-102, C.R.S., 8 SHALL REVIEW THE RESULTS OF THE IMPLEMENTATION OF THE PROVISIONS 9 OF THIS PART 5 SINCE THEIR ENACTMENT IN 2006. THE COMMISSION SHALL 10 COMPLETE A REPORT OF ITS FINDINGS AND SUBMIT THE REPORT TO THE 11 JUDICIARY COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND SENATE, 12 OR ANY SUCCESSOR COMMITTEES, ON OR BEFORE JANUARY 1, 2014.

14 (a) THE NUMBER OF CASES PROSECUTED AND CONVICTIONS
15 DECLARED WITHIN THE STATE FOR THE OFFENSES DESCRIBED IN SECTIONS
16 18-3-501, 18-3-502, AND 18-3-503;

(b) THE NUMBER OF CASES PROSECUTED AND CONVICTIONS
DECLARED WITHIN THE STATE FOR ATTEMPTS, SOLICITATIONS, AND
CONSPIRACIES TO COMMIT THE OFFENSES DESCRIBED IN SECTIONS
18-3-501, 18-3-502, AND 18-3-503;

(c) THE CIRCUMSTANCES INVOLVED IN THESE CASES, INCLUDING
 ANY CIRCUMSTANCES THAT SEEM CONSISTENTLY PRESENT IN MULTIPLE
 CASES;

(d) THE SENTENCE IMPOSED FOR EACH CONVICTION, INCLUDING
 CONSIDERATION OF THE APPROPRIATENESS OF EACH SENTENCE; AND
 (e) ANY OTHER INFORMATION THAT THE COMMISSION DEEMS TO BE
 RELEVANT TO ASSIST THE GENERAL ASSEMBLY IN CONSIDERING THE
 RESULTS OF THE IMPLEMENTATION OF THE PROVISIONS OF THIS PART 5
 SINCE THEIR ENACTMENT IN 2006.

7 (3) This section is repealed, effective January 2, 2014.".
