THE FUND CONSISTS OF ALL MONEYS 8 THAT MAY BE APPROPRIATED THERETO BY THE GENERAL ASSEMBLY AND 9 ALL PRIVATE AND PUBLIC FUNDS RECEIVED THROUGH GIFTS, GRANTS, 10 REIMBURSEMENTS, OR DONATIONS THAT ARE TRANSMITTED TO THE STATE 11 TREASURER AND CREDITED TO THE FUND. ALL INTEREST EARNED FROM 12 THE INVESTMENT OF MONEYS IN THE FUND SHALL BE CREDITED TO THE 13 FUND. THE MONEYS IN THE FUND ARE HEREBY CONTINUOUSLY 14 APPROPRIATED FOR THE PURPOSES INDICATED IN THIS SECTION. ANY 15 MONEYS NOT EXPENDED AT THE END OF THE FISCAL YEAR SHALL REMAIN 16 IN THE FUND AND SHALL NOT BE TRANSFERRED TO OR REVERT TO THE 17 GENERAL FUND.

(b) THE EXECUTIVE DIRECTOR SHALL USE THE MONEYS IN THE
RESOURCE MOBILIZATION FUND TO PROVIDE REIMBURSEMENT TO STATE
AGENCIES AND JURISDICTIONS FOR WILDFIRES IN ACCORDANCE WITH THE
TERMS OF THE MOBILIZATION PLAN.".
