Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

- **J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$260,114 General Fund and 2.8 FTE to the Office of Emergency Management in the Department of Public Safety for FY 2013-14. The amendment also provides a \$108,000 reappropriated funds appropriation to the Governor's Office of Information Technology for software upgrades for FY 2013-14.
- L.003 Bill Sponsor amendment L.003 (attached) requires that the Executive Director of the Department of Public Safety notify Legislative Council Staff when adequate funding through gifts, grants, and donations has been received in the Resource Mobilization Fund to provide reimbursements to state agencies and jurisdictions for wildfires in accordance with the terms of the mobilization and shall include in the notice the information specified in Section 24-75-1303 (3), C.R.S. Whether or not L.003 is adopted, J.001 should be adopted.

Points to Consider

General Fund Impact

The Joint Budget Committee introduced a budget package for FY 2013-14 based on the March 2013 Office of State Planning and Budgeting revenue forecast. The budget package appropriates all but approximately \$8.0 million of General Fund revenues projected to be available, less a statutorily required five percent General Fund reserve. This bill requires a General Fund appropriation of \$260,114 for FY 2013-14.

Legislative Authority

Is it necessary to "continuously appropriate" moneys in the Resource Mobilization Fund? This method of funding essentially moves expenditures off budget, and thus expenditures are not reported or accounted for through the budget process.
