The Legislative Council Staff Revised Fiscal Note (03/18/13) states that pursuant to H.B. 12-1283, the Division of Fire Prevention and Control received a three-year federal grant to develop, implement, and administer the prescribed burning program. The Department has stated that the Wildland Fire Management Services line item in the Division of Fire Prevention and Control reflects sufficient federal funds to cover the personal services and program set-up costs described in the fiscal note, however, the legal services line item in the Executive Director's Office does not reflect any federal funds necessary to pay legal services provided by the Department of Law. In addition, the Department of Law requires an appropriation to be able to provide legal services to the Department of Public Safety. Legislative Council Staff agrees with this JBC staff assessment.

Description of Amendments in This Packet

The amendment also appropriates \$4,635 reappropriated funds to the Department of Law for FY 2013-14 for the provision of legal services to the Department of Public Safety.
