4 **1-1-104. Definitions.** As used in this code, unless the context otherwise requires:

6 (19.5) (d) VERIFICATION THAT A VOTER IS COMMITTED TO A 7 JUVENILE FACILITY AND IN THE CUSTODY OF THE DIVISION OF YOUTH 8 CORRECTIONS IN THE DEPARTMENT OF HUMAN SERVICES SHALL BE 9 CONSIDERED SUFFICIENT IDENTIFICATION OF SUCH VOTER FOR THE 10 PURPOSES OF SECTION 1-2-210.5.".

- 12 Page 2, line 6, strike "CONFINED" and substitute "COMMITTED".
- 13 Page 2, line 10, strike "CONFINED" and substitute "COMMITTED".
- 14 Page 3, strike lines 10 through 27 and substitute:
