- 2 Page 6, line 14, strike "BUSINESS DEVELOPMENT CENTER CLIENT".
- 3 Page 6, line 21, strike "AND SMALL".
- 4 Page 6, line 22, strike "BUSINESS DEVELOPMENT CENTER CLIENTS".
- 5 Page 7, line 2, strike "MAY" and substitute "SHALL", and after "INCLUDE"
  6 insert "SECOND-STAGE".
- 7 Page 8, strike lines 1 through 12 and substitute:

8 "(5) (a) THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE
9 THE MONEYS IN THE ECONOMIC GARDENING PILOT PROJECT ACCOUNT OF
10 THE SMALL BUSINESS DEVELOPMENT CENTERS FUND, CREATED IN SECTION
11 24-48.5-102.5, CREATED IN HOUSE BILL 13-1002, ENACTED IN 2013, TO

ECONOMIC AND WORKFORCE DEVELOPMENT COMMITTEES OF THE HOUSE
OF REPRESENTATIVES AND THE FINANCE AND BUSINESS, LABOR, AND
TECHNOLOGY COMMITTEES OF THE SENATE, OR ANY SUCCESSOR

- 7 48.5-102.5 (5) (a), Colorado Revised Statutes, as enacted in section 2
- 8 of this act," and strike "13-\_\_\_\_" and substitute "13-1002".
- 9 Page 9, line 15, strike "13-\_\_\_\_" and substitute "13-1002".
- 10 Page 9, after line 15, insert: "(b) Section 24-48.5-102.5 (5) (b),
- 11 Colorado Revised Statutes, as enacted in section 2 of this act, takes
- 12 effect upon passage only if House Bill 13-1002 does not become law.".
