After consideration on the merits, the Committee recommends the following:

HB13-1292 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 5, strike lines 13 through 20 and substitute
- 2 "~~public works~~. THE GOVERNMENTAL BODY FINANCING A PUBLIC WORKS
- 3 PROJECT SHALL WAIVE THE EIGHTY PERCENT REQUIREMENT IF THERE IS
- 4 REASONABLE EVIDENCE TO DEMONSTRATE INSUFFICIENT COLORADO
- 5 LABOR TO PERFORM THE WORK OF THE PROJECT. A GOVERNMENTAL
- 6 BODY".

- 7 Page 5, line 23, after "SITE." add "A GOVERNMENTAL BODY SHALL NOT
- 8 IMPOSE CONTRACTUAL DAMAGES ON A CONTRACTOR FOR A DELAY IN
- 9 WORK DUE TO THE WAIVER PROCESS."

- 10 Page 6, line 1, strike "at the time of employment," and substitute "~~at the~~
- 11 ~~time of employment~~ AT THE TIME OF THE PUBLIC WORKS PROJECT,".

- 12 Page 6, strike lines 9 through 11.

- 13 Page 6, line 12, strike "(c)" and substitute "(b)".

- 14 Page 7, line 7, after "SECTION." add "THE DEPARTMENT SHALL NOT
- 15 INVESTIGATE OR TAKE ANY OTHER ACTION REGARDING A COMPLAINT
- 16 FILED MORE THAN NINETY DAYS AFTER THE PROJECT HAS BEEN
- 17 FINALIZED."

- 18 Page 8, line 1, after "PROJECT." insert "THE DEPARTMENT SHALL
- 19 COMPLETE ANY INVESTIGATION IN RESPONSE TO A COMPLAINT WITHIN

- 1 NINETY DAYS OF THE DATE THAT THE DEPARTMENT BEGAN THE
2 INVESTIGATION."
- 3 Page 8, line 2, strike "PROJECT BY EACH CONSTRUCTION" and substitute
4 "PROJECT."
- 5 Page 8, strike line 3.
- 6 Page 21, line 24, strike "PUBLIC BUILDINGS OR".
- 7 Page 21, line 25, strike "IN WHOLE OR IN PART BY STATE MONEYS" and
8 substitute "BY A STATE AGENCY AS DEFINED IN SECTION 24-30-1301 (12),
9 C.R.S.,".
- 10 Page 22, line 4, strike "ALL".
- 11 Page 22, strike lines 5 through 7 and substitute "THE PRODUCT WILL BE
12 CONSIDERED MANUFACTURED IN THE UNITED STATES IF ALL OF THE
13 MANUFACTURING PROCESSES FOR THE FINAL PRODUCT TAKE PLACE IN THE
14 UNITED STATES."
- 15 Page 23, strike lines 21 through 27 and substitute:
- 16 "(b) "PUBLIC WORKS" SHALL HAVE THE SAME MEANING AS "PUBLIC
17 PROJECT" AS DEFINED IN SECTION 24-92-102 (8) (a), C.R.S."
- 18 Page 24, strike lines 1 through 6.
