After consideration on the merits, the Committee recommends the following:

HB13-1051 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, strike lines 4 through 14 and substitute:
 - 2 "38-37-101. **Creation of the office of public trustee.** There is
 - 3 hereby created the office of public trustee in each county in this state,
 - 4 whose duties are as prescribed by law. In all counties of the ~~first and~~
 - 5 second ~~classes~~ CLASS, such public trustee shall be appointed as provided
 - 6 in section 38-37-102, and, in counties of all other classes, the county
 - 7 treasurer of the county shall be such public trustee; except that, in the city
 - 8 and county of DENVER AND THE CITY AND COUNTY OF Broomfield, the
 - 9 public trustee shall be such equivalent officer as shall be provided by its
 - 10 charter or code."
- 11 Page 2, strike lines 17 through 23.
- 12 Page 3, strike lines 1 through 7.
- 13 Page 3, line 8, strike "(b)" and substitute:
 - 14 "38-37-102. **Appointment - bond - office.** (1)".
- 15 Page 4, after line 4 insert:
 - 16 "SECTION 3. In Colorado Revised Statutes, 38-37-104, **amend**
 - 17 (2) (a), (2) (b), (2) (b.3) (I), and (2) (b.3) (II) as follows:

1 **38-37-104. Duties of public trustees - fees, expenses, and**
2 **salaries - reports.** (2) (a) The salary of the public trustee in the different
3 counties of the state shall be fixed at the following amounts, to wit: In
4 counties of the ~~first class and~~ second class, twenty-six thousand dollars
5 per annum for full-time public trustees and, in counties of the third class,
6 six thousand five hundred dollars per annum.

7 (b) For public trustees whose terms begin on or after July 1, 1998,
8 but prior to January 1, 2003, the salary of the public trustee in the
9 different counties of the state shall be fixed at the following amounts, to
10 wit: In counties of the ~~first and~~ second class, thirty-two thousand dollars
11 per annum for full-time public trustees and, in counties of the third class,
12 eight thousand dollars per annum; except that, in the city and county of
13 Broomfield, such salary shall be as set forth in its annual budget.

14 (b.3) (I) For public trustees whose terms begin on or after January
15 1, 2003, except as otherwise provided in subparagraph (II), (III), or (IV)
16 of this paragraph (b.3), the salary of the public trustee in the different
17 counties of the state shall be fixed at the following amounts, to wit: In
18 counties of the ~~first and~~ second class, forty-eight thousand five hundred
19 dollars per annum, and in counties of the third class, twelve thousand five
20 hundred dollars per annum.

21 (II) For public trustees who are serving in office on or after March
22 13, 2008, the salary of the public trustee in the different counties of the
23 state shall be fixed at the following amounts, to wit: In ~~counties of the~~
24 ~~first class, forty-eight thousand five hundred dollars per annum, in~~
25 counties of the second class, fifty-six thousand five hundred dollars per
26 annum; and in counties of the third class, twelve thousand five hundred
27 dollars per annum."
