After consideration on the merits, the Committee recommends the following:

SB13-193 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 4, line 7, after "PUBLIC" insert "SCHOOL
- 2 ACCOUNTABILITY COMMITTEE".
- 3 Page 4, strike lines 10 and 11 and substitute "PLAN."
- 4 Page 4, line 12, strike "AND PARTICIPATE IN".
- 5 Page 4, line 14, strike "PLAN;" and substitute "PLAN. A MEMBER OF THE
- 6 SCHOOL ACCOUNTABILITY COMMITTEE IS ENCOURAGED TO ATTEND THE
- 7 PUBLIC HEARING."
- 8 Page 9, line 2, strike "(3)" and substitute "(3),".
- 9 Page 9, line 3, strike "and (4)" and substitute "(4), and (5)".
- 10 Page 9, line 4, strike "**assistance.**" and substitute "**assistance - report.**".
- 11 Page 9, line 5, strike "WORK WITH" and substitute "PROVIDE TRAINING
- 12 AND OTHER RESOURCES DESIGNED TO HELP".
- 13 Page 9, line 7, strike "TO".
- 14 Page 9, line 24, strike "(a)".
- 15 Page 9, line 27, strike "RESEARCH-BASED".

2 "RECOMMENDATIONS FOR METHODS BY WHICH THE DEPARTMENT OF

4 AND MONITOR".
- 5 Page 10, line 3, strike everything after the period.
- 6 Page 10, strike lines 4 through 7.
- 7 Page 10, line 8, strike "(b)" and substitute "(5)".
- 8 Page 10, line 12, strike "ON THE LEVEL OF" and substitute "THE COUNCIL'S
9 PROGRESS IN PROMOTING PARENT ENGAGEMENT IN THE STATE AND IN
10 FULFILLING THE DUTIES SPECIFIED IN THIS SECTION."
- 11 Page 10, strike lines 13 and 14.
- 12 Page 11, strike lines 6 through 12 and substitute:
- 13 "(c) EACH SCHOOL DISTRICT SHALL IDENTIFY AN EMPLOYEE OF THE
14 DISTRICT TO ACT AS THE POINT OF CONTACT FOR PARENT ENGAGEMENT
15 TRAINING AND RESOURCES. THE IDENTIFIED PERSON SHALL ALSO SERVE AS
16 THE LIAISON BETWEEN THE DISTRICT, THE DISTRICT ACCOUNTABILITY
17 COMMITTEE, THE COLORADO STATE ADVISORY COUNCIL FOR PARENT
18 INVOLVEMENT IN EDUCATION, AND THE DEPARTMENT OF EDUCATION AND
19 SHALL FACILITATE THE DISTRICT'S EFFORTS TO INCREASE PARENT
20 INVOLVEMENT WITHIN THE DISTRICT. THE SCHOOL".
- 21 Page 12, line 6, strike everything after the period.
- 22 Page 12, strike lines 7 and 8 and substitute "AT THE SCHOOL
23 ACCOUNTABILITY COMMITTEE'S PUBLIC MEETING, THE".
- 24 Page 12, line 9, strike "DISTRICT" and substitute "SCHOOL PRINCIPAL".
- 25 Page 12, line 17, strike everything after the period and substitute "A
26 MEMBER OF THE".
- 27 Page 12, line 18, strike "SHALL" and substitute "IS ENCOURAGED TO".
- 28 Page 13, strike lines 8 through 12 and substitute:

1 "(c) THE INSTITUTE SHALL IDENTIFY AN EMPLOYEE TO ACT AS THE
2 POINT OF CONTACT FOR PARENT ENGAGEMENT TRAINING AND RESOURCES.
3 THE IDENTIFIED PERSON SHALL ALSO SERVE AS THE LIAISON BETWEEN THE
4 INSTITUTE, THE COLORADO STATE ADVISORY COUNCIL FOR PARENT
5 INVOLVEMENT IN EDUCATION, AND THE DEPARTMENT OF EDUCATION AND
6 SHALL FACILITATE THE INSTITUTE'S EFFORTS TO INCREASE PARENT
7 INVOLVEMENT WITHIN INSTITUTE CHARTER SCHOOLS. THE".

8 Page 14, line 7, strike everything after the period.

9 Page 14, strike lines 8 and 9 and substitute "AT THE SCHOOL
10 ACCOUNTABILITY COMMITTEE'S PUBLIC MEETING, THE".

11 Page 14, line 10, strike "INSTITUTE" and substitute "SCHOOL PRINCIPAL".

12 Page 14, line 22, strike "THE SCHOOL ACCOUNTABILITY COMMITTEE
13 SHALL" and substitute "A MEMBER OF THE SCHOOL ACCOUNTABILITY
14 COMMITTEE IS ENCOURAGED TO".
