THE DEPARTMENT OF LABOR AND EMPLOYMENT.

(11) "METROPOLITAN COMMUNITY" MEANS A MUNICIPALITY THAT,
BASED ON THE MOST RECENT DECENNIAL CENSUS OF THE UNITED STATES,
AS DETERMINED BY THE DEPARTMENT OF LABOR AND EMPLOYMENT, HAS:
