After consideration on the merits, the Committee recommends the following:

<u>HB13-1274</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

- 1 Amend printed bill, page 6, line 13, after "BEMADE" insert "SOLELY FROM
- THE STATE BOARD OF LAND COMMISSIONERS LEASE-PURCHASE FUND WITH
 TRANSFERS".
- 4 Page 6, strike lines 18 through 27.

5 Strike page 7.

6 Page 8, strike lines 1 through 11 and substitute:

7 "(2) (a) NOTWITHSTANDING THE PROVISIONS OF SECTION 8 24-82-801, C.R.S., THE STATE BOARD OF LAND COMMISSIONERS MAY 9 INSTRUCT THE STATE TREASURER TO ENTER INTO LEASE-PURCHASE 10 AGREEMENTS ON BEHALF OF THE STATE SCHOOL LANDS FOR THE 11 ACQUISITION, CONSTRUCTION, RENOVATION, AND IMPROVEMENT OF 12 COMMERCIAL REAL PROPERTY THAT THE BOARD WILL THEN OFFER AS 13 LEASE SPACE FOR STATE AGENCIES OR OTHER TENANTS ONLY IF:

(I) THE STATE BOARD OF LAND COMMISSIONERS HAS REVIEWED
THE LEASED SPACE NEEDS FOR STATE AGENCIES WITH THE DEPARTMENT
OF PERSONNEL;

(II) THE STATE BOARD OF LAND COMMISSIONERS HAS EVALUATED
THE PROJECT WITH THE ASSISTANCE OF THE DEPARTMENT OF PERSONNEL
AND THE OFFICE OF STATE PLANNING AND BUDGETING AGAINST THE
CAPITOL COMPLEX MASTER PLAN IF THE PROJECT IS RELATED TO CAPITOL
COMPLEX LEASED SPACE NEEDS;

(III) THE PROJECTED ANNUAL RENT COSTS OF THE STATE AGENCIES
 THAT WILL BE LOCATED IN THE PROPERTY PLUS ANY CURRENT RENTAL
 PAYMENT OR RENTAL PAYMENT PROJECTED TO BE RECEIVED FROM OTHER
 NONSTATE AGENCY TENANTS FOR EACH FISCAL YEAR DURING THE
 MAXIMUM TERM OF THE PROPOSED LEASE-PURCHASE AGREEMENT WILL
 EXCEED THE ANNUAL LEASE-PURCHASE PAYMENT FOR THE PROPERTY;

7 (IV) A FINANCIAL PLAN FOR THE LEASE-PURCHASE TRANSACTION
8 THAT INCLUDES THE ITEMS DESCRIBED IN PARAGRAPH (b) OF THIS
9 SUBSECTION (2) HAS BEEN APPROVED BY THE OFFICE OF STATE PLANNING
10 AND BUDGETING AND REVIEWED BY THE CAPITAL DEVELOPMENT
11 COMMITTEE OF THE GENERAL ASSEMBLY PURSUANT TO SUBSECTION (3) OF
12 THIS SECTION;

13 (V) THE STATE BOARD OF LAND COMMISSIONERS APPROVES THE
14 TERMS OF THE LEASE-PURCHASE AGREEMENTS AND ANY ANCILLARY
15 AGREEMENTS;

16 (VI) THE STATE BOARD OF LAND COMMISSIONERS ENSURES THAT
17 THE AGREEMENTS FOR THE LEASE-PURCHASE TRANSACTION ACCURATELY
18 REFLECT THE FINANCIAL PLAN APPROVED BY THE OFFICE OF STATE
19 PLANNING AND BUDGETING AND THE CAPITAL DEVELOPMENT COMMITTEE;
20 AND

21 (VII) THE STATE CONTROLLER HAS APPROVED ALL AGREEMENTS
22 PURSUANT TO SECTION 24-30-202, C.R.S.

(b) FOR PURPOSES OF THIS SUBSECTION (2), "ANNUAL RENT COSTS"
MEANS BASE RENT TYPICALLY FOUND IN THE LEASED SPACE LINE ITEM IN
THE GENERAL APPROPRIATION BILL PLUS ALL OPERATION, MAINTENANCE,
AND RELATED COSTS PAID TO A LESSOR OR OTHER THIRD PARTY.

27 (c) THE FINANCIAL PLAN MUST INCLUDE ALL NECESSARY 28 PARAMETERS OF THE LEASE-PURCHASE AGREEMENT, INCLUDING BUT NOT 29 LIMITED TO LEASED-SPACE NEEDS, SUBLEASING AGREEMENTS, INCOME, 30 EXPENSES, CAPITAL MAINTENANCE COSTS, INTEREST RATES, RESERVE 31 REQUIREMENTS, AMORTIZATION, EXPECTED RETURN ON INVESTMENT, AND 32 OVERALL BENEFIT TO THE PERMANENT SCHOOL FUND AS RELATED TO THE 33 STATE BOARD'S DUTIES ENUMERATED IN SECTION 10 OF ARTICLE IX OF THE 34 STATE CONSTITUTION. THE FINANCIAL PLAN MUST ALSO INCLUDE ANY 35 OTHER FINANCIAL CONSIDERATION THAT THE OFFICE OF STATE PLANNING 36 AND BUDGETING OR THE CAPITAL DEVELOPMENT COMMITTEE MIGHT 37 REQUEST AFTER THEIR REVIEW OF THE FINANCIAL PLAN. THE STATE BOARD 38 MAY UTILIZE THE SERVICES OF THE STATE'S FINANCIAL ADVISORS IN ORDER 39 TO PREPARE THE FINANCIAL PLAN.

40 (d) THE STATE BOARD SHALL ADOPT A POLICY THAT AT MINIMUM
41 SPECIFIES THAT LEASED SPACE IS AVAILABLE TO A STATE AGENCY
42 THROUGH THE APPLICATION OF THIS SECTION WHEN SUCH A LEASED SPACE

ARRANGEMENT IS MUTUALLY BENEFICIAL TO THE STATE BOARD AND THE
 STATE AGENCY SEEKING TO LEASE SPACE.

3 (e) THE STATE TREASURER SHALL ISSUE THE LEASE-PURCHASE
4 AGREEMENTS AS SPECIFIED IN SECTION 24-36-121, C.R.S.

5 (3) IF THE OFFICE OF STATE PLANNING AND BUDGETING APPROVES 6 THE FINANCIAL PLAN, IT SHALL SUBMIT THE FINANCIAL PLAN TO THE 7 CAPITAL DEVELOPMENT COMMITTEE OF THE GENERAL ASSEMBLY. THE 8 CAPITAL DEVELOPMENT COMMITTEE SHALL REVIEW THE FINANCIAL PLAN 9 AND REFER ITS RECOMMENDATIONS REGARDING THE FINANCIAL PLAN, 10 WITH WRITTEN COMMENTS, TO THE STATE BOARD OF LAND 11 COMMISSIONERS.".


15 (c) ANNUAL PAYMENTS ON LEASE-PURCHASE AGREEMENTS THAT 16 THE STATE BOARD OF LAND COMMISSIONERS INSTRUCTED THE STATE 17 TREASURER TO ENTER INTO PURSUANT TO THIS SECTION MUST BE MADE 18 SOLELY FROM THE STATE BOARD OF LAND COMMISSIONERS 19 LEASE-PURCHASE FUND WITH TRANSFERS FIRST FROM THE COMMERCIAL 20 REAL PROPERTY OPERATING FUND CREATED IN SECTION 36-1-153.7, 21 SECOND FROM THE RESERVE DESCRIBED IN PARAGRAPH (d) OF SUBSECTION 22 (8) OF THIS SECTION, AND, IN THE EVENT OF ANY SHORTFALL, FROM THE 23 STATE BOARD OF LAND COMMISSIONERS INVESTMENT AND DEVELOPMENT FUND CREATED IN SECTION 36-1-153.". 24
