Bill Summary

Sunset Process - Senate Agriculture, Natural Resources, and Energy Committee. In 2010, the general assembly created the Colorado food systems advisory council (council) to foster a healthy food supply available to all Colorado residents while enhancing the state's agricultural and natural resources, encouraging economic growth, expanding the

viability of agriculture, and improving the health of Colorado's communities and residents by making recommendations to the general assembly. The council is scheduled to repeal July 1, 2013. The bill continues the council indefinitely. The bill also adds 2 more members to the committee and ensures diversity among the existing members.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)
3 (z) (VI); and **add** (3) (ee.5) as follows:

4 **2-3-1203. Sunset review of advisory committees.** (3) The

12 **IN SECTION 24-37.3-102, C.R.S.**

13 **SECTION 2.** In Colorado Revised Statutes, 24-37.3-102, **amend**
14 (2) introductory portion, (2) (b) introductory portion, (2) (b) (II), and (2)
15 (b) (III); and **add** (2) (b) (VI) and (2) (b) (VII) as follows:

16 **24-37.3-102. Colorado food systems advisory council - created**
17 **- membership - terms - vacancies.** (2) The council consists of ~~thirteen~~

6 FOOD WHOLESALERS OR FOOD RETAILERS;

7 (VI) ONE MEMBER FROM AN ACADEMIC INSTITUTION WHO
8 SPECIALIZES IN ECONOMIC SYSTEMS, AGRICULTURE, OR HEALTH CARE;

9 (VII) THE DIRECTOR OF THE COLORADO STATE UNIVERSITY
10 EXTENSION SERVICES PROGRAM OR HIS OR HER DESIGNEE.

11 **SECTION 3. In Colorado Revised Statutes, 24-37.3-105, amend**
12 **(1) as follows:**

13 **24-37.3-105. Fund - acceptance of gifts, grants, or donations.**

14 **(1) For the purposes of carrying out the duties of the council, the council**
15 **is authorized to seek and accept gifts, grants, or donations, including**
16 **in-kind donations, from private or public sources for the purposes of this**
17 **article; except that the council may not accept a gift, grant, or donation**
18 **that is subject to conditions that are inconsistent with this article or any**
19 **other law of the state. The council may accept in-kind donations of staff**
20 **services from the private sector to staff the council. The council is also**
21 **authorized to accept and expend federal funds available for food policy**
22 **councils. All private and public moneys received through gifts, grants, or**
23 **donations shall be transmitted to the state treasurer, who shall credit the**
24 **same to the food systems advisory council fund, which fund is hereby**
25 **created and referred to in this section as the "fund". The moneys in the**
26 **fund shall be subject to annual appropriation** MUST BE CONTINUOUSLY
27 **APPROPRIATED by the general assembly to the department of agriculture**

1 for allocation to the council for the direct and indirect costs associated
2 with implementing this article. Any moneys in the fund not expended for
3 the purpose of this article may be invested by the state treasurer as
4 provided by law. All interest and income derived from the investment and
5 deposit of moneys in the fund shall be credited to the fund. Any
6 unexpended and unencumbered moneys remaining in the fund at the end
7 of a fiscal year shall remain in the fund and shall not revert or be credited
8 or transferred to the general fund or another fund; except that, if, at the
9 time this article is repealed pursuant to section 24-37.3-107, the fund
10 contains a balance of unencumbered and unexpended moneys, those
11 moneys shall revert to the general fund.

12 **SECTION 4.** In Colorado Revised Statutes, **amend** 24-37.3-107
13 as follows:

14 **24-37.3-107. Repeal of article.** This article is repealed, effective
15 ~~July 1, 2013~~ SEPTEMBER 1, 2018. Prior to such repeal, the food systems
16 advisory council shall be reviewed as provided for in section 2-3-1203,
17 C.R.S.

18 **SECTION 5. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
