A BILL FOR AN ACT CONCERNING PROCEDURES GOVERNING THE TRANSMISSION OF PUBLIC RECORDS THAT ARE COPIED IN RESPONSE TO A REQUEST FOR INSPECTION OF SUCH RECORDS UNDER THE "COLORADO OPEN RECORDS ACT".

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Upon request by a person seeking a copy of any public record for which a right to inspection exists under the "Colorado Open Records Act"

(CORA), the records custodian must transmit a copy of the record by United States mail or by any other practicable means of delivery.

No fees related to transmission may be charged to the record requester for transmitting public records via electronic mail.

The custodian shall notify the record requester that a copy of the record is available but will only be sent to the requester once the custodian receives payment for postage if the copy is transmitted by United States mail, or payment for the cost of delivery if the copy is transmitted other than by United States mail, and payment for any other supplies used in the mailing, delivery, or transmission of the record and for all other costs associated with producing the record. Upon receiving such payment, the custodian shall send the record to the requester as soon as practicable but no more than 3 business days after receipt of such payment.

Be it enacted by the General Assembly of the State of Colorado:

24-72-205. Copy, printout, or photograph of a public record.

5 (1) (a) In all cases in which a person has the right to inspect a public

6 record, the person may request a copy, printout, or photograph of the

7 record. The custodian shall furnish a copy, printout, or photograph and

8 may charge a fee determined in accordance with subsection (5) of this

9 section; except that, when the custodian is the secretary of state, fees shall

be determined and collected pursuant to section 24-21-104 (3), and when

the custodian is the executive director of the department of personnel,

fees shall be determined and collected pursuant to section 24-80-102 (10).

Where the fee for a certified copy or other copy, printout, or photograph

of a record is specifically prescribed by law, the specific fee shall apply.

13	LAWFULLY ALLOWED, UNLESS IMPOSITION OF A FEE HAS BEEN WAIVED BY
14	THE CUSTODIAN. UPON RECEIVING SUCH PAYMENT, THE CUSTODIAN SHALL
15	SEND THE RECORD TO THE REQUESTER AS SOON AS PRACTICABLE BUT NO
16	MORE THAN THREE BUSINESS DAYS AFTER RECEIPT OF SUCH PAYMENT.
17	SECTION 2. Applicability. This act applies to any record
18	request made on or after the effective date of this act.
19	SECTION 3. Safety clause. The general assembly hereby finds,
20	determines, and declares that this act is necessary for the immediate
21	preservation of the public peace, health, and safety.
