# A BILL FOR AN ACT

101 CONCERNING DESIGNATING FORT CARSON POLICE OFFICERS AS PEACE

102 OFFICERS.

### **Bill Summary**

The bill designates Fort Carson police officers as peace officers in Colorado. A Fort Carson police officer may be P.O.S.T.-certified.

1 Be it enacted by the General Assembly of the State of Colorado:





SECTION 1. In Colorado Revised Statutes, add 16-2.5-150 as
follows:

16-2.5-150. Fort Carson police officers. \_\_\_\_ A FORT CARSON 3 4 POLICE OFFICER IS A PEACE OFFICER WHILE ENGAGED IN THE 5 PERFORMANCE OF HIS OR HER DUTIES. FORT CARSON POLICE OFFICERS ARE 6 EMPLOYED BY THE FORT CARSON POLICE, A FEDERAL CIVILIAN LAW ENFORCEMENT AGENCY WITHIN THE STATE OF COLORADO. A FORT 7 8 CARSON POLICE OFFICER'S AUTHORITY INCLUDES ENFORCING ALL THE 9 LAWS OF THE CONSTITUTION OF THE UNITED STATES, THE UNITED STATES 10 CODE, THE "UNIFORM CODE OF MILITARY JUSTICE", 10 U.S.C. CHAPTER 11 47, AND THE LAWS OF THE STATE OF COLORADO WITHIN THE JURISDICTION 12 AND PROPERTIES OF FORT CARSON AND THE PINON CANYON MANEUVER 13 SITE, INCLUDING ALL FIXED AND MOBILE PROPERTIES OF FORT CARSON AND THE PINON CANYON MANEUVER SITE. \_\_\_\_\_ A FORT CARSON POLICE 14 15 OFFICER MAY BE P.O.S.T.-CERTIFIED.

17 **SECTION 2.** Act subject to petition - effective date. This act 18 takes effect at 12:01 a.m. on the day following the expiration of the 19 ninety-day period after final adjournment of the general assembly (August 20 7, 2013, if adjournment sine die is on May 8, 2013); except that, if a 21 referendum petition is filed pursuant to section 1 (3) of article V of the 22 state constitution against this act or an item, section, or part of this act 23 within such period, then the act, item, section, or part will not take effect 24 unless approved by the people at the general election to be held in 25 November 2014 and, in such case, will take effect on the date of the 26 official declaration of the vote thereon by the governor.
