Bill Summary

Sunset Process - Health and Human Services Committee. The bill extends the Colorado youth advisory council indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

1 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)
2 (z) (V) as follows:

3 **2-3-1203. Sunset review of advisory committees.** (3) The
4 following dates are the dates for which the statutory authorization for the
5 designated advisory committees is scheduled for repeal:

9 **SECTION 2.** In Colorado Revised Statutes, **repeal** 2-2-1307.

10 **SECTION 3.** In Colorado Revised Statutes, 2-2-1304, **amend** (4)
11 (a) as follows:

12 **2-2-1304. Duties - meetings - community outreach -**
13 **designation of organization to accept donations - authority to**
14 **contract.** (4) (a) On or before September 1, 2009, and every other
15 September 1 thereafter, the four legislative members appointed pursuant
16 to section 2-2-1303 shall designate, by majority vote, a nonprofit or
17 private organization as the custodian of moneys donated to the council
18 through the designated organization. The designated organization shall
19 not be the custodian of any moneys appropriated by the state and credited
20 to the fund created in section 2-2-1306. The designated organization is
21 authorized to expend any moneys it receives as is necessary for the
22 operation of the council and may solicit and accept monetary and in-kind
23 gifts, grants, and donations used to further the council's duties and
24 responsibilities. Any such moneys donated or awarded to the designated
25 organization for the benefit of the council are not subject to appropriation
26 by the general assembly. Any such moneys obtained by the council or the
27 designated organization and not in the fund that are unexpended and

1 unencumbered at the time the council is dissolved ~~or this part 13 is~~
2 ~~repealed pursuant to section 2-2-1307~~ shall be distributed according to
3 appropriate federal and state laws governing nonprofit organizations. If
4 a different nonprofit or private organization is subsequently designated
5 as the custodian of donated moneys in accordance with this paragraph (a),
6 any moneys that are unexpended and unencumbered at the time of the
7 change in designation shall be promptly transferred by the previously
8 designated organization to the newly designated organization.

9 **SECTION 4. Safety clause.** The general assembly hereby finds,
10 determines, and declares that this act is necessary for the immediate
11 preservation of the public peace, health, and safety.
