101 **CONCERNING THE MEMBERSHIP OF CERTAIN ALLOCATION**  
102 **COMMITTEES IN THE DEPARTMENT OF HUMAN SERVICES.**

**Bill Summary**

The bill increases the membership of the child welfare allocation committee and the works allocation committee to 11 members each and allocates the appointment of members between a statewide association of counties and the state department of human services.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 26-5-103.5, **amend**  
3 (2) as follows:

4 **26-5-103.5. Child welfare allocations committee - organization**  
5 **- advisory duties.** (2) The child welfare allocations committee shall  
6 consist of ~~eight~~ ELEVEN members, ~~four~~ EIGHT of whom shall be appointed  
7 by a statewide association of counties and ~~four~~ THREE of whom shall be  
8 appointed by the state department. ~~OF THE MEMBERS APPOINTED BY THE~~  
9 ~~STATEWIDE ASSOCIATION OF COUNTIES, AT LEAST TWO MEMBERS SHALL~~  
10 ~~BE FROM SMALL OR MEDIUM-SIZED COUNTIES, AND AT LEAST THREE SHALL~~  
11 ~~BE FROM LARGE COUNTIES. The appointing authorities shall consult with~~  
12 ~~each other to ensure that the child welfare allocations committee is~~  
13 ~~representative of the counties in the state. If a statewide association of~~  
14 ~~counties does not appoint a representative~~ A REPRESENTATIVE from the  
15 ~~county that has the greatest percentage of the state's child welfare~~  
16 ~~caseload the state department shall appoint such a representative from~~  
17 ~~such county~~ WILL AUTOMATICALLY BE APPOINTED, WHICH APPOINTMENT  
18 SHALL BE CREDITED AGAINST THE EIGHT APPOINTMENTS ALLOCATED TO  
19 THE STATEWIDE ASSOCIATION OF COUNTIES.

20 **SECTION 2.** In Colorado Revised Statutes, 26-2-714, **amend** (6)  
21 (c) (IV) as follows:

22 **26-2-714. County block grants formula - use of moneys - rules.**  
23 (6) (c) **Actual spending levels - 1998-99 and thereafter.** (IV) There is  
24 hereby created the works allocation committee that shall consist of ~~seven~~  
25 ELEVEN members, ~~five~~ EIGHT of whom shall be appointed by a statewide  
26 association of counties and ~~two~~ THREE of whom shall be appointed by the

1 state department. OF THE MEMBERS APPOINTED BY THE STATEWIDE  
2 ASSOCIATION OF COUNTIES, AT LEAST TWO MEMBERS SHALL BE FROM  
3 SMALL OR MEDIUM-SIZED COUNTIES, AND AT LEAST THREE SHALL BE FROM  
4 LARGE COUNTIES. The appointing authorities shall consult with each other  
5 to ensure that the works allocation committee is representative of the  
6 counties in the state. If a statewide association of counties does not  
7 appoint A representative from the county that has the greatest percentage  
8 of the state's works caseload the state department shall appoint such a  
9 representative from such county WILL AUTOMATICALLY BE APPOINTED,  
10 WHICH APPOINTMENT SHALL BE CREDITED AGAINST THE EIGHT  
11 APPOINTMENTS ALLOCATED TO THE STATEWIDE ASSOCIATION OF  
12 COUNTIES. The works allocation committee shall develop its own  
13 operational procedures.

14 **SECTION 3. Safety clause.** The general assembly hereby finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, and safety.
