A BILL FOR AN ACT

101 **CONCERNING THE ELIMINATION OF THE REQUIREMENT THAT A**
102 **POLITICAL SUBDIVISION PROVIDE CERTAIN REPORTS ON AN**
103 **ANNUAL BASIS.**

Bill Summary

Currently, every political subdivision in the state is required to file an annual report with the division of local government (division) in the department of local affairs that lists the current contracts in effect with other political subdivisions. The bill eliminates the requirement to file the

lists annually and instead requires a political subdivision to provide such list within 30 days of receiving a written request to do so from the division.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 29-1-205 as
3 follows:

4 **29-1-205. List of contracts - contracts establishing power**
5 **authorities.** (1) ~~On or before February 1 of each year, each~~ WITHIN
6 THIRTY DAYS AFTER RECEIVING A WRITTEN REQUEST FROM THE DIVISION
7 OF LOCAL GOVERNMENT, A political subdivision shall ~~file with~~ PROVIDE
8 the division of local government ~~an updated informational~~ WITH A
9 CURRENT list of all contracts in effect with other political subdivisions.
10 ~~Said~~ THE list shall MUST contain the names of the contracting political
11 subdivisions, the nature of the contract, and the **expiration date thereof.**

12 (2) **Within ten days after the execution of a contract** establishing
13 a separate governmental entity pursuant to section 29-1-204, or an
14 amendment or a modification thereof, THE CONTRACTING LOCAL
15 GOVERNMENTS SHALL FILE a copy of such contract, amendment, or
16 **modification shall be filed with the division. of local government.**

17 (3) **Failure** to make any filing under this section shall DOES not
18 invalidate any contract referred to in this section.

19 **SECTION 2. Act subject to petition - effective date.** This act
20 takes effect at 12:01 a.m. on the day following the expiration of the
21 ninety-day period after final adjournment of the general assembly (August
22 7, 2013, if adjournment sine die is on May 8, 2013); except that, if a
23 referendum petition is filed pursuant to section 1 (3) of article V of the
24 state constitution against this act or an item, section, or part of this act

1 within such period, then the act, item, section, or part will not take effect
2 unless approved by the people at the general election to be held in
3 November 2014 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
