A BILL FOR AN ACT

101 **CONCERNING THE ADDITION OF TWO MEMBERS TO THE COLORADO**
102 **STATE BOARD OF CHIROPRACTIC EXAMINERS, AND, IN**
103 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

Currently, the Colorado state board of chiropractic examiners (board) has 5 members, 4 of whom must have practiced chiropractic in Colorado for the 5 years preceding their appointment to the board and one of whom is appointed from the public at large. The bill increases the

number of members on the board to 7 by adding one more chiropractor and one more member of the public at large.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-33-103, **amend**
3 (1) as follows:

4 **12-33-103. State board of chiropractic examiners - subject to**
5 **termination - repeal of article.** (1) There is hereby created a Colorado
6 state board of chiropractic examiners, referred to in this article as the
7 "board", consisting of ~~five~~ SEVEN members who are citizens of the United
8 States, ~~four~~ FIVE of whom ~~shall~~ MUST have practiced chiropractic in the
9 state of Colorado for five years ~~prior to~~ BEFORE their appointment and ~~one~~
10 TWO of whom shall be appointed from the public at large. The governor
11 shall appoint members of the board for a term of four years. Any board
12 member may be removed by the governor for misconduct, incompetence,
13 or neglect of duty. No member shall serve more than two consecutive
14 terms.

15 **SECTION 2. Appropriation.** In addition to any other
16 appropriation, there is hereby appropriated, out of any moneys in the
17 division of professions and occupations cash fund created in section
18 24-34-105 (2) (b) (I), Colorado Revised Statutes, not otherwise
19 appropriated, to the department of regulatory agencies, for the fiscal year
20 beginning July 1, 2013, the sum of \$2,100, or so much thereof as may be
21 necessary, for allocation to the division of professions and occupations
22 for board member expenses related to the implementation of this act.

23 **SECTION 3. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
