**A BILL FOR AN ACT**

101     **CONCERNING AUTHORIZING RED ROCKS COMMUNITY COLLEGE TO**  
102             **OFFER A PHYSICIAN ASSISTANT STUDIES PROGRAM AS A**  
103             **PROGRAM OF GRADUATE EDUCATION.**

**Bill Summary**

Currently, Red Rocks community college offers a certificate program in physician assistant studies, and, through an affiliation with St. Francis university in Pennsylvania, students may obtain a master of medical science degree. The eligibility requirements of the accrediting

body of physician assistant programs now requires the sponsor of the program to confer a graduate degree upon completion of the program.

The bill authorizes Red Rocks community college to continue providing its physician assistant studies program by authorizing Red Rocks community college to confer a graduate degree on students who complete the physician assistant studies program.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby finds and declares that:

4 (a) The health care industry is relying, in part, on the physician  
5 assistant profession to meet certain provider needs in the present and in  
6 the future that will otherwise be unmet without these providers;

7 (b) The accreditation standards for physician assistant programs  
8 require that all currently accredited programs confer graduate degrees  
9 upon those students who initially enroll in the physician assistant program  
10 after 2020;

11 (c) Further, in order to meet the eligibility requirements of the  
12 accreditation review commission on education for the physician assistant,  
13 a single institution must be clearly identified as the sponsor of the  
14 program, must be authorized under applicable law to provide a program  
15 of graduate education, must be accredited by a recognized regional  
16 accrediting agency, and must be authorized by the accrediting agency to  
17 confer a graduate degree upon those students who complete the physician  
18 assistant program;

19 (d) Physician assistant programs that are not in compliance with  
20 these degree requirements by January 1, 2021, will have their  
21 accreditation withdrawn;

22 (e) Red Rocks community college's physician assistant program

1 (RRCCPAP) is accredited through the accreditation review commission  
2 on education for the physician assistant. Red Rocks community college  
3 offers a certificate program in physician assistant studies and prepares the  
4 student for the national exam through a twenty-five-month-long program  
5 designed to train individuals to provide primary care to the medically  
6 underserved. Admission requirements include a bachelor's degree and  
7 2,000 hours of paid medical experience. The RRCCPAP currently offers  
8 an on-line master of medical science degree through an affiliation with St.  
9 Francis university in Pennsylvania.

10 (f) In order to continue to meet the eligibility requirements and  
11 ensure that Red Rocks community college can continue to prepare  
12 students to serve as physician assistants, Red Rocks community college  
13 must be authorized to confer a masters of physician assistant studies  
14 degree on students completing the RRCCPAP on its own, and not through  
15 an affiliation with St. Francis university in Pennsylvania.

16 (2) Therefore, the general assembly declares that it is in the best  
17 interests of the state of Colorado to authorize Red Rocks community  
18 college to seek accreditation for and offer its physician assistant program  
19 as a program of graduate education.

20 **SECTION 2.** In Colorado Revised Statutes, 23-60-211, **add** (3)  
21 as follows:

22 **23-60-211. Degrees.** (3) PURSUANT TO SECTION 23-60-213, RED  
23 ROCKS COMMUNITY COLLEGE MAY OFFER A GRADUATE PROGRAM IN  
24 PHYSICIAN ASSISTANT STUDIES.

25 **SECTION 3.** In Colorado Revised Statutes, **add** 23-60-213 as  
26 follows:

27 **23-60-213. Red Rocks community college - physician assistant**

1 **master's program.** NOTWITHSTANDING ANY OTHER PROVISION OF LAW  
2 TO THE CONTRARY, RED ROCKS COMMUNITY COLLEGE IS AUTHORIZED TO  
3 CONFER A GRADUATE DEGREE UPON A STUDENT WHO COMPLETES THE  
4 PHYSICIAN ASSISTANT STUDIES PROGRAM AND SHALL SEEK  
5 ACCREDITATION FOR THE PROGRAM.

6 **SECTION 4. Act subject to petition - effective date.** This act  
7 takes effect at 12:01 a.m. on the day following the expiration of the  
8 ninety-day period after final adjournment of the general assembly (August  
9 7, 2013, if adjournment sine die is on May 8, 2013); except that, if a  
10 referendum petition is filed pursuant to section 1 (3) of article V of the  
11 state constitution against this act or an item, section, or part of this act  
12 within such period, then the act, item, section, or part will not take effect  
13 unless approved by the people at the general election to be held in  
14 November 2014 and, in such case, will take effect on the date of the  
15 official declaration of the vote thereon by the governor.
