Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

Under current law, restorative justice victim-offender conferences must be initiated by the victim. The bill modifies the requirement of victim initiation in some instances to permit district attorney or offender initiation. There is a restorative justice coordinating council established in the state court administrator's office; the bill adds:

The restorative justice coordinating council shall develop a uniform restorative justice satisfaction evaluation. The council shall collect information regarding all existing restorative justice programs and practices and report that data to the house and senate judiciary committees by January 31, 2014.

The bill creates a pilot project for restorative justice programs in 4 judicial districts. At each site, if a juvenile who is under 18 years of age and could be charged in the petition with a misdemeanor and has not been previously charged or who has not participated in the pilot project, the district attorney shall assess the juvenile's suitability for restorative justice. The district attorney may also refer any juvenile who is charged with a class 3, 4, 5, or 6 felony and has not been previously charged or who has not participated in the pilot project. If the district attorney determines that the juvenile is a suitable candidate for the restorative justice program, the district attorney may offer the juvenile an opportunity to participate in the restorative justice program. If the juvenile agrees to participate, the district attorney shall not file charges pending completion of the program. If the juvenile fails to complete the program, the district attorney may file a petition against the juvenile. The pilot project sites must annually report to the division of criminal justice in the department of public safety certain information on the pilot projects. The division of criminal justice shall prepare an annual report based on the information received.

The bill creates a \$10 surcharge on all crimes to support a restorative justice fund. The fund will be used to defray the costs of restorative justice programs and administrative costs of the restorative justice coordinating council.

18-1-901. Definitions. (3) (0.5) "Restorative justice practices" means practices that emphasize repairing the harm caused to victims and the community by offenses. Restorative justice practices include

7 victim-initiated victim-offender conferences, family group conferences,

1 circles, community conferences, and other similar victim-centered 2 practices. Restorative justice practices are facilitated meetings attended 3 voluntarily by the victim or victim's representatives, the victim's 4 supporters, the offender, and the offender's supporters and may include 5 community members. By engaging the parties to the offense in voluntary 6 dialogue, restorative justice practices provide an opportunity for the 7 offender to accept responsibility for the harm caused to the victim and 8 community, promote victim healing, and enable the participants to agree 9 on consequences to repair the harm, to the extent possible, including but 10 not limited to apologies, community service, reparation, restoration, and 11 counseling. Restorative justice practices may be used in addition to any 12 other conditions, consequences, or sentence imposed by the court.

13 SECTION 2. In Colorado Revised Statutes, 18-1.3-204, amend

IF A DEFENDANT WANTS TO PARTICIPATE IN RESTORATIVE 25 JUSTICE PRACTICES, THE DEFENDANT MUST MAKE THE REQUEST TO THE 26 DISTRICT ATTORNEY OR THE LAW ENFORCEMENT AGENCY ADMINISTERING 27 THE PROGRAM AND MAY NOT MAKE THE REQUEST TO THE VICTIM. IF

1 REQUESTED BY THE DEFENDANT, DISTRICT ATTORNEY, OR LAW 2 ENFORCEMENT AGENCY, A VICTIM-OFFENDER CONFERENCE MAY ONLY BE 3 CONDUCTED AFTER THE VICTIM IS CONSULTED BY THE DISTRICT ATTORNEY 4 AND OFFERED THE OPPORTUNITY TO PARTICIPATE OR SUBMIT A VICTIM 5 IMPACT STATEMENT. IF A VICTIM ELECTS NOT TO ATTEND, A VICTIM 6 OFFENDER CONFERENCE MAY BE HELD WITH A SUITABLE VICTIM 7 SURROGATE OR VICTIM ADVOCATE, AND THE VICTIM MAY SUBMIT A 8 VICTIM-IMPACT STATEMENT. To be eligible for restorative justice 9 practices, the defendant shall not have been convicted of unlawful sexual 10 behavior as defined in section 16-22-102 (9), C.R.S., a crime in which the 11 underlying factual basis involves domestic violence, as defined in section 12 18-6-800.3 (1), stalking as defined in section 18-3-602, or violation of a 13 protection order as defined in section 18-6-803.5. Any statements made 14 during a restorative justice conference shall be confidential and shall not 15 be used as a basis for charging or prosecuting the defendant unless the 16 defendant commits a chargeable offense during the conference. Failure 17 to complete the requirements arising from a restorative justice conference 18 may be considered a violation of probation. Nothing in this subparagraph 19 (III.5) shall be construed to require a victim to participate in RESTORATIVE 20 JUSTICE PRACTICES OR a restorative justice victim-offender conference. 21

(44) "Diversion" means a decision made by a person with

1 and in lieu thereof providing individually designed services by a specific 2 program. The goal of diversion is to prevent further involvement of the 3 juvenile or child in the formal legal system. Diversion of a juvenile or 4 child may take place either at the prefiling level as an alternative to the 5 filing of a petition pursuant to section 19-2-512 or at the postadjudication 6 level as an adjunct to probation services following an adjudicatory 7 hearing pursuant to section 19-3-505 or a disposition as a part of 8 sentencing pursuant to section 19-2-907. "Services", as used in this 9 subsection (44), includes but is not limited to diagnostic needs 10 assessment, restitution programs, community service, job training and 11 placement, specialized tutoring, constructive recreational activities, 12 general counseling and counseling during a crisis situation, and follow-up 13 activities. Services may include restorative justice practices as defined in 14 section 18-1-901 (3) (0.5), C.R.S., as requested by the victim, after being 15 informed about restorative justice practices pursuant to section 16 24-4.1-303 (11) (g), C.R.S., and as deemed suitable by the probation 17 department or a designated restorative justice practices facilitator. 18 Such practices may include victim-offender conferences, if requested by 19 the victim. Restorative justice practices shall be conducted by facilitators 20 recommended by the district attorney.

SECTION 4. In Colorado Revised Statutes, 19-2-213, amend (1)

19-2-213. Restorative justice coordinating council establishment - membership - repeal. (1) (a) A council to provide
assistance and education related to restorative justice programs is hereby
established. The council shall be known as the "restorative justice
coordinating council" and shall be established in the state judicial

8 SECTION 6. In Colorado Revised Statutes, 19-2-512, amend (2)
9 as follows:

10 **19-2-512.** Petition initiation. (2) If the petition is the first 11 juvenile petition filed against the juvenile in any jurisdiction and is 12 initiated in a jurisdiction that has restorative justice practices available, 13 the district attorney or his or her designee may determine whether a 14 juvenile is suitable for restorative justice practices. In making a 15 determination of whether the juvenile is suitable for restorative justice 16 practices, the district attorney shall first determine whether the victim, 17 having been informed about restorative justice practices pursuant to 18 section 24-4.1-303 (11) (g), C.R.S., is requesting consideration of 19 restorative justice practices as an alternative to formal prosecution. Upon 20 such request, The district attorney shall consider WHETHER THE VICTIM, 21 HAVING BEEN INFORMED ABOUT RESTORATIVE JUSTICE PRACTICES 22 PURSUANT TO SECTION 24-4.1-303 (11) (g), C.R.S., IS REQUESTING 23 CONSIDERATION OF RESTORATIVE JUSTICE PRACTICES AS AN ALTERNATIVE 24 TO FORMAL PROSECUTION; THE SERIOUSNESS OF THE CRIME; THE CRIME'S 25 IMPACT ON THE VICTIM; THE BEST METHODOLOGY TO INVOLVE THE 26 VICTIM; whether the juvenile accepts responsibility for, expresses remorse 27 for, and is willing to repair the harm caused by his or her actions; and

1 whether the juvenile's parent or legal guardian is willing to support the 2 juvenile in the process; AND OTHER PROGRAMMATIC SUPPORT AVAILABLE. 3 If requested by the victim, restorative justice practices may be utilized as 4 part of this process. IF A JUVENILE WANTS TO PARTICIPATE IN 5 RESTORATIVE JUSTICE PRACTICES, THE JUVENILE MUST MAKE THE REQUEST 6 TO THE DISTRICT ATTORNEY OR THE LAW ENFORCEMENT AGENCY 7 ADMINISTERING THE PROGRAM AND MAY NOT MAKE THE REQUEST TO THE 8 VICTIM. IF REQUESTED BY THE JUVENILE, RESTORATIVE JUSTICE PRACTICES 9 MAY ONLY BE CONDUCTED AFTER THE VICTIM IS CONSULTED BY THE 10 DISTRICT ATTORNEY AND OFFERED AN OPPORTUNITY TO PARTICIPATE OR 11 SUBMIT A VICTIM IMPACT STATEMENT. IF A VICTIM ELECTS NOT TO 12 ATTEND, A VICTIM-OFFENDER CONFERENCE MAY BE HELD WITH A 13 SUITABLE VICTIM SURROGATE OR VICTIM ADVOCATE, AND THE VICTIM 14 MAY SUBMIT A VICTIM-IMPACT STATEMENT. The district attorney may 15 offer dismissal of charges as an option for the successful completion of 16 these and any other conditions imposed and designed to address the harm 17 done to the victim and the community by the offender, subject to approval 18 by the court.

SECTION 7. In Colorado Revised Statutes, 19-2-706, amend (1)
as follows:

19-2-706. Advisement. (1) At the first appearance before the court after the filing of a petition, the juvenile and his or her parents, guardian, or other legal custodian shall be advised by the court of their constitutional and legal rights as set forth in rule 3 of the Colorado rules of juvenile procedure. Such advisement shall include the possibility of restorative justice practices, including victim-offender conferences if applicable IF RESTORATIVE JUSTICE PRACTICES ARE AVAILABLE IN THE

JURISDICTION. The advisement regarding restorative justice practices does
 not establish any right to restorative justice practices on behalf of the
 juvenile. and failure to provide an advisement regarding restorative
 justice practices does not constitute any legal error by the court.

SECTION 8. In Colorado Revised Statutes, 19-2-708, **amend** (2) as follows:

7 **19-2-708.** Entry of plea. (2) Upon the entry of a plea of guilty to 8 one or more of the allegations contained in the petition, the court shall 9 advise the juvenile in accordance with rule 3 of the Colorado rules of 10 juvenile procedure. Such advisement shall include the possibility of 11 restorative justice practices, including victim-offender conferences if 12 applicable RESTORATIVE JUSTICE PRACTICES ARE AVAILABLE IN THE 13 JURISDICTION. The advisement regarding restorative justice practices does 14 not establish any right to restorative justice practices on behalf of the 15 juvenile. and failure to provide an advisement regarding restorative 16 justice practices does not constitute any legal error by the court.

SECTION 9. In Colorado Revised Statutes, 19-2-905, amend (4)
as follows:

19 19-2-905. Presentence investigation. (4) Prior to sentencing a 20 juvenile who was adjudicated for an offense that would be a felony or 21 misdemeanor not contained in title 42, C.R.S., if committed by an adult, 22 the court upon the request of the victim, may order the juvenile to 23 participate in an assessment to determine whether the juvenile would be 24 suitable for participation in restorative justice practices that would be a 25 part of the juvenile's sentence; except that the court may not order 26 participation in a restorative justice practice if the juvenile was adjudicated a delinquent for unlawful sexual behavior, as defined in 27

1 section 16-22-102 (9), C.R.S., a crime in which the underlying factual 2 basis involves domestic violence, as defined in section 18-6-800.3 (1), 3 C.R.S., stalking as defined in section 18-3-602, C.R.S., or violation of a 4 protection order as defined in section 18-6-803.5, C.R.S. If the court 5 orders a suitability assessment, the assessor shall provide the services for 6 a fee of no more than forty dollars based on a sliding scale; however, the 7 fee may be waived by the court REDUCED BY THE COURT BASED ON A 8 SLIDING SCALE CONSISTENT WITH GUIDELINES USED TO DETERMINE 9 ELIGIBILITY FOR APPOINTMENT OF COUNSEL. IF A JUVENILE WANTS TO 10 PARTICIPATE IN RESTORATIVE JUSTICE PRACTICES, THE JUVENILE MUST 11 MAKE THE REQUEST TO THE DISTRICT ATTORNEY OR THE LAW 12 ENFORCEMENT AGENCY ADMINISTERING THE PROGRAM AND MAY NOT 13 MAKE THE REQUEST TO THE VICTIM. IF REQUESTED BY THE JUVENILE OR 14 LAW ENFORCEMENT AGENCY, A VICTIM-OFFENDER CONFERENCE MAY 15 ONLY BE CONDUCTED AFTER THE VICTIM IS CONSULTED BY THE DISTRICT 16 ATTORNEY AND OFFERED AN OPPORTUNITY TO PARTICIPATE OR SUBMIT A 17 VICTIM IMPACT STATEMENT. IF A VICTIM ELECTS NOT TO ATTEND, A 18 VICTIM-OFFENDER CONFERENCE MAY BE HELD WITH A SUITABLE VICTIM 19 SURROGATE OR VICTIM ADVOCATE, AND THE VICTIM MAY SUBMIT A 20 VICTIM-IMPACT STATEMENT. If the juvenile participates in a restorative 21 justice practices victim-offender conference, the facilitator shall provide 22 these services for a fee of no more than one hundred twenty-five dollars 23 based on a sliding scale; however, the fee may be waived by the court. 24 **SECTION 10.** In Colorado Revised Statutes, add article 25 to 25 title 18 as follows:

18-25-101. Restorative justice surcharge - definitions.

SECTION.

17 (3) (a) THERE IS CREATED IN THE STATE TREASURY THE 18 RESTORATIVE JUSTICE SURCHARGE FUND THAT CONSISTS OF MONEYS 19 RECEIVED BY THE STATE TREASURER PURSUANT TO THIS SECTION. THE 20 MONEYS IN THE FUND ARE SUBJECT TO ANNUAL APPROPRIATION BY THE 21 GENERAL ASSEMBLY TO THE JUDICIAL DEPARTMENT FOR DISTRIBUTION TO 22 JUDICIAL DISTRICTS THAT OFFER RESTORATIVE JUSTICE PROGRAMS AND TO 23 THE RESTORATIVE JUSTICE COORDINATING COUNCIL FOR ADMINISTRATIVE 24 EXPENSES.

(b) THE JUDICIAL DEPARTMENT SHALLESTABLISH GUIDELINES FOR
 THE DISTRIBUTION OF THE MONEYS FROM THE FUND TO ASSIST IN
 DEFRAYING THE COSTS OF RESTORATIVE JUSTICE PROGRAMS, INCLUDING

BUT NOT LIMITED TO PROCEDURES FOR PROGRAMS TO USE IN APPLYING TO
 THE JUDICIAL DEPARTMENT FOR MONEYS FROM THE FUND.

3 (c) THE JUDICIAL DEPARTMENT SHALL NOT EXPEND ANY MONEYS
