**A BILL FOR AN ACT**

101 **CONCERNING AN INCREASE IN THE NUMBER OF JUDGES IN CERTAIN**  
102 **JUDICIAL DISTRICTS, AND, IN CONNECTION THEREWITH, MAKING**  
103 **AN APPROPRIATION.**

**Bill Summary**

The bill increases the number of judges in the 5th judicial district from 5 to 6 and in the 9th judicial district from 4 to 5.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 13-5-106, **amend** (2)  
3 (a); and **repeal** (2) (b) and (2) (c) as follows:

4 **13-5-106. Fifth district.** (2) (a) The number of judges for the  
5 fifth judicial district shall be ~~three~~ SIX.

6 (b) ~~Subject to available appropriations, effective July 1, 2002, the~~  
7 ~~number of judges for the fifth judicial district shall be four.~~

8 (c) ~~Subject to available appropriations, effective July 1, 2004, the~~  
9 ~~number of judges for the fifth judicial district shall be five.~~

10 **SECTION 2.** In Colorado Revised Statutes, 13-5-110, **amend** (2)  
11 as follows:

12 **13-5-110. Ninth district.** (2) (a) The number of judges for the  
13 ninth judicial district shall be ~~three~~ FIVE.

14 (b) ~~Subject to available appropriations, effective July 1, 2008, the~~  
15 ~~number of judges for the ninth judicial district shall be four.~~

16 **SECTION 3. Appropriation.** (1) In addition to any other  
17 appropriation, there is hereby appropriated, out of any moneys in the  
18 judicial stabilization cash fund created in section 13-32-101 (6), Colorado  
19 Revised Statutes, not otherwise appropriated, to the judicial department,  
20 for the fiscal year beginning July 1, 2013, the sum of \$635,476 and 8.0  
21 FTE, or so much thereof as may be necessary, to be allocated to the trial  
22 courts for the implementation of this act as follows:

23 (a) \$618,376 and 8.0 FTE for trial court programs for personal  
24 services; and

25 (b) \$17,100 for trial court programs for operating expenses.

26 (2) In addition to any other appropriation, there is hereby  
27 appropriated, out of any moneys in the judicial stabilization cash fund

1 created in section 13-32-101 (6), Colorado Revised Statutes, not  
2 otherwise appropriated, to the judicial department, for the fiscal year  
3 beginning July 1, 2013, the sum of \$141,498, or so much thereof as may  
4 be necessary, to be allocated to the courts administration division for  
5 courthouse capital expenses related to the implementation of this act.

6 **SECTION 4. Effective date.** This act takes effect July 1, 2013.

7 **SECTION 5. Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, and safety.
