A BILL FOR AN ACT

101 CONCERNING THE CREATION OF A POSITION BY THE GOVERNOR FOR 102 **CLIMATE CHANGE MATTERS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill directs the governor to establish a position for climate change issues. The person appointed to that position is required to develop climate action plans and to report annually to the general assembly regarding how climate change affects the state.
