#### **Bill Summary**

The bill creates a mental health and firearms task force (task force) to advise the general assembly regarding issues surrounding the loss, maintenance, and restoration of the right to purchase and possess firearms by persons who, as a result of mental health issues, alcohol abuse, or

substance abuse, are clearly dangerous to the health and safety of themselves or others.

The task force shall submit a written report of its findings and recommendations to the judiciary committees of the house of representatives and senate, or any successor committees, on or before January 15, 2015. The first meeting of the task force shall occur no later than July 18, 2013. The task force shall meet at least 5 times.

Meetings of the task force shall be public meetings. The task force may accept reports and public testimony and may request other sources to provide testimony, written comments, and other relevant data to the task force.

Members of the task force shall serve without compensation and shall not be entitled to reimbursement for expenses. The legislative council staff and the office of legislative legal services shall not provide staff support to the task force.

The task force is repealed, effective August 1, 2015.

(1) ON AND AFTER THE 6 EFFECTIVE DATE OF THIS SECTION, THE DEPARTMENT SHALL CONVENE A 7 MENTAL HEALTH AND FIREARMS TASK FORCE, REFERRED TO IN THIS 8 SECTION AS THE "TASK FORCE", FOR THE PURPOSE OF ADVISING THE 9 GENERAL ASSEMBLY REGARDING ISSUES SURROUNDING THE LOSS, 10 MAINTENANCE, AND RESTORATION OF THE RIGHT TO PURCHASE AND 11 POSSESS FIREARMS BY PERSONS WHO, AS A RESULT OF MENTAL HEALTH 12 ISSUES, ALCOHOL ABUSE, SUBSTANCE ABUSE, OR FAMILY DYNAMICS, ARE 13 CLEARLY DANGEROUS TO THE HEALTH AND SAFETY OF THEMSELVES OR 14 OTHERS, INCLUDING BUT NOT LIMITED TO PERSONS WHO:

2 (XVII) A REPRESENTATIVE OF THE COLORADO FRATERNAL ORDER 3 OF POLICE; AND 4 (XVIII) TWO PERSONS, EACH OF WHOM HAS BEEN PLACED IN A 5 FACILITY FOR TREATMENT PURSUANT TO SECTION 27-65-105, 27-81-111 (3), OR 27-82-107 (3). 6 7 (3) (a) THE APPOINTING ENTITIES DESCRIBED IN SUBSECTION (2) OF 8 THIS SECTION SHALL APPOINT THE MEMBERS OF THE TASK FORCE, AS 9 DESCRIBED IN SAID SUBSECTION (2), ON OR BEFORE JULY 1, 2013. 10 (b) ON OR BEFORE JULY 1, 2013, THE SPEAKER OF THE HOUSE OF 11 REPRESENTATIVES SHALL APPOINT A CHAIR AND A VICE CHAIR OF THE 12 TASK FORCE. IN MAKING SUCH APPOINTMENTS, THE SPEAKER SHALL 13 APPOINT ONLY PERSONS WHO HAVE BEEN OTHERWISE APPOINTED TO THE 14 TASK FORCE. 15 (4) THE TASK FORCE SHALL SUBMIT A WRITTEN REPORT OF ITS 16 FINDINGS AND RECOMMENDATIONS TO THE JUDICIARY COMMITTEES OF THE

HOUSE OF REPRESENTATIVES AND SENATE, OR ANY SUCCESSOR
COMMITTEES, ON OR BEFORE JANUARY 15, 2015. UPON REQUEST OF A
MEMBER OF THE TASK FORCE, SUMMARIES OF DISSENTING OPINIONS SHALL
BE PREPARED AND ATTACHED TO THE FINAL REPORT OF FINDINGS AND
RECOMMENDATIONS.

(5) (a) THE FIRST MEETING OF THE TASK FORCE SHALL OCCUR NO
LATER THAN JULY 18, 2013. THE TASK FORCE SHALL MEET AT LEAST FIVE
TIMES.

(b) MEETINGS OF THE TASK FORCE SHALL BE PUBLIC MEETINGS.
(c) THE TASK FORCE MAY ACCEPT REPORTS AND PUBLIC
TESTIMONY AND MAY REQUEST OTHER SOURCES TO PROVIDE TESTIMONY,

1 WRITTEN COMMENTS, AND OTHER RELEVANT DATA TO THE TASK FORCE.

2 (6) MEMBERS OF THE TASK FORCE SHALL SERVE WITHOUT
3 COMPENSATION AND ARE NOT BE ENTITLED TO REIMBURSEMENT FOR
4 EXPENSES.

5 (7) THE LEGISLATIVE COUNCIL STAFF AND THE OFFICE OF
6 LEGISLATIVE LEGAL SERVICES SHALL NOT PROVIDE STAFF SUPPORT TO THE
7 TASK FORCE.

8 (8) This section is repealed, effective August 1, 2015.

9 SECTION 2. Appropriation. In addition to any other 10 appropriation, there is hereby appropriated, out of any moneys in the 11 general fund not otherwise appropriated, to the department of human 12 services, for the fiscal year beginning July 1, 2013, the sum of \$25,792, or 13 so much thereof as may be necessary, for allocation to behavioral health 14 services for contract staffing costs related to the implementation of this 15 act.

SECTION 3. Safety clause. The general assembly hereby finds,
determines, and declares that this act is necessary for the immediate
preservation of the public peace, health, and safety.
