101 **CONCERNING RECOGNITION OF MILITARY PERSONNEL FROM**
102 **COLORADO WHO HAVE SERVED IN OPERATION NEW DAWN AND**
103 **OPERATION ENDURING FREEDOM AND IN THE GLOBAL WAR ON**
104 **TERRORISM, AND HONORING THOSE WHO HAVE DIED WHILE**
105 **SERVING THEIR COUNTRY IN IRAQ, AFGHANISTAN, AND**
106 **ELSEWHERE AROUND THE WORLD.**

1 WHEREAS, Thousands of military personnel from Colorado have
2 served in Afghanistan in Operation Enduring Freedom, in Iraq in
3 Operation New Dawn, and in the Global War on Terrorism, including
4 troops based at Fort Carson, the United States Air Force Academy,
5 Peterson Air Force Base, and Buckley Air Force Base; members of the
6 Colorado National Guard, Army Reserve, and Marine Corps Reserve; and

24 Reconnaissance Battalion, based at Camp Pendleton,
25 California;

26 ! Staff Sergeant Liam Jules Nevins, 32, of Denver, a member
27 of the United States Army assigned to Company B, 5th
28 Battalion, 19th Special Forces Group, based at Fort Carson,
29 Colorado, while serving as part of Operation Enduring
30 Freedom;

31 ! Specialist Rob Lee Nichols, 24, of Colorado Springs, a
32 member of the United States Army assigned to Company
33 B, 3rd Battalion, 15th Infantry Regiment, 4th Infantry
34 Brigade Combat Team, 3rd Infantry Division, based at Fort
35 Stewart, Georgia, while serving as part of Operation

1 Enduring Freedom; and

2 ! Corporal David Michael Sonka, 23, of Parker, a member of
3 the United States Marine Corps assigned to 2nd Marine
4 Special Operations Battalion, based at Camp Lejeune,
5 North Carolina, while serving as part of Operation
6 Enduring Freedom; now, therefore,

7 *Be It Resolved by the House of Representatives of the Sixty-ninth*
8 *General Assembly of the State of Colorado, the Senate concurring herein:*

9 That we, the members of the Sixty-ninth General Assembly of the
10 state of Colorado:

11 (1) Remember and honor these and all Coloradans who have
12 given their lives in service to their country in Operation New Dawn,
13 Operation Enduring Freedom, and in the Global War on Terrorism;

14 (2) Express our sympathy to the families and friends of those
15 service members who have died; and

16 (3) Honor the service, dedication, and valor of all military
17 personnel from Colorado who have served and are currently serving in
18 Iraq and Afghanistan and in the Global War on Terrorism.
