After consideration on the merits, the Committee recommends the following:

SB14-176 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 5, strike lines 24 through 27.

2 Page 6, strike lines 1 through 3 and substitute:

3 "SECTION 3. In Colorado Revised Statutes, **add** 17-18-111 as
4 follows:

5 **17-18-111. Appropriation to comply with section 2-2-703 - SB**
6 **14-176 - repeal.** (1) PURSUANT TO SECTION 2-2-703, C.R.S., THE
7 FOLLOWING STATUTORY APPROPRIATIONS, OR SO MUCH THEREOF AS MAY
8 BE NECESSARY, ARE MADE IN ORDER TO IMPLEMENT SENATE BILL 14-176,
9 ENACTED IN 2014:

10 (a) FOR THE FISCAL YEAR BEGINNING JULY 1, 2015, IN ADDITION TO
11 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
12 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
13 OTHERWISE APPROPRIATED, THE SUM OF TWENTY-ONE THOUSAND FOUR
14 HUNDRED EIGHTY-FOUR DOLLARS (\$21,484).

15 (b) FOR THE FISCAL YEAR BEGINNING JULY 1, 2016, IN ADDITION TO
16 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
17 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
18 OTHERWISE APPROPRIATED, THE SUM OF FORTY-TWO THOUSAND NINE
19 HUNDRED SIXTY-EIGHT DOLLARS (\$42,968).

20 (c) FOR THE FISCAL YEAR BEGINNING JULY 1, 2017, IN ADDITION TO
21 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
22 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT

1 OTHERWISE APPROPRIATED, THE SUM OF SIXTY-FOUR THOUSAND FOUR
2 HUNDRED FIFTY-TWO DOLLARS (\$64,452).

3 (d) FOR THE FISCAL YEAR BEGINNING JULY 1, 2018, IN ADDITION TO
4 ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
5 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
6 OTHERWISE APPROPRIATED, THE SUM EIGHTY-TWO THOUSAND FIVE
7 HUNDRED THIRTY-FOUR DOLLARS (\$82,534).

8 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2019."

9 Page 1, line 102, strike "VEHICLES." and substitute "VEHICLES, AND, IN
10 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
