**A BILL FOR AN ACT**

101 **CONCERNING CLARIFICATION OF THE STATUTES RELATING TO THE**  
102 **REGISTRATION OF COLLECTOR'S ITEM MOTOR VEHICLES TO**  
103 **SPECIFY THAT CERTAIN SPECIAL EMISSION INSPECTION**  
104 **REQUIREMENTS FOR COLLECTOR'S ITEM MOTOR VEHICLES**  
105 **REGISTERED PRIOR TO THE ENACTMENT OF HOUSE BILL 13-1071**  
106 **CONTINUE TO APPLY TO THOSE VEHICLES UNTIL THEY ARE**  
107 **TRANSFERRED.**

The bill clarifies changes made to the laws governing the registration of collector's item motor vehicles by HB 13-1071. **Sections 1 through 3** make clear that emission inspection requirements for collector's item motor vehicles registered before September 1, 2009, continue to apply to those vehicles until they are transferred.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-4-310, **amend** (1)

3 (a) (II) (D) as follows:

4 **42-4-310. Periodic emissions control inspection required.**

5 (1) (a) (II) (D) EXCEPT FOR A MOTOR VEHICLE THAT WAS REGISTERED AS  
6 A COLLECTOR'S ITEM BEFORE SEPTEMBER 1, 2009, AND MEETS THE  
7 REQUIREMENTS OF SECTIONS 42-12-101 (2) (b) AND 42-12-404 (2), to be  
8 sold or transferred or to renew the registration, A 1976 ~~and~~ OR newer  
9 model motor ~~vehicles~~ VEHICLE registered as a collector's item under  
10 article 12 of this title must be inspected and have a certification of  
11 emissions control. The certification of emissions control is valid for sixty  
12 months.

13 **SECTION 2.** In Colorado Revised Statutes, 42-12-101, **amend**  
14 (2) (c) introductory portion as follows:

15 **42-12-101. Definitions.** As used in this article, unless the context  
16 otherwise requires:

17 (2) "Collector's item" means a motor vehicle, including a truck or  
18 truck tractor, that is of:

19 (c) A model year at least thirty-two years old ~~except that~~ UNLESS  
20 THE VEHICLE WAS REGISTERED BEFORE SEPTEMBER 1, 2009, AND MEETS  
21 THE REQUIREMENTS OF PARAGRAPH (b) OF THIS SUBSECTION (2). If the  
22 vehicle is being registered UNDER THIS PARAGRAPH (c) AND in the

1 program area, as defined in section 42-4-304:

2 **SECTION 3.** In Colorado Revised Statutes, 42-12-404, **amend**  
3 (3) as follows:

4 **42-12-404. Emissions.** (3) EXCEPT FOR A MOTOR VEHICLE THAT  
5 WAS REGISTERED BEFORE SEPTEMBER 1, 2009, AND MEETS THE  
6 REQUIREMENTS OF SUBSECTION (2) OF THIS SECTION, to register or  
7 reregister a collector's item that is model year 1976 or ~~later~~ NEWER, the  
8 owner must have a certificate of emission control issued under part 3 of  
9 article 4 of this title.

10 **SECTION 4. Safety clause.** The general assembly hereby finds,  
11 determines, and declares that this act is necessary for the immediate  
12 preservation of the public peace, health, and safety.
