**A BILL FOR AN ACT**

101 **CONCERNING CLARIFICATION OF THE REQUIREMENTS APPLICABLE TO**  
102 **A CHANGE OF POINT OF WATER DIVERSION.**

**Bill Summary**

A statute enacted in 1881 allows the owner of a ditch to relocate the ditch's headgate if changes to the stream prevent the headgate from effectuating the diversion. The "Water Right Determination and Administration Act of 1969" (1969 act) requires changes of water rights, including changes of points of diversion, to be adjudicated. The 1969 act

does not exempt changes authorized by the 1881 act. The bill clarifies that a water right owner may relocate a ditch headgate pursuant to the 1881 act without filing for a change of water right under the 1969 act if the relocation does not physically interfere with the complete use or enjoyment of other water rights.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 37-86-111 as  
3 follows:

4           **37-86-111. Head of ditch may be relocated.** (1) In case the  
5 channel of ~~any~~ A natural stream becomes so cut out, lowered, turned  
6 aside, or otherwise changed from any cause as to prevent any ditch, canal,  
7 or feeder of any reservoir from receiving the proper inflow of water to  
8 which it may be entitled from ~~such~~ THE natural stream, the owners of ~~such~~  
9 THE ditch, canal, or feeder have the right to ~~extend~~ RELOCATE the head of  
10 ~~such~~ THE ditch, canal, or feeder to such distance ~~up~~ TO the stream ~~which~~  
11 THAT supplies ~~the same~~ IT as may be necessary for securing a sufficient  
12 flow of water into the ~~same~~ DITCH, CANAL, OR FEEDER. For that purpose  
13 they have the same right to maintain proceedings for condemnation of A  
14 right-of-way for ~~such extension~~ THE RELOCATION as in THE case of  
15 constructing a new ditch. The priority of right to take water from ~~such~~ A  
16 stream through such ditch, canal, or feeder ~~as to any such ditch, canal, or~~  
17 ~~feeder shall remain~~ REMAINS unaffected in any respect by reason of ~~such~~  
18 ~~extension~~ THE RELOCATION; but ~~no such extension shall~~ THE RELOCATION  
19 MUST NOT PHYSICALLY interfere with the complete use or enjoyment of  
20 any ~~ditch, canal, or feeder~~ ABSOLUTE OR DECREED CONDITIONAL WATER  
21 RIGHT.

22           (2) IF AN OWNER OF A WATER RIGHT RELOCATES A SURFACE  
23 DIVERSION STRUCTURE TO A NEW SURFACE POINT OF DIVERSION IN

1 COMPLIANCE WITH SUBSECTION (1) OF THIS SECTION, THE OWNER DOES  
2 NOT NEED TO FILE A CHANGE OF WATER RIGHT APPLICATION FOR THE NEW  
3 SURFACE POINT OF DIVERSION.

4 **SECTION 2.** In Colorado Revised Statutes, 37-92-103, **amend**  
5 (5) as follows:

6 **37-92-103. Definitions.** As used in this article, unless the context  
7 otherwise requires:

8 (5) "Change of water right" means a change in the type, place, or  
9 time of use, a change in the point of diversion EXCEPT AS SPECIFIED IN  
10 SECTION 37-86-111 (2), a change from a fixed point of diversion to  
11 alternate or supplemental points of diversion, a change from alternate or  
12 supplemental points of diversion to a fixed point of diversion, a change  
13 in the means of diversion, a change in the place of storage, a change from  
14 direct application to storage and subsequent application, a change from  
15 storage and subsequent application to direct application, a change from  
16 a fixed place of storage to alternate places of storage, a change from  
17 alternate places of storage to a fixed place of storage, or any combination  
18 of such changes. The term "change of water right" includes changes of  
19 conditional water rights as well as changes of water rights.

20 **SECTION 3. Applicability.** This act applies to changes in points  
21 of diversion made before, on, or after the effective date of this act.

22 **SECTION 4. Safety clause.** The general assembly hereby finds,  
23 determines, and declares that this act is necessary for the immediate  
24 preservation of the public peace, health, and safety.
