**A BILL FOR AN ACT**

101 **CONCERNING RIGOR-BASED TUITION ASSISTANCE FOR STUDENTS AT**  
102 **POSTSECONDARY INSTITUTIONS, AND, IN CONNECTION**  
103 **THEREWITH, MAKING AN APPROPRIATION.**

The bill creates the Colorado opportunity scholarship initiative (initiative) within the department of higher education (department) to:

! Award scholarships or grants based upon a rigor-based method to students who are classified as Colorado residents

for tuition purposes; and

- ! Develop the connections and community partnerships necessary to ensure that every Colorado student has the support needed to enter a postsecondary opportunity, persist and succeed, and enter his or her desired position in the workforce.

The bill creates the Colorado opportunity pipeline scholarship initiative advisory board (board) and requires the board to promulgate rules for administration of the initiative, including but not limited to the following:

- ! Criteria for eligibility of state agencies, nonprofit organizations, and public institutions of higher education to participate in the initiative;
- ! Criteria for eligibility of students to apply for and receive grants from the initiative;
- ! Rules establishing permissible uses of grant moneys from the initiative; and
- ! Criteria for evaluating the effectiveness of the initiative in improving higher education outcomes in the state.

The director of the initiative shall administer the initiative in accordance with rules promulgated by the board.

The bill creates the Colorado opportunity pipeline scholarship initiative fund (fund), which consists of:

- ! Any moneys appropriated to the fund by the general assembly;
- ! Any moneys transferred to the fund from any other fund; and
- ! Any moneys received by the department as gifts, grants, or donations.

The department is authorized to spend not more than 3% of the moneys annually appropriated to the fund to pay the direct and indirect costs of administering the initiative. The board may promulgate rules for the administration of the fund. For the 2015-2016 fiscal year, the general assembly shall appropriate \$30 million to the fund.

The members of the state workforce development council (state council) shall serve as members of the board. The state council shall identify staff members within the department of education, the department of higher education, and the department of labor and employment who shall assist the state council in fulfilling its duties as members of the board.

The financial need scholarship fund in the department is repealed, and any moneys remaining in the financial need scholarship fund are transferred to the fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** part 10 to article  
3 3.3 of title 23 as follows:

7 **23-3.3-1001. Legislative declaration.** (1) THE GENERAL  
8 ASSEMBLY HEREBY DECLARES THAT THE COLORADO OPPORTUNITY  
9 SCHOLARSHIP INITIATIVE CREATED IN THIS PART 10 IS INTENDED TO:

10 (a) AWARD SCHOLARSHIPS OR GRANTS BASED UPON A  
11 RIGOR-BASED METHOD THAT EMPHASIZES STUDENT COMMITMENT TO  
12 ACADEMIC ACHIEVEMENT AND SUCCESSFUL PLACEMENT IN THE  
13 WORKFORCE AND ENSURING THAT PARTICIPATING STUDENTS AND  
14 INSTITUTIONS BE HELD ACCOUNTABLE THROUGH MEASURABLE OUTCOMES;  
15 AND

16 (b) DEVELOP THE CONNECTIONS AND COMMUNITY PARTNERSHIPS  
17 NECESSARY TO ENSURE THAT EVERY COLORADO STUDENT HAS THE  
18 SUPPORT NEEDED TO ENTER A POSTSECONDARY OPPORTUNITY, PERSIST  
19 AND SUCCEED, AND ENTER HIS OR HER DESIRED POSITION IN THE  
20 WORKFORCE.

21 (2) IT IS THE INTENT OF THE GENERAL ASSEMBLY TO MATCH  
22 NON-PROFIT AND PRIVATE FINANCIAL CONTRIBUTIONS TO THE COLORADO  
23 OPPORTUNITY SCHOLARSHIP INITIATIVE WITH ANNUAL CONTRIBUTIONS  
24 FROM THE GENERAL FUND SO THAT A SUSTAINABLE CORPUS IS CREATED TO  
25 FUND SCHOLARSHIP AWARDS IN FUTURE YEARS. WHENEVER PRACTICABLE,  
26 THE ANNUAL MATCH SHOULD BE IN AN AMOUNT THAT IS SIGNIFICANT  
27 ENOUGH TO ATTRACT CONTINUED INVESTMENT BY COMMUNITY PARTNERS.

20 FEDERALLY FUNDED PROGRAM OFFERING POSTSECONDARY  
21 WORKFORCE-READY OPTIONS TO COLORADO STUDENTS.

22           (9) "TUITION ASSISTANCE" MEANS FINANCIAL ASSISTANCE TO AN  
23 ELIGIBLE STUDENT OF AN ELIGIBLE INSTITUTION, INCLUDING SUCH  
24 FINANCIAL ASSISTANCE AS IS NECESSARY TO PAY THE COSTS OF TUITION,  
25 FEES, BOOKS, HOUSING, FOOD, AND TRANSPORTATION.

27 **- created - report.** (1) THERE IS CREATED THE COLORADO OPPORTUNITY

1 ■ SCHOLARSHIP INITIATIVE WITHIN THE DEPARTMENT. THE EXECUTIVE  
2 DIRECTOR OR HIS OR HER DESIGNEE SHALL APPOINT THE DIRECTOR OF THE  
3 INITIATIVE FROM EXISTING PERSONNEL WHO SHALL ADMINISTER THE  
4 INITIATIVE IN ACCORDANCE WITH RULES PROMULGATED BY THE BOARD  
5 PURSUANT TO SECTION 23-3.3-1004 (4).

6 (2) ON OR BEFORE JUNE 30, 2015, THE DIRECTOR OF THE  
7 INITIATIVE SHALL REPORT TO THE EDUCATION COMMITTEES OF THE HOUSE  
8 OF REPRESENTATIVES AND SENATE, OR TO ANY SUCCESSOR COMMITTEES,  
9 CONCERNING THE RECOMMENDATIONS PREPARED BY THE BOARD  
10 PURSUANT TO SECTION 23-3.3-1004 (4) (c).

11 **23-3.3-1004. Colorado opportunity ■ scholarship initiative**  
12 **advisory board - created - duties - rules.** (1) THERE IS CREATED THE  
13 COLORADO OPPORTUNITY ■ SCHOLARSHIP INITIATIVE ADVISORY BOARD,  
14 WHICH SHALL CONSIST OF THE EXECUTIVE COMMITTEE OF THE STATE  
15 WORK FORCE DEVELOPMENT COUNCIL CREATED IN SECTION 24-46.3-101,  
16 C.R.S., AS DESCRIBED IN THE BYLAWS OF THE COUNCIL, AS WELL AS THE  
17 FOLLOWING THREE PERSONS, TO BE APPOINTED BY THE GOVERNOR OR HIS  
18 OR HER DESIGNEE:

19 (a) ONE PERSON REPRESENTING THE FOUR-YEAR RESEARCH  
20 INSTITUTIONS OF HIGHER EDUCATION IN THE STATE;

21 (b) ONE PERSON REPRESENTING THE SYSTEM OF FOUR-YEAR  
22 POSTSECONDARY INSTITUTIONS IN THE STATE; AND

23 (c) ONE PERSON REPRESENTING THE COMMUNITY COLLEGES AND  
24 AREA VOCATIONAL DISTRICTS OF THE STATE.

25 (2) THE GOVERNOR OR HIS OR HER DESIGNEE SHALL MAKE HIS OR  
26 HER APPOINTMENTS TO THE BOARD ON OR BEFORE AUGUST 1, 2014. THE  
27 MEMBERS OF THE BOARD SHALL ELECT PRESIDING OFFICERS FOR THE

1 BOARD, INCLUDING A CHAIR AND VICE-CHAIR, FROM AMONG THE BOARD  
2 MEMBERS APPOINTED PURSUANT TO SUBSECTION (1) OF THIS SECTION,  
3 WHICH PRESIDING OFFICERS SHALL SERVE TERMS OF TWO YEARS. BOARD  
4 MEMBERS MAY REELECT A PRESIDING OFFICER.

5 (3) EACH MEMBER OF THE BOARD APPOINTED BY THE GOVERNOR  
6 OR HIS OR HER DESIGNEE SHALL SERVE AT THE PLEASURE OF THE  
7 GOVERNOR OR HIS OR HER DESIGNEE FOR A TERM OF FOUR YEARS. THE  
8 GOVERNOR OR HIS OR HER DESIGNEE MAY REAPPOINT THE MEMBER FOR AN  
9 ADDITIONAL TERM OR TERMS. MEMBERS OF THE BOARD SHALL SERVE  
10 WITHOUT COMPENSATION.

11 (4) THE BOARD SHALL HOLD ITS FIRST MEETING ON OR BEFORE  
12 NOVEMBER 1, 2014, AT A TIME AND PLACE TO BE DESIGNATED BY THE  
13 EXECUTIVE DIRECTOR OR BY HIS OR HER DESIGNEE. THE BOARD SHALL  
14 MEET AT LEAST FOUR TIMES EACH YEAR AND SHALL CARRY OUT THE  
15 FOLLOWING DUTIES:

16 (a) PROMULGATE RULES FOR ADMINISTRATION OF THE INITIATIVE,  
17 INCLUDING BUT NOT LIMITED TO THE FOLLOWING:

18 (I) CRITERIA FOR ELIGIBILITY OF STATE AGENCIES, NONPROFIT  
19 ORGANIZATIONS, AND PUBLIC INSTITUTIONS OF HIGHER EDUCATION TO  
20 PARTICIPATE IN THE INITIATIVE;

21 (II) CRITERIA FOR ELIGIBILITY OF STUDENTS TO APPLY FOR AND  
22 RECEIVE GRANTS FROM THE INITIATIVE, WHICH CRITERIA SHALL INCLUDE  
23 CONSIDERATION OF AN APPLICANT STUDENT'S:

24 (A) COURSES OF STUDY;

25 (B) COMMITMENT TO ACADEMIC ACHIEVEMENT;

26 (C) WORK EXPERIENCE;

27 (D) COMMUNITY INVOLVEMENT; AND

1 (E) EXTRACURRICULAR ACTIVITIES;

2 (III) RULES ESTABLISHING PERMISSIBLE USES OF GRANT AND  
3 SCHOLARSHIP MONEYS FROM THE INITIATIVE, WHICH RULES SHALL  
4 STIPULATE THAT:

5 (A) NOT MORE THAN TEN PERCENT OF THE MONEYS IN THE  
6 FUND IN ANY FISCAL YEAR MAY BE AWARDED TO STATE AGENCIES AND  
7 NONPROFIT ORGANIZATIONS TO ASSIST SUCH AGENCIES AND  
8 ORGANIZATIONS WITH ENSURING THAT STUDENT-SUCCESS,  
9 PRECOLLEGIATE, POSTSECONDARY STUDENT SUPPORT SERVICES ARE  
10 AVAILABLE TO STUDENTS WHO ARE CLASSIFIED AS COLORADO RESIDENTS  
11 FOR TUITION PURPOSES; INCREASING THE CAPACITY FOR STUDENT SUPPORT  
12 SERVICES AT POSTSECONDARY INSTITUTIONS; AND DEVELOPING  
13 CONNECTIONS BETWEEN LOCAL EMPLOYERS, PUBLIC SCHOOLS,  
14 PRECOLLEGIATE ORGANIZATIONS, AND POSTSECONDARY INSTITUTIONS;

15 (B) OF THE MONEYS DESCRIBED IN SUB-SUBPARAGRAPH (A) OF  
16 THIS SUBPARAGRAPH (III), AT LEAST SEVENTY PERCENT MUST BE  
17 AWARDED TO NONGOVERNMENTAL ENTITIES;

18 (C) ANY MONEYS APPROPRIATED TO THE FUND THAT ARE NOT  
19 USED FOR THE PURPOSES DESCRIBED IN SUB-SUBPARAGRAPH (A) OF THIS  
20 SUBPARAGRAPH (III), OR TO PAY THE DIRECT AND INDIRECT COSTS OF  
21 ADMINISTERING THE INITIATIVE AS DESCRIBED IN SECTION 23-3.3-1005 (4),  
22 MUST BE USED TO BUILD A FINANCIAL CORPUS CAPABLE OF PROVIDING  
23 TUITION ASSISTANCE TO ELIGIBLE COLORADO STUDENTS IN COLORADO  
24 WHO WILL ATTEND ELIGIBLE INSTITUTIONS OF HIGHER EDUCATION WITHIN  
25 THE STATE. TUITION ASSISTANCE PROVIDED PURSUANT TO THIS  
26 SUB-SUBPARAGRAPH (B) MAY TAKE THE FORM OF DIRECT AWARDS,  
27 MATCHING INCENTIVES TO CREATE OR INCREASE THE NUMBER OF OTHER

1 SCHOLARSHIPS, LOANS, OR ANY COMBINATION THEREOF.

2 (D) TO THE EXTENT PRACTICABLE, GRANTS OF TUITION  
3 ASSISTANCE MUST BE AWARDED TO STUDENTS REPRESENTING RURAL AND  
4 URBAN AREAS OF THE STATE AND TO STUDENTS ATTENDING PUBLIC  
5 VOCATIONAL SCHOOLS, COMMUNITY COLLEGES, FOUR-YEAR INSTITUTIONS  
6 OF HIGHER EDUCATION, AND RESEARCH INSTITUTIONS; AND

7 (E) TO THE EXTENT PRACTICABLE, TUITION ASSISTANCE MUST BE  
8 EVENLY DISTRIBUTED BETWEEN STUDENTS WHO ARE ELIGIBLE FOR  
9 FEDERAL PELL GRANTS AND STUDENTS WHOSE HOUSEHOLD INCOMES ARE  
10 BETWEEN ONE HUNDRED PERCENT AND TWO HUNDRED FIFTY PERCENT OF  
11 THE MAXIMUM PERMISSIBLE INCOME FOR THE PURPOSE OF DETERMINING  
12 ELIGIBILITY FOR PELL GRANTS;

13 (IV) CRITERIA FOR EVALUATING THE EFFECTIVENESS OF THE  
14 INITIATIVE IN IMPROVING HIGHER EDUCATION OUTCOMES IN THE STATE,

19 (D) INCREASES IN STUDENT RETENTION RATES;

20 (E) REDUCTIONS IN DISPARITIES BETWEEN THE ACADEMIC  
21 ACHIEVEMENTS OF CERTAIN STUDENT POPULATIONS BASED ON  
22 DEMOGRAPHIC, GEOGRAPHIC, AND ECONOMIC INDICATORS;

23 (F) ADOPTION OF BEST PRACTICES FOR STUDENT SUPPORT  
24 SERVICES;

25 (G) FULFILLMENT OF LOCAL WORKFORCE NEEDS;

26 (H) REDUCTIONS IN STUDENT LOAN DEBT;

27 (I) IMPROVEMENTS IN TUITION AFFORDABILITY; AND

1 (J) IMPROVEMENTS IN STUDENTS' ACCESS TO FEDERAL GRANT  
2 PROGRAMS AND OTHER FEDERAL SOURCES OF SUPPORT FOR  
3 POSTSECONDARY STUDENTS;

4 (b) IDENTIFY AND CONSIDER THE FEASIBILITY OF POTENTIAL  
5 FUNDING SOURCES FOR THE INITIATIVE, INCLUDING BUT NOT LIMITED TO:

6 (I) THE IMPLEMENTATION OF AN INCOME TAX CREDIT FOR  
7 TAXPAYERS OF THE STATE WHO ELECT TO MAKE A CONTRIBUTION TO THE  
8 FUND; AND

9 (II) ANY FUNDRAISING FOR THE INITIATIVE THAT MAY RESULT  
10 FROM A MEMORANDUM OF UNDERSTANDING EXECUTED BETWEEN THE  
11 BOARD AND A NONPROFIT ORGANIZATION, AS DESCRIBED IN SUBSECTION  
12 (5) OF THIS SECTION; AND

13 (c) ON OR BEFORE MAY 30, 2015, PREPARE AND SUBMIT TO THE  
14 DIRECTOR ANY RECOMMENDATIONS THE BOARD HAS FOR THE GENERAL  
15 ASSEMBLY CONCERNING THE IMPLEMENTATION OF THE INITIATIVE. THE  
16 DIRECTOR SHALL REPORT THE RECOMMENDATIONS OF THE BOARD TO THE  
17 EDUCATION COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND  
18 SENATE, OR TO ANY SUCCESSOR COMMITTEES, AS DESCRIBED IN SECTION  
19 23-3.3-1003 (2).

20 (5) THE BOARD MAY ENTER INTO A MEMORANDUM OF  
21 UNDERSTANDING WITH A NONPROFIT ORGANIZATION FOR THE PURPOSE OF  
22 RAISING MONEYS FOR THE INITIATIVE.

23 **23-3.3-1005. Colorado opportunity scholarship initiative**  
24 **fund - created - rules.** (1) THERE IS CREATED IN THE STATE TREASURY  
25 THE COLORADO OPPORTUNITY SCHOLARSHIP INITIATIVE FUND, WHICH  
26 CONSISTS OF:

27 (a) ANY MONEYS APPROPRIATED TO THE FUND BY THE GENERAL

1 ASSEMBLY;

2 (b) ANY MONEYS TRANSFERRED TO THE FUND FROM ANY OTHER  
3 FUND; AND

4 (c) ANY MONEYS RECEIVED BY THE DEPARTMENT AS GIFTS,  
5 GRANTS, OR DONATIONS PURSUANT TO SUBSECTION (3) OF THIS SECTION.

6 (2) THE MONEYS IN THE FUND ARE CONTINUOUSLY APPROPRIATED  
7 TO THE DEPARTMENT FOR THE PURPOSES DESCRIBED IN THIS PART 10. ALL  
8 INTEREST DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEYS IN  
9 THE FUND MUST REMAIN IN THE FUND. ANY UNEXPENDED OR  
10 UNENCUMBERED MONEYS REMAINING IN THE FUND AT THE END OF A  
11 FISCAL YEAR MUST REMAIN IN THE FUND AND NOT BE TRANSFERRED OR  
12 CREDITED TO THE GENERAL FUND OR ANOTHER FUND.

13 (3) THE DEPARTMENT IS AUTHORIZED TO ACCEPT ANY GIFTS,  
14 GRANTS, OR DONATIONS FROM ANY PRIVATE OR PUBLIC SOURCE ON  
15 BEHALF OF THE STATE FOR THE PURPOSES DESCRIBED IN THIS PART 10. THE  
16 DEPARTMENT SHALL TRANSMIT ALL SUCH GIFTS, GRANTS, AND DONATIONS  
17 TO THE STATE TREASURER, WHO SHALL CREDIT THE SAME TO THE FUND.

18 (4) THE DEPARTMENT IS AUTHORIZED TO SPEND NOT MORE THAN  
19 THREE PERCENT OF THE MONEYS IN THE FUND TO PAY THE DIRECT AND  
20 INDIRECT COSTS OF ADMINISTERING THE INITIATIVE IN ANY FISCAL YEAR.

21 (5) THE BOARD MAY PROMULGATE RULES FOR THE  
22 ADMINISTRATION OF THE FUND.

23

24 **SECTION 2.** In Colorado Revised Statutes, 24-46.3-101, **add** (9)  
25 as follows:

26 **24-46.3-101. State work force development council - creation**  
27 **- membership.** (9) (a) THE MEMBERS OF THE EXECUTIVE COMMITTEE OF

1 THE STATE COUNCIL SHALL SERVE AS MEMBERS OF THE COLORADO  
2 OPPORTUNITY SCHOLARSHIP INITIATIVE ADVISORY BOARD CREATED  
3 PURSUANT TO SECTION 23-3.3-1004, C.R.S.

4 (b) THE EXECUTIVE COMMITTEE OF THE STATE COUNCIL SHALL  
5 IDENTIFY STAFF MEMBERS WITHIN THE DEPARTMENT OF EDUCATION  
6 CREATED PURSUANT TO SECTION 24-1-115, THE DEPARTMENT OF HIGHER  
7 EDUCATION CREATED PURSUANT TO SECTION 24-1-114, AND THE  
8 DEPARTMENT OF LABOR AND EMPLOYMENT CREATED PURSUANT TO  
9 SECTION 24-1-121 WHO SHALL BE CHARGED WITH ASSISTING THE STATE  
10 COUNCIL IN FULFILLING ITS DUTIES PURSUANT TO THIS SUBSECTION (9).

12 as follows:

13 **23-3.1-206.2. Financial need scholarships and grants - fund -**  
14 **repeal.** (3) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2014.  
15 THE STATE TREASURER SHALL TRANSFER ANY MONEYS REMAINING IN THE  
16 FUND ON SUCH DATE TO THE COLORADO OPPORTUNITY SCHOLARSHIP  
17 INITIATIVE FUND CREATED IN SECTION 23-3.3-1004.

18 **SECTION 4.** In Colorado Revised Statutes, 23-3.1-205.4, **amend**
