HB14-1384 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 4, strike "PIPELINE".
- 2 Page 3, line 8, strike "PIPELINE".
- 3 Page 3, after line 20, insert:
 - 4 "(2) IT IS THE INTENT OF THE GENERAL ASSEMBLY TO MATCH
 - 5 NON-PROFIT AND PRIVATE FINANCIAL CONTRIBUTIONS TO THE COLORADO
 - 6 OPPORTUNITY SCHOLARSHIP INITIATIVE WITH ANNUAL CONTRIBUTIONS
 - 7 FROM THE GENERAL FUND SO THAT A SUSTAINABLE CORPUS IS CREATED TO
 - 8 FUND SCHOLARSHIP AWARDS IN FUTURE YEARS. WHENEVER PRACTICABLE,
 - 9 THE ANNUAL MATCH SHOULD BE IN AN AMOUNT THAT IS SIGNIFICANT
 - 10 ENOUGH TO ATTRACT CONTINUED INVESTMENT BY COMMUNITY
 - 11 PARTNERS."
