Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB14-1037 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, before line 15 insert:

2 **"SECTION 5. Appropriation - adjustments to 2014 long bill.**

3 (1) For the implementation of this act, the general fund appropriation
4 made in the annual general appropriation act to the controlled
5 maintenance trust fund created in section 24-75-302.5 (2) (a), Colorado
6 Revised Statutes, for the fiscal year beginning July 1, 2014, is decreased
7 by \$339,602.

8 (2) In addition to any other appropriation, there is hereby
9 appropriated, out of any moneys in the general fund, not otherwise
10 appropriated, to the department of public safety, for the fiscal year
11 beginning July 1, 2014, the sum of \$339,602 and 0.6 FTE, or so much
12 thereof as may be necessary, to be allocated to laboratory and
13 investigative services for the implementation of this act as follows:

- 14 (a) \$36,844 and 0.6 FTE for personal services;
- 15 (b) \$5,258 for operating expenses and capital outlay; and
- 16 (c) \$297,500 for equipment, training, and supplies.

17 **SECTION 6.** In Colorado Revised Statutes, **add** 17-18-111 as
18 follows:

19 **17-18-111. Appropriation to comply with section 2-2-703 - HB**
20 **14-1037 - repeal.** (1) PURSUANT TO SECTION 2-2-703, C.R.S., THE
21 FOLLOWING STATUTORY APPROPRIATIONS, OR SO MUCH THEREOF AS MAY
22 BE NECESSARY, ARE MADE IN ORDER TO IMPLEMENT HOUSE BILL 14-1037,
23 ENACTED IN 2014:

1 (a) FOR THE FISCAL YEAR BEGINNING JULY 1, 2015, IN ADDITION
2 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
3 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
4 OTHERWISE APPROPRIATED, THE SUM OF TWENTY-ONE THOUSAND FOUR
5 HUNDRED EIGHTY-FOUR DOLLARS (\$21,484).

6 (b) FOR THE FISCAL YEAR BEGINNING JULY 1, 2016, IN ADDITION
7 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
8 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
9 OTHERWISE APPROPRIATED, THE SUM OF TWENTY-ONE THOUSAND FOUR
10 HUNDRED EIGHTY-FOUR DOLLARS (\$21,484).

11 (c) FOR THE FISCAL YEAR BEGINNING JULY 1, 2017, IN ADDITION
12 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
13 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
14 OTHERWISE APPROPRIATED, THE SUM OF TWENTY-ONE THOUSAND FOUR
15 HUNDRED EIGHTY-FOUR DOLLARS (\$21,484).

16 (d) FOR THE FISCAL YEAR BEGINNING JULY 1, 2018, IN ADDITION
17 TO ANY OTHER APPROPRIATION, THERE IS HEREBY APPROPRIATED TO THE
18 DEPARTMENT, OUT OF ANY MONEYS IN THE GENERAL FUND NOT
19 OTHERWISE APPROPRIATED, THE SUM OF TWENTY-ONE THOUSAND FOUR
20 HUNDRED EIGHTY-FOUR DOLLARS (\$21,484).

21 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2019."

22 Renumber succeeding section accordingly.

23 Page 1, line 101, strike "DRUGS." and substitute "DRUGS, AND, IN
24 CONNECTION THEREWITH, MAKING AND REDUCING APPROPRIATIONS."
