A BILL FOR AN ACT

101 CONCERNING AN INCREASE IN THE NUMBER OF JUDGES FOR THE
102 EIGHTEENTH JUDICIAL DISTRICT, AND, IN CONNECTION
103 THEREWITH, MAKING AN APPROPRIATION.

Bill Summary

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 13-5-119, **add** (2) (d)
3 (V) as follows:

4 **13-5-119. Eighteenth district.** (2) (d) (V) SUBJECT TO
5 AVAILABLE APPROPRIATIONS, EFFECTIVE JULY 1, 2014, THE NUMBER OF
6 JUDGES FOR THE EIGHTEENTH JUDICIAL DISTRICT IS TWENTY-THREE.

7 **SECTION 2. Appropriation.** (1) In addition to any other
8 appropriation, there is hereby appropriated, out of any moneys in the
9 general fund not otherwise appropriated, to the judicial department, for
10 the fiscal year beginning July 1, 2014, the sum of \$600,756 and 7.3 FTE,
11 or so much thereof as may be necessary, to be allocated to the trial courts
12 for the implementation of this act as follows:

13 (a) \$583,656 and 7.3 FTE for trial court programs for personal
14 services; and

15 (b) \$17,100 for trial court programs for operating expenses.

16 (2) In addition to any other appropriation, there is hereby
17 appropriated, out of any moneys in the general fund not otherwise
18 appropriated, to the judicial department, for the fiscal year beginning July
19 1, 2014, the sum of \$150,718, or so much thereof as may be necessary, to
20 be allocated for courthouse capital expenses related to the implementation
21 of this act.

22 (3) In addition to any other appropriation, there is hereby
23 appropriated, out of any moneys in the general fund not otherwise
24 appropriated, to the judicial department, for the fiscal year beginning July
25 1, 2014, the sum of \$86,350 and 1.5 FTE, or so much thereof as may be
26 necessary, to be allocated to the office of the state public defender for the

1 implementation of this act as follows:

2 (a) \$79,647 and 1.5 FTE for personal services;

3 (b) \$1,810 for operating and travel expenses;

4 (c) \$4,703 for capital outlay; and

5 (d) \$190 for attorney registration.

6 **SECTION 3. Safety clause.** The general assembly hereby finds,
7 determines, and declares that this act is necessary for the immediate
8 preservation of the public peace, health, and safety.
