**Summary of Legislation**

This bill authorizes the Peace Officers Standards and Training (P.O.S.T.) Board to promulgate rules for:

- certification of inspectors of vehicle identification numbers;
- annual in-service training requirements for certified peace officers; and
- any rules necessary to carry out the functions of the P.O.S.T. Board.

The bill allows the P.O.S.T. Board to increase its certification fees from \$125 to \$150. The bill also allows the P.O.S.T. Board to expand the entities to whom it may make grants by including nonprofit organizations. The P.O.S.T. Board may deny certification to any person who is convicted of a municipal violation that is the equivalent of any of the state law violations that permit denial of certification. Finally, the registration fee (P.O.S.T. fee) paid by owners of Class A, B, or C vehicles will increase from \$0.60 to \$1.00.

**Background**

The P.O.S.T. Board is cash funded and has an annual budget of approximately \$2.8 million and 7.0 FTE. The majority of revenues are generated from the \$0.60 P.O.S.T. fee on vehicle registrations, which is being adjusted by \$0.40 to \$1.00 under the amended version of the bill.

Current law allows county clerk and recorder offices to retain 5 percent of the fee for administrative purposes. The program also receives about \$127,528 per year from P.O.S.T. certification fees and \$6,000 per year in miscellaneous revenue. The program distributes an average of \$2.2 million per year in training grants.

**State Revenue**

**Beginning in FY 2014-15, this bill will increase state cash fund revenue credited to the P.O.S.T. Board Cash Fund in the Department of Law by \$1,636,492 in FY 2014-15 and by \$1,801,744 in FY 2015-16.**

**Assumptions.** Based on an average of the past three fiscal years, the fiscal note assumes that 1,020 persons will pay an increased fee of \$25 per year for P.O.S.T. certification. In addition, the P.O.S.T. fee on vehicle registrations will increase by \$0.38 (\$0.40 less 5 percent or \$0.02 retained by counties). Based on current collections, the rate of assumed growth is 1.07 percent per year, and the first year is adjusted for the effective date of the bill.

**Fee impact on individuals.** Section 2-2-322, C.R.S., requires legislative service agency review of measures which create or increase any fee collected by a state agency. Table 1 below identifies the fee impact of this bill.

**State Expenditures**

**This bill will increase costs and workload in the Department of Law by \$1,636,492 and 1.4 FTE in FY 2014-15 and by \$1,799,043 and 1.5 FTE in FY 2015-16.** For FY 2014-15 only, the bill will increase workload for the Department of Revenue. Table 2 and the discussion that follows describe the costs of the bill.

**Department of Law.** The Department of Law will expand its training activities to support peace officers. To accomplish this, the department requires 1.5 FTE, including 1.0 FTE Program Assistant I at an annual salary of \$50,400 and 0.5 FTE Accountant I at an annual salary of \$40,200. Standard operating and capital outlay costs are included. First year costs are prorated for the effective date of the bill. Training equipment and software assumes the purchase of three driving and three shooting simulators, the instructor certification, and three licenses for the shooting simulation software per year. Training session costs are based on the assumption that there will be four events of 100 people per event, per year and include costs for ammunition, range and driving track fees, ammunition targets, training facility rentals, instructor training, and reimbursements to provide coverage for peace officers attending a training. Records management software is assumed to be \$100,000 per year for FY 2014-15 and FY 2015-16, and will require maintenance costs of about \$25,000 in future years (not shown above). Online training development costs are assumed to be \$100,000 in FY 2014-15 and \$25,000 in FY 2015-16. Online P.O.S.T. certification testing development costs are assumed to be \$25,500 per year. Grants and scholarships will be provided to local governments to conduct testing and attend training functions. Centrally appropriated costs are shown in Table 3, below.

**Department of Revenue.** The Department of Revenue will be required to update its GenTax, Colorado State Titling and Registration Systems (CSTARS), and Online Vehicle Registration Renewal System to reflect the change in the P.O.S.T. fee on vehicle registrations. These activities will not require an increase in appropriations.

**Centrally appropriated costs.** Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. The centrally appropriated costs subject to this policy are estimated in the fiscal note for informational purposes and summarized in Table 3.

### **Local Government Impact**

This bill will increase revenue to counties by an estimated \$84,789 in FY 2014-15 and \$93,486 in FY 2015-16. Under current law, county clerk and recorder offices receive 5 percent of the registration fee paid by owners of Class A, B, or C vehicles (P.O.S.T. fee). Under the bill, this fee will increase from \$0.60 to \$1.00, which will increase the county share by \$0.02 per vehicle registration, from \$0.03 to \$0.05 per registration.

### **Effective Date**

The bill was signed into law by the Governor on May 21, 2014, and takes effect August 6, 2014, assuming no referendum petition is filed.

### **State Appropriations**

For FY 2014-15, the Department of Law is appropriated \$1,612,467 from the P.O.S.T. Board Cash Fund and allocated 1.4 FTE.
