A BILL FOR AN ACT

101 **CONCERNING FINANCIAL ASSISTANCE FOR LOCAL GOVERNMENTS**
102 **AFTER A DECLARED DISASTER EMERGENCY.**

Bill Summary

In the event of a declared disaster emergency, the bill authorizes the governor to determine the percentage at which the state and a local government will contribute moneys to cover the nonfederal cost share required by federal law when the disaster emergency triggers federal assistance to the local government through the federal emergency

management agency. As soon as practicable after making such a determination, the governor is required to notify the joint budget committee of the source and amount of state moneys that will be contributed to cover the nonfederal cost share.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-704, **add** (7)

3 (j) as follows:

4 **24-33.5-704. The governor and disaster emergencies -**
5 **governor's disaster emergency council - creation - expert emergency**
6 **epidemic response committee - creation.** (7) In addition to any other
7 powers conferred upon the governor by law, the governor may:

8 (j) DETERMINE THE PERCENTAGE AT WHICH THE STATE AND A

10 NONFEDERAL COST SHARE REQUIRED BY THE FEDERAL "ROBERT T.

12 AMENDED, 42 U.S.C. SEC. 5121 ET SEQ., OR REQUIRED BY THE FEDERAL
13 HIGHWAY ADMINISTRATION PURSUANT TO 23 U.S.C. SEC. 125. AFTER
14 MAKING SUCH A DETERMINATION, THE GOVERNOR MAY AMEND THE
15 PERCENTAGE AT WHICH THE STATE AND LOCAL GOVERNMENT WILL
16 CONTRIBUTE MONEYS TO THE NONFEDERAL COST SHARE BASED ON THE
17 NEEDS OF THE INDIVIDUAL LOCAL GOVERNMENTS. AS SOON AS
18 PRACTICABLE AFTER MAKING OR AMENDING SUCH A DETERMINATION, THE
19 GOVERNOR SHALL NOTIFY THE JOINT BUDGET COMMITTEE OF THE SOURCE

22 **SECTION 2.** In Colorado Revised Statutes, 24-33.5-1107, **add**

23 (1) (d) as follows:

1 **24-33.5-1107. Community loans.** (1) Whenever, at the request
2 of the governor, the president of the United States has declared a major
3 disaster to exist in this state, the governor is authorized:

4 (d) TO DETERMINE THE PERCENTAGE AT WHICH THE STATE AND A
5 LOCAL GOVERNMENT WILL CONTRIBUTE MONEYS TO COVER THE
6 NONFEDERAL COST SHARE REQUIRED BY THE FEDERAL "ROBERT T.
7 STAFFORD DISASTER RELIEF AND EMERGENCY ASSISTANCE ACT", AS
8 AMENDED, 42 U.S.C. SEC. 5121 ET SEQ., OR REQUIRED BY THE FEDERAL
9 HIGHWAY ADMINISTRATION PURSUANT TO 23 U.S.C. SEC. 125. AFTER
10 MAKING SUCH A DETERMINATION, THE GOVERNOR MAY AMEND THE
11 PERCENTAGE AT WHICH THE STATE AND LOCAL GOVERNMENT WILL
12 CONTRIBUTE MONEYS TO THE NONFEDERAL COST SHARE BASED ON THE
13 NEEDS OF THE INDIVIDUAL LOCAL GOVERNMENTS. AS SOON AS
14 PRACTICABLE AFTER MAKING OR AMENDING SUCH A DETERMINATION, THE
15 GOVERNOR SHALL NOTIFY THE JOINT BUDGET COMMITTEE OF THE SOURCE
16 AND AMOUNT OF STATE MONEYS THAT WILL BE CONTRIBUTED TO COVER
17 A NONFEDERAL COST SHARE PURSUANT TO THIS PARAGRAPH (d).

18 **SECTION 3. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
