After consideration on the merits, the Committee recommends the following:

SB14-087 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike lines 4 through 10 and substitute:

2 "42-1-229. Report. (1) ON OR BEFORE JULY 1, 2015, AND EVERY
3 YEAR THEREAFTER, THE DEPARTMENT SHALL SUBMIT TO THE
4 TRANSPORTATION LEGISLATION REVIEW COMMITTEE A REPORT
5 CONCERNING THE EFFECTIVENESS OF EXCEPTIONS PROCESSING,
6 INCLUDING:

7 (a) THE NUMBER OF INDIVIDUALS ISSUED OR DENIED AN
8 IDENTIFICATION CARD OR DRIVER'S LICENSE ON HIS OR HER FIRST VISIT TO
9 AN OFFICE AND THE NUMBER OF INDIVIDUALS ADVISED TO PROVIDE MORE
10 DOCUMENTS;

11 (b) THE AVERAGE LENGTH OF TIME BETWEEN AN UNSUCCESSFUL
12 FIRST VISIT AND ULTIMATE APPROVAL;

13 (c) THE NUMBER OF INDIVIDUALS WHO FAIL TO RETURN;

14 (d) THE BREAKDOWN BY EACH OFFICE OF APPROVAL AND DENIAL
15 RATES;

16 (e) THE NUMBER OF INDIVIDUALS WHO REQUEST EXCEPTIONS
17 PROCESSING EACH MONTH AND THE OUTCOMES OF THOSE REQUESTS BY
18 EACH OFFICE;

19 (f) THE NUMBER OF HEARINGS REQUESTED AFTER NOTICE OF
20 DENIAL AND THE OUTCOMES OF THE HEARINGS; AND

21 (g) A SUMMARY OF THE MAIN REASONS FOR DENIAL UNDER
22 EXCEPTIONS PROCESSING."

1 Page 2, strike line 16 and substitute:

2 "(I) WAS BORN ON OR BEFORE DECEMBER 1, 1964;"

3 Page 3, strike lines 7 through 24 and substitute:

4 "(b) THE DEPARTMENT MAY ACCEPT ANY RELIABLE, CONSISTENT,
5 AND VERIFIABLE DOCUMENT TO ESTABLISH LAWFUL PRESENCE IF AN
6 APPLICANT SIGNS AN AFFIDAVIT THAT A CERTIFIED UNITED STATES BIRTH
7 CERTIFICATE EITHER DOES NOT EXIST OR CANNOT BE OBTAINED WITHIN
8 TWENTY WORKING DAYS."

9 Reletter succeeding paragraph accordingly.

10 Page 4, strike line 8 and substitute:

11 "(I) IF THE PETITIONER ATTEMPTED TO OBTAIN A
12 FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK AND RESULTS
13 WERE INCONCLUSIVE OR UNREADABLE, MAY SUBMIT, IN LIEU OF A
14 FINGERPRINT-BASED CRIMINAL".

15 Page 4, strike lines 22 through 24 and substitute:

16 "(II) BE AT LEAST SEVENTY YEARS OF AGE."
