After consideration on the merits, the Committee recommends the following:

HB14-1266 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, after line 26 insert:
- 2       "(a.7) A CLASS 3 MISDEMEANOR IF THE FRAUDULENT CHECK WAS
- 3 FOR THE SUM OF FIFTY DOLLARS OR MORE BUT LESS THAN THREE HUNDRED
- 4 DOLLARS OR IF THE OFFENDER IS CONVICTED OF FRAUD BY CHECK
- 5 INVOLVING THE ISSUANCE OF TWO OR MORE CHECKS WITHIN A SIXTY-DAY
- 6 PERIOD IN THE STATE OF COLORADO TOTALING FIFTY DOLLARS OR MORE
- 7 BUT LESS THAN THREE HUNDRED DOLLARS IN THE AGGREGATE;"
  
- 8 Page 6, line 4, strike "ONE" and substitute "TWO".
  
- 9 Page 6, line 6, strike "ONE" and substitute "TWO".
  
- 10 Page 7, line 16, strike "ONE" and substitute "TWO".
  
- 11 Page 7, line 18, strike "ONE" and substitute "TWO".
  
- 12 Page 9, line 2, strike "ONE" and substitute "TWO".
  
- 13 Page 9, line 6, strike "ONE" and substitute "TWO".
  
- 14 Page 10, after line 24 insert:
- 15       "**SECTION 6.** In Colorado Revised Statutes, 18-4-409, **amend**
- 16 (3) as follows:
- 17       **18-4-409. Aggravated motor vehicle theft.** (3) Aggravated
- 18 motor vehicle theft in the first degree is a:

1           (a) ~~Class 4~~ CLASS 5 felony if the value of the motor vehicle or  
2 motor vehicles involved is LESS THAN twenty thousand dollars; ~~or less~~  
3           (a.5) CLASS 4 FELONY IF THE VALUE OF THE MOTOR VEHICLE OR  
4 MOTOR VEHICLES INVOLVED IS TWENTY THOUSAND DOLLARS OR MORE BUT  
5 LESS THAN ONE HUNDRED THOUSAND DOLLARS;  
6           (b) Class 3 felony if the value of the motor vehicle or motor  
7 vehicles involved is more than ~~twenty~~ ONE HUNDRED thousand dollars or  
8 if the defendant has twice previously been convicted or adjudicated of  
9 charges separately brought and tried either in this state or elsewhere of an  
10 offense involving theft of a motor vehicle under the laws of this state, any  
11 other state, the United States, or any territory subject to the jurisdiction of  
12 the United States."
